Brad:

I began writing this email's text & pdf-document during your last Union Conference Call, on the 7th of July, 2021; & I expected to finish it that evening, but these issues were more complex than what I first calculated, & I also suffered computer problems. And please share this email with Bill, & with others, as you deem appropriate; perhaps even including that military general whom you say you communicate regularly with.

I believe These Issues are of Critical Importance to Every Honorable American Patriot; & that this discussion deserves to be widely disseminated. Here-under; I request that you affirm that you have no objection to my also sharing this email with other Honorable American Patriots in our circles.

Here-under, I ask that you join with me in focusing our mutual attention on the Agenda which is currently being pursued in your Union Conference Calls, & which seems mostly promoted by Bill. That Agenda <u>seems to me</u>, clearly, to be <u>Prioritizing</u> the Directing of <u>our Patriotic Individual Members</u> to Separately Invest their Limited Time, Energy, & Money Resources in Attempting to Secure Their God-Given Natural-Rights, in manners which may Only Possibly Winn Small Gains for Individual Patriots, but which are Completely Worthless in Any Long-Term Strategy for Saving Our American Republick & Union of States.

More Specifically; that Agenda Prioritizes these Members Investing their Limited Resources in Learning to Competently Use the Uniform Commercial Code, aka UCC; (which is a form of the Godless Roman Municipal/Civil Statutory-Codes); but Only To Use the Whimpy Parts there-of, because the Strategy Gurus advocating this "UCC Strategy" have become Terrorized with Fear, that, Using The Full Power of the UCC will cause the Corrupted Jack-Booted Nazi Murders in & surrounding USA DeFacto Government to Respond with Violent Acts against our people. (This strategy also seems to be including, that, these same Patriotic Members Learn how to Seek, & actually Edit & secure, copies of their Separate Individual "IRS-Master-Files".)

Now I have No Objection, to, (Eventually, & Possibly), Incorporating these Man-Made Legal-Fiction Social-Engineering Strategies in-to our Larger Over-All Strategy. But; it is My Carefully Considered Judgement, that, the Manner in which this "UCC Strategy" is being presented in your Union Conferences, is being promoted in manners which actually Eclipse & Obscure our Godly & Constitutionally-Lawful "Duties" to Prioritize our Local Community Organizing & Empowerment Strategies.

It is My Further Judgement, that, if actually embraced by Our Community, that entire "UCC Strategy" (which Bill is promoting), will Cause Our Community to Fall In-To "Fatal Error", & to Cause the "Doom & Destruction of our Union of States" & of our Republickan Form of Government.

I make these boldly confrontational statements, because, this "UCC Strategy" is Based Solidly on Man-Made Legal-Fiction Social-Engineering Schemes, all of which is in Direct Violation of our "Higher Law Duties" to Prioritize Our Obedience to the "Laws of Nature & of Nature's God".

Here-under; your <u>Union Assembly Conference Patriot Attendees</u> are being <u>Indoctrinated</u> with that Agenda which Promotes the "Ideology" of Investing our Time & Energy Resources in Seeking Remedies thru Un-Natural Man-Made Social-Engineering Schemes. The Worst Part, is, that, that same "UCC Strategy", as being promoted by Bill in your Conferences, is being allowed to actually Eclipse & Distract from our Godly Christian Priority of Building our Responsibly Self-Governing Organic

<u>Constitutional Body-Politic Communities</u>. This would especially include our Exodus-18 <u>Bible-Law & Torah-Law Command From God to Organize & Build Our Local</u> & Common-Law Compliant <u>Townships & Precinct-Level/Hundred-Court Communities</u>.

These issues are all seriously concerned with the Nature of the Conflict Against the Violently Warmongering, & Treasonous Aristocratic Parasite-Class Community, which our Patriotic Organic Body-Politic Community has long been suffering deep entanglement in. Here-under; our Patriotic Community needs to Collectively Prioritize our Building a Consensus which Recognizes, that, When People Freely Chose to Engage In Corruption, & to Criminally Violate Our Constitutionally-Guaranteed Anglo/American "Natural Rights"; then they are "At War", Against Our Entire Anglo/American Organic Body-Politic.

They are the "Aggressors". They are the ones who are Causing the Criminal "Breach of the Peace". They are the ones In "Trespass", as against Our Body-Politic Community's "Natural Rights". Here-under; We are Lawfully & Judicially Commanded & Mandated By God to Form Community Consensus thru Juries from Our Responsibly Self-Governing Sixth & Seventh Amendment Common-Law Compliant Courts; & there-under to Prepare to Effectively "Defend" the Members of Our Self-Governing Communitys from those Parasitic Criminal Conspirators, who are so engaged in their self-evident & Massive Criminal Conspiracy to Posture as Legitimate "Public Servants".

But, in direct contrast there-with; <u>Bill seems entrenched in</u> insisting that our Community's Collective-Consciousness devote close to Exclusive & Highest Priority to <u>using a Watered-Down version of "UCC Strategy"</u>, (similar to that which Leroy Schweitzer & the Montana Freemen used). <u>Bill actually Advocates our Using even Less Seriously Confrontational UCC-Strategy</u>, <u>than that which finally resulted in the complete earthly Doom of Schweitzer & the Freemen</u>. Bill attempts to justify his whimpy strategy, thru theorizing, that, <u>if we "play nice" with these murdering jack-booted nazis</u>, that, <u>they will give us most of the rights which we claim</u>, at least if we don't claim any which have any serious potential to set a precedent for causing the fall & destruction of the entire babylonian-whore, commercially militarized evil-empire.

That is a "Godless Strategy"; Brad. That is an "Un-Natural Strategy", Brad.

Schweitzer & the Freemen were already Organizing their Common-Law Compliant & Responsibly Self-Governing Local Communities. The one they already had set-up & functioning, was known as "Justus Township"; & they had been promoting others, except they became distracted with the "UCC Strategy". And the Only Reason that the Corrupted Feds Refrained from Prosecuting the Freeman for as long as they did, was, because the Freeman were Plausibly Claiming Their "Common-Law Jurisdiction", "On the Land", in "Justus Township". That was a Legal/Lawful Argument that the Defacto Feds Absolutely Could Not Beat; & it there-by caused chaos & confusion in the corrupted fed prosecutors offices & judiciary offices.

Bill seems Not Claiming Any Similarly Powerful "Law of the Land" Grounding, for his watered-down "UCC Strategy"; & there-under, modern patriots following that strategy are seriously vulnerable to becoming squished like buggs.

The Freemen had come to realize, that, when Prioritizing the <u>Organizing of our Self-Governing Communities</u>, one there-under has <u>accompanying Self-Governing Community "Duties"</u>, to <u>Effectively Defend Against Aggressively Warring & Peace-Breaching Criminals</u>, including even those who routinely posture as municipal Public-Servants. That is a Big Project, which <u>Requires a Complete Devotion</u>, <u>similar to a Religious Person's Devotion to God</u>, as you will surely recognize.

<u>Leroy & the Freemen had also become aware of the seemingly powerful remedies offered thru</u> <u>the UCC</u>; just as Bill is now promoting. Leroy & the Freemen then <u>Made a Strategic "Decision"</u>, to

<u>Avoid the Work & Danger</u> which likely would Result, eventually, <u>from Establishing Our Own</u> <u>Constitutionally-Lawful & Common-Law Compliant Courts</u>, <u>& there-under "Keeping the Peace</u>", with "What-Ever Force is Necessary".

Here-under; <u>Leroy & the Freemen made the Quick & Easy Decision to Embrace a "Less Confrontational Strategy</u>", thru <u>Trusting that the Corrupted Municipal Governmental Judges would Seriously Respect</u> the Rules of the Man-Made Municipal Social-Engineering Scheme, which is known as <u>the "Uniform Commercial Code</u>", aka the "UCC".

But when the Corrupted Judges Railroaded the Freemen In-to Prison; the "Light Finally Went Of in their Heads", to the effect, that, "They Made a Bad Decision", when they decided to Trust that the Corrupted Judges would Respect the Municipal Social-Engineering Scheme which is known as the "UCC".

I was involved in that event. I then heard reliable & un-controverted testimony, that, Leroy Clearly Declared, that, (at least Concerning any Cases which are seriously Capable of even Possibly Promoting Return to the Ideal of a "More Perfect Union" under Republican & Common-Law Principles of Local Community Self-Governing); that, there is Absolutely "No Remedy" To Be Secured, thru Any Strategy which Required Trust of the Municipal Government's Judiciary; & that included the seriously confrontational use of the UCC that they had then been prioritizing.

In larger context, & to summarize; <u>Leroy & the Freemen First Chose to use a "UCC Strategy"</u>, Only Because, they wanted <u>to Avoid the Work</u> of Local Community Organizing, <u>& also to Avoid Using "Criminal Prosecutions" to More Seriously Confront the many Corrupted Municipal Government Office-Holders.</u>

After the first month or so of their imprisonment; Leroy had clearly Admitted that their entire "UCC Strategy" was a "Completely Hopeless Strategy" For bringing about Any Significant Positive Change for our Common American People. Leroy then Admitted, Because of the Extreme & Deep Corruption in the Fed & State Municipal Judicial Systems, that his entire "UCC Strategy" was a Completely Wasted & Worthless Effort. (I have multiple letters from Leroy in storage, where, as I recall, Leroy Admitted this there-in. And I know that Leroy Admitted this verbally; as I have heard it from multiple reliable witnesses.) This was painfully "Self-Evident" To All, after they got rail-roaded in the Shamm-Trial which Destroyed all of Their Heroic Efforts, at least out-side of memories like this discussion.

But again, in larger context, & to summarize; <u>Leroy & the Freemen Decided to "Avoided Direct Confrontation</u>" thru their Strategy of Using the UCC in Seriously Confrontational Manners. <u>That is a "Less Confrontational" Strategy</u>, <u>than the Christian Common-Law Community Organizing & Peace-Keeping Strategy</u>, which was the only other option available to the Freemen.

Leroy & the Freemen later Admitted, effectively, that, their "UCC Strategy" was a "Bad Choice"; &, in essence, that, we are "At War" against the Corrupted Municipal Executive & Judiciary Classes, with a small percentage of exceptions; & that "We Need To Be More Confrontational", against those blood-drinking satanists, & Not Less Confrontational.

But <u>now</u>, <u>Bill here is</u> Dominating our Conferences by <u>Advocating</u> that our Community Return to that same basic Strategy of using the UCC, only in <u>Even "Less Confrontational Manners"</u> than how the Freemen were so courageously using it.

It is My Judgement, Brad, that, in this larger context; <u>Bill's Strategy amounts to "Cowardice & Doom</u>". It amounts to "Capitulation". It amounts to "Surrender". Effectively; it Abandons Completely the Idea of Creating & Organizing & Populating Our Own "Responsibly Self-Governing Communities".

Further; <u>Bill's Strategy does Not Effectively Confront the Military Threat from the Parasitical Oppressor Body-Politic Conspirators</u>. When People such as those Freely Chose to Engage In Criminally Violating Our Constitutionally-Guaranteed Anglo/American "Natural Rights"; then <u>They are "At War"</u>, as Against our Anglo/American Organic Body-Politic.

Here-under; <u>Bill's Watered-down UCC-Strategies</u>, <u>& IRS Master-File searchings</u>, <u>are Not "Effective Defense Strategies"</u>, <u>as Against the Brutal Military Nature of the modern Municipal Defacto Governmental Threat</u>, which so clearly exists as Against our modern Anglo/American Organic Body-Politic Community.

Again; I have No Inherent Objection to Using Some of those Man-Made Remedy Strategies in our Larger Strategy; but, we Must Not Allow such to Eclipse or Obstruct or Distract from our Higher Duties to God to First Prioritize our Organizing Our Local Responsibly Self-Governing Communities.

On a Separate Note of Concern, in our last Union Conference, & his (massively time consuming) presentation there-in; <u>Bill spoke in manners which Promoted Trust in "Sheriff Mack", & "Robert David Steel</u>". In my cell-phone's text to you last night, I informed you, that, competent research completed, & solidly recognized among the better informed in our Patriotic Community, is the common-knowledge fact that <u>both of those named men are extremely likely Cointelpro Subversives</u>, <u>who are only active</u> in our communities, <u>in their malicious efforts to hinder any significant progress</u> that the more enlightened among us might be capable of actually making.

For the record here, I transcribe most of the text messages which I then sent to you, as follows: "Brad, I believe Bill is Leading Your Assembly In-to Destruction and Doom. ... We can Not Look to the Military to Save Us. This is the Reason Why We Must Organize Our Own County Level Military as Peace Officers and Constables under Posse Comitatus. ...

"Both Sheriff Mack and Robert Steel are Cointelpro Subversives. And Bill should be smart enough to know that. ... Why did Bill Not Waite till After he had Investigated Them before he Publicly Praised Them? And tell Bill to give me a call. I will bring him up to speed on lots of these subversives. He should not be embarrassing our Assembly by praising commonly recognized subversives. If he would communicate more like an equal team-player, we can cure these embarrassments."

For further reference, I am capable of producing videos which produce powerful Evidence of the Subversive Agenda of "Robert David Steel". Steel is Ex-CIA. That alone should give even Bill serious apprehension about trusting or promoting Steel.

And I have older conference recordings, & I still have regular conference attendees in our Supreme Court of Law, who have Witnessed first-hand the Subversive Activities of Ex-Sheriff "Richard Mack".

<u>We are in "Low Intensity Warfare</u>", Brad; & that is all slowly but surely Progressing to "Higher Intensity Warfare"; & <u>Unless We Get really Serious about Getting Our Own House In Order</u>, then <u>America & the Cause of Liberty & Republickan Self-Government id Doomed to Destruction</u>.
