"Oath of Office"

for the **Township level Public-Office** of:

"Qualified Elector".

"Traditional Anglo/American Common-Law Organic 'Township' Jurisdiction & Social Safety-Net."

Version: S-3.

I have spent sufficient time in studying <u>our American National & State Constitutions</u> in order to come to firmly know that the People who wrote those documents <u>Intended to Prioritize the ability of "We the People" to Secure Justice, Peace, & Liberty, for our-selves</u>, by way of their listing those concepts as their "Ultimate Goals" in the Prioritized "Preambles" of those documents. I have also come to Recognize, that, <u>our American System of Constitutional-Law Preserves our "Rights of Local Self-Government"</u>; as indicated in our U.S. Constitution's "Sixth, Seventh, Ninth, & Tenth Amendments".

I have also spent sufficient time in studying documents related to those, & including the one directly related to this effort which is entitled similarly as "Basis-In-Law For Common People Organizing Local Smaller Constitutional Township Communities"; & that I have sufficiently discussed these matters with others who seem knowledgeable about them; so that I have now come to my own conclusions & belief, that, the Framers of our State & National Constitutions Intended to Preserve for "We the People", a much More Ancient Form of "De-Centralized Self-Government", which is described in detail in such ancient documents as Magna-Charta, & the Bible.

Here-under; I have come to believe, that, in our culture's more ancient Anglo/American Governing System, that, "Vigilance" was Required from Every "Qualified Elector" in his own efforts to bring Truth, Justice, Safety, & Peace to their larger Collective Communities. I recognize, that, in the more perfected versions of this ancient form of government, that there were very close & personal bonds between the common people & their leaders, including their "Kings"; & that, here-under, the "Constituents" of those Kingdoms, were Composed of Electors who were "Vigilant" about Maintaining Their Own Smaller Portions of the "King's Peace". I have further come to know, that, All Other Rights & Liberties for our Common People, & for our general Social & Economic Welfare, can Only be Maintained "After" this "Truth, Justice, Safety, & Peace" has been Secured for "We the People", generally.

I have here-under come to believe, that, the ability of our People to Secure these ideals will more effectively & perfectly be secured for us if we can just exercise our own initiative in our own local communities for achieving these noble goals in the manners that the people in our own smaller communities deem best for us. I recognize, that, by my signing this document, that, I am solemnly affirming that I will recognize it to be my solemn Duty to exercise similar Vigilance in securing this same Truth, Justice, Safety, & Peace for our progressively larger Collective Communities.

I have come to the further belief, that, <u>America's "Original Constitutional-Plan"</u>, <u>Mandated</u> that <u>Our Common People "Keep the Peace"</u>, & that this was originally & more anciently designed to be accomplished <u>in our own smaller Local Communities of approximately "Ten Heads-of-Households"</u>; & that <u>this is the specific numerical-requirement for Traditional Anglo/American "Townships"</u>, under our American Organic/Constitutional "Common-Law Jurisdiction".

I comprehend that <u>our American Constitutional "Township" Communities</u> are derived from the "Common-Law" of ancient Europe & England; & that the words "Town", "Ten", & "Tithing", are all historically Related, & that, as the word "Tithing" indicates, the "Tithing-Man" or Town-Constable therein was & is Responsible for a a Religious manner & Process for what amounts to "Collecting Taxes", but only as Non-Coercive & Voluntary "Tithing Donations". Here-under; a <u>Non-Coercive & Voluntary form of "Economic-Support" for Each Township Community was adequately obtained; & the historical context</u>

<u>indicates that the "Tithing Man" there-in merely Passed On Up to the Higher Levels of Government</u> in these Christian Kingdoms the Economic Donations which were Gathered Voluntarily in their Local Township/Tithing Communities.

I comprehend that these ancient "Township Communities" were so Small, & that everyone knew each-other so well there-in, that it would have been easy for every-one there-in to know if some among them were not contributing their "fair share", in good-faith. I here-under recognize that this System for Gathering "Voluntary Economic-Support" for Governmental Services, is much More "Peaceable" & "Justifiable" than is the modern & essentially threatening & Coercive form of "Taxation".

I am aware of research which indicates, that, <u>Ten of these local ten-household "Township Communities"</u> formed what was known then as "Hundred Courts", which were also known as "Courts of Justice", aka: "Courts of Law"; & that, these same "Courts of Justice" were more anciently Organized in Communities <u>referred to in the Bible & Magna-Charta as "Hundreds"</u>; & that these Communities were Obligated to Provide a "Hundred Men under Arms", or Containing roughly a "Hundred Homesteads"; all so that <u>they could more effectively "Keep the Peace"</u> & "Administer Justice" <u>in their own essentially separate communities</u>. I recognize the research which indicates that these "Hundred Courts" are our modern American Equivalent of "Courts of Justice", & that every "Precinct" under every County in America & England has Constitutionally Lawful Authority "Administer Justice" through "Due Process of Law" in these communities.

I Recognize, that, when formal Complaints concerning un-lawful behavior have been formally presented; that, our Nation's Constitutional Rules of "Due-Process-of-Law" Requires those Complaints to be Resolved by "Twelve-Person Juries" & "Unanimous Verdicts", along with a small number of other procedural concerns. I here-under further recognize, that, that this process is specifically designed so that the Collective "Conscience of the Community" can be Publicly Declared by the Jury, in each of our Smaller Township & Precinct Communities.

I further here-under find, that, <u>America's modern Civil & Municipal Court Systems</u> Rarely actually Provide These Constitutionally-Required Procedures for our common American People, & that those courts <u>are "Not Effective" in Securing Truth, Justice, Safety, Peace, & Happiness, for us;</u> & that our People's Ability to obtain these Constitutionally Guaranteed Rights should be More Efficiently Secured if we just "Do It for Our-Selves", by way of our invoking this modernized version of this same ancient De-Centralized "Due Process" for Administering Justice & Keeping the Peace in our own local communities.

I further recognize, that, <u>if twelve-member Juries can reach a "Consensus</u>" on how local communities should respond to formal Complaints brought before them; that, <u>it should similarly be easy for the Ten Qualified-Electors who form our own Constitutional "Town-Councils" to develop the required "Consensus"</u> on the more general issues of our Township's responsible local self-governing.

I recognize at the beginning of our "Township Organizing Effort", that I & the approximately nine others in our "Township Community" will be Required to Develop a "Consensus" concerning Which of the Qualified-Electors among us is Most Qualified to assume our "Township's Leadership Position", as our "Town Peace Officer" & "Town Constable". I recognize that this will be the first & most important Duty that I will be required to participate in assuming; & I here-by do solemnly affirm that I will exercise good-faith & vigilance, to the best of my reasonable capabilities, in fulfilling these Duties.

I recognize further here, that, our American <u>Constitutional Tradition Requires</u> the Existence of specific "<u>Offices of Government</u>", <u>where-in Local Communities of Common-Americans may Easily Find</u> Reasonable "<u>Public-Servants</u>" <u>who are sufficiently Competent so-as-to Provide</u> Us With the Necessary "<u>Judicial Machinery</u>" <u>so that We may Directly File & Prosecute Our Own Civil & Criminal Complaints</u>, all by following those Few & Simple Procedural-Steps of American Constitutional "Due Process of Law", aka: the "Rules of the Common-Law"; & this all <u>in such manners as Quickly & Efficiently Secure this same "Justice & Peace" for our Common People & our Communities</u>.

In furtherance here-of, I also recognize, that, <u>our American Traditional "Common-Law Jury</u>", as referenced in the "Seventh Amendment" to our "US-Constitution"; <u>was Required to be Composed of "Twelve-People"</u>, of Good Reputations in their Communities, whom each were charged <u>to use "Reason & Logic" to arrive at their "Unanimous Judgement"</u> concerning how <u>their "Collective Conscience" should "Administer Justice"</u>, all so-as-to "Responsibly Self-Govern" in their own Communities.

I have come to the further belief, here-under; that, this Process for Securing "Justice, Safety, & Peace" for our American People, through "Unanimous Judgements" of "Twelve People" of Good Reputations in our Local Communities, is a "Reasonable Process" for actually achieving these goals; especially in light of the Requirements that these Jurists all use Good-Faith in efforts at following "Due Process of Law" & the "Rules of the Common-Law", as referenced in the Fifth & Seventh Amendments to our National Constitution.

I recognize, here-under; that, the "<u>Duties</u>" of Assembling Twelve-People of Good-Reputation in our Communities to serve as "Jury Members" will Require Significant Effort; & that these Public-Servants will be much more capable of performing these "Duties", if we various "Heads-of-Household" in our communities <u>have already been "Certified" as Possessing the "Qualifications" which are Necessary</u>, in order for us to Responsibly Serve on these local-community "Juries".

<u>I comprehend</u>, that, "<u>Keeping the Peace</u>" & <u>assisting in "Administering Justice</u>", in our local communities, & in the manners described here-in, <u>is the main Purpose for which I am filling-out this formal "Oath of Office of Qualified-Elector" document.</u>

I have become sufficiently informed of these early American self-governing concepts, so that, I am reasonably aware of my Duties here-under. I recognize, that, the Duties I am assuming here will require that I make reasonably vigilant & good-faith efforts to Attend any & all "Town Meetings" which our Town-Constable might call; & that, to the best of my reasonable capabilities, I have a Duty to Participate in these Community Meetings, in "Good Faith", & with Respect for the Opinions of Others.

I comprehend that <u>People</u> in our local community <u>who Refuse to Participate in the Social-Process of seeking "Consensus" as to How the of "Force" our Governmental-Authorities shall be Applied in our local communities, are "Not Qualified" for the "Status" of an "Elector" with-in Our Township & Precinct level Communities, & in our American Nation.</u>

I also recognize that <u>our Community Needs to have Mechanisms In Place for "Judging" Accurately if any People</u> in attendance with our Community Meetings might Act or Speak in manners which <u>are "Disruptive"</u> of the Good-Faith Discussions which the more honorable members of our community are participating in; <u>& that</u> if & when such "Socially Irresponsible People" ware clearly identified by a majority of our Township's Members, then <u>they will need to be "Excluded" from our Township Community Meetings</u>. I recognize, that, <u>unless firm & clear "Judgements" are Made to "Exclude" any such "Disruptive People" from Our Smaller Community, then our own smaller community's efforts at "Responsibly Self Governing" will likely be Doomed to Failure.</u>

I recognize that, regarding <u>any & all Issues of concern which are related to my Household</u>, & <u>which I am not fully capable of peaceably resolving</u>, that <u>I have a Duty to Communicate these Concerns</u> on Up the chain-of-command, <u>to our Town-Constable</u>, so that he can exercise his larger Township-level jurisdiction, to assist me with in maintaining the Peace, Safety, & good Order in my Household.

I further Recognize that I have a Duty to promptly & vigilantly Obey all Commands & Directives that our Town Constable may ask me to carry out; with my only "Exception" for Refusing to Obey such a Command here being, if I can make a Believable Argument to My Fellow Electors in our Township that I Sincerely Believed that the Order I was Refusing was in Violation of "Higher Law" or "Natural Law" or the "Laws of God"; & that if I can Not make any such "Good Excuse" as this for Refusing any such command, that, this could be grounds for my Loosing my "Qualified-Elector Status" in our Township.

Here-under; I further recognize, that, in our collective efforts to "Responsibly Self-Govern", that, there are Many Different "Duties" which the Individual Members of our Township will be asked to collectively assume; but that any among us might have serious mental-blocks or emotional insecurities concerning our performance of some of these Duties; that others in our township community can likely shoulder those burdens, & that such ones should be given opportunities for contributing to our Township's welfare & security in other manners which are more comfortable to them.

I here-under recognize, that, <u>I & others may be called on to Attend City or County Meetings</u>, & to <u>Testify there-in</u> concerning our beliefs & judgements; & that we also may be asked to Participate in Lawfully Organized & Prudently & Engineered "Mass Marches". This may include Marches on Court-Buildings, City & County Office-Buildings, Newspaper-Offices, Television & Radio Stations, &/or Police or Sheriff's Headquarters, & Prisons.

In particular, I recognize, eventually, <u>it is likely that I will be Called On to Participate in "Administering Justice" as a "Juror</u>"; <u>& that this</u> or other similar callings made to me <u>May Require</u>, as I am reasonably able, <u>that I "Investigate" by "Inquiring" from Other People</u>, (including Corporate-Executives & Government-Officials), as to <u>whether or not they, or those they know, are causing any Social-Injustice</u> to manifest with-in the Township Community with-in which I hold my membership.

<u>I have sufficiently reviewed documents related to this oath document</u>, & which explain the history, duties, & benefits of my participating in this effort at smaller community self-governing; & <u>I have no significant dis-agreements</u> with the Duties described there-in; & <u>I solemnly affirm that I will exercise Vigilance & Good-Faith in</u> my Efforts to Full-Fill <u>these Duties</u>.

I do solemnly under-take to full-fill these Duties as Socially-Compacted Member & a "Qualified Elector" in the below described "Township" Jurisdiction.
