

“Public Notice to Keith Livingway”.

This message is intended to be delivered to one “Keith Livingway”, & it is intended to function as a “Notice of Lawful Proceedings being Brought Against You”, based on the “Complaint” of one “Charles Stewart”, & others affirming their support; & who are all proceeding “Nation/State-Ex-Rel”, & “In the Public-Interest”, & “in the Name of, & on the behalf of, the People of the Nation/State of the USA”; & this all for the purpose of Lawfully Adjudicating Keith Livingway's Leadership of a small but influential organization in our Modern American Patriotic Movement, & which has publicly professed to be dedicated to Bringing About more Honorable & Accountable American National Government; as evidenced by web-links to their web-pages, further below & here-in.

Here-under; the said Complaint is more specifically “Alleging”, that, while Some of the Work of the groups lead by Keith Livingway may truly be working towards the best interests of the American People; the General Manner in which Keith Livingway Hosts & Leads the Meetings of his Organizations are “Despotic & Tyrannical”; ... & there-under, Kieth Livingway is “Not Maintaining 'Qualified-Elector Status'”; ... & further there-under; Kieth Livingway is Not the “Leader” of “Any Organization” which might be Recognized as being “Legitimate” by any other truly Lawful American Patriotic Organization or Individuals. “Rule of Law” requires such Adjudication. “Due Process of Law” will be scrupulously followed, & if shows those accusations to be False, then Judgement will be rendered in the Favor of Kieth Livingway, & the Complaint will be Dismissed.

Here-under; & as affirmed by this author there-in, Keith Livingway is here-by further “Notified”, to “Appear”, in a similar phone-conference, in assembly with a similar group of patriotically concerned Americans, on Friday, 21-July-2017; at 7:00-pm Eastern-Time, & 4:00-pm Pacific-Time; to “Defend” against these charges, or else send a Representative to Defend on his behalf; or else, those in attendance, will move our open court process towards “Judgement by Default”, based on the non-appearance of Kieth Livingway or any supporter, to Appear & Defend against these serious charges. If “Final Judgement” can not be fully adjudicated by twelve qualified-electors in that sitting of this court, then similar future conference/forum/court proceedings will be followed until a full twelve qualified-electors can come to their unanimous verdict concerning this matter.
