## **Summary of Charles Stewart's Previous Lectures/Sermons:**

In our recent conferences, this author/host/moderator did there-in continue with <u>my own Series</u> <u>of Brief Opening Lecture/Sermons</u>, in which i <u>expanded on the "Traditional Organic Social</u> <u>Community Relationship" between "Israelite Torah-Law", "Christian Bible-Law", "English</u> <u>Common-Law", & "American Constitutional-Law</u>". I further expanded on these insights, by <u>jumping-back in History, to the events surrounding what is known as</u> the "Jewish Revolution of <u>ad-66</u>"; & which is directly related in this time-line to the Biblical verses of Mark 6, 39 & 40, & in Luke 9: 14 & 15; where-in are clearly illustrated, that, Israelite Messiah/Christ, <u>Yeshuah/Jesus, was directing His Followers to Organize Similarly as</u> the previously-referenced <u>Power De-Centralizing Governmental-Model ofExodus-18</u>. I then built there-on, to illustrate, that, <u>the clear implications of all of this, is that, "Jesus was a Revolutionary</u>".

I then pointed-out how all of this history indicates <u>a Grand Surviving Spiritual & Legal Legacy</u> of <u>the "Perfect Law of Liberty</u>"; & how <u>this amounts to a Perfected Spiritual Ideal of De-</u> <u>Centralized Responsible Self-Government</u> as Reasonably Perceived through close-examination of <u>our modern Anglo/American Organic/Constitutional Tradition of "Due-Process of Common-Law</u>".

Our more recent conferences have <u>focused more intensely on "Modern Applications" of</u> these Ancient & Time-Tested "Perfect Laws of Liberty". There-in i explained how the <u>American</u> <u>National "Constitution" document, of 1787/1789, did Not establish a "Government Of the</u> <u>People, By & For the People</u>", under general & "Public Law", but <u>rather it Established a</u> <u>"Private-Corporation for a Public-Purpose</u>". The alleged reason for this convoluted quagmire of confusion, was, <u>because our Common People were Too Incompetent to "Responsibly Self-Govern</u>", under a general & public system of Common-Law; & there-under, <u>we allegedly Needed a "Nanny State" to impose "Coercive Force" over us all</u>, as is generally described in the concept of "Parens Patriae".

Building further here-on, <u>we explored the concept of "Venue</u>", & how our most powerful arguments center around "<u>Challenging Jurisdiction</u>" in the modern defacto Civil/Municipal Courts. Further explained here is that <u>all Federal Courts & all State level Circuit & Superior Courts, are only Courts of "Limited Jurisdiction</u>"; as contrasted with <u>the much More Lawfully Empowered Courts of "General Jurisdiction"</u>, which are Constitutionally Mandated to Exist at <u>our Precinct & County Levels</u>. The <u>related Concepts of "Original Jurisdiction"</u> & "Exclusive Jurisdiction" here come in-to powerful play. These are extremely powerful concepts; which only a small part of our community seems to fully comprehend.

### **Following General Agenda Items:**

<u>General Agenda Item 1</u>: Following directly in pursuit of my above discourse; <u>perhaps the Single</u> <u>Most Important Issue</u> for our Community to Discuss, <u>is the issue of "Executive Action" &</u> <u>"Enforcement</u>".
