"Opening Presentation", or "Key-Note Presentation", as related to: his view of the Most-Pressing Issues Facing Our Responsibly Self-Governing North-American Organic Body-Politic Community.

**Agenda Item 6:** New Court-Case, from Nevada; & involving two men, "Stewart Handte", & "Roger Hillygus". Roger started this series of events; by trying to free his 90-year-old elderly & mentally-impaired mother from an abusive institutionalized health-care environment. That triggered the military-police-state health-care mercenaries prosecuting & arresting Roger.

Stewart is a past County Sheriff, in Mineral-County, Nevada; & Roger successfully persuaded

Stewart to Assist Roger in freeing his mother from the abuses she was suffering at the defacto health-care institution. Rogers mother recently died at the hands of those militarized-police-state health-care subversives. Roger him-self is presently in prison, & is suffering serious life-threatening health issues.

Stewart is being prosecuted & threatened with imprisonment, as the direct result of his efforts to secure Justice for Roger & his mother in all of this. This is all a bit of a long story; &, Stewart has appeared & presented some of his story in our past conferences; & we expect Stewart here to give us another presentation & up-date regarding his case here with Roger.
