

**Notes: Second Stage of Economic Development, for Long Term Economic Stability; of the Christian/Israelite Torah-Law & Common-Law Compliant Kingdom, which is being Organized by Charles Bruce Stewart & his “Natural Law Church”, & this all under the inherent traditional authority of the “Court of Saint James” in-to a Responsibly Self-Governing Organic Body-Politic Community.**

Under our “First Stage of Economic Development”, as described in other articles; our Economic System is being “Jump Started” by the Logical & Reasonably Justified “Lawful Necessity” for Immediate Economic Relief to the Grass-Roots of the Common People of our US-American Organic Body-Politic; Our Community’s Pro-Tem Chief Judicial & Executive Officer, Charles Stewart, has Presumed to Begin Distributing to our Grass-Roots Leaders & Commoners, the Economic Credits which are Logically & Reasonably Justified to be so distributed, under both Biblical Torah-Law & Anglo/American Common-Law.

But; that sort of “Centralized Power & Control” is Only “Temporary”, sort of like with getting water to flow through a water-pump that has dried-out & can no longer maintain the vacuum necessary in order to get the water flowing; this process is similar to an action to “Prime the Pump”.

The Long Term Strategy inherently Implied under an accurate comprehension of the involved Principles of Biblical Torah-Law & Anglo/American Common-Law, Mandates that, at the earliest opportunity where-under Competent Politically-Sub-Divided Leadership might first become solidly Organized, then, those Leaders of our Smaller Self-Governing Communities Must Assume Long-Term Control of the Fair & Benevolent Distribution of All of these Economic Credits.

Here-under; & as soon as such may be practical, the Organic Governing Body of this Sovereign Constitutional Common-Law Monarchy & Kingdom, Will Collectively Affirm the Natural & Organic Law based Prioritized Necessity, for Our Governing Body to Move to a “Second Stage of Economic Development”, for this Alternative Economic System which we are here-by bringing in-to existence.

As applied with-in this Christian Common-Law Kingdom’s Organized Organic Body-Politic Community, Control of the manner in which All Economic Credits & Debits are Assigned & Distributed to the Lower Levels of our Lower-Level Nobility & Commoners, is Designed to be Given, eventually, but as soon as is practical to the Top Twelve Chair-men, aka Stake-Holders, Wise-Men, & Qualified-Electors, who Constitute this Inner-Circle Assembly of our High-Court’s Board-of-Directors.

From with-in this Higher Twelve-Member Inner Circle, All Credits will be Distributed, eventually, step by step, down Through the Progressively Smaller Populations of Each Level of the Organic Hierarchy lawfully so mandated, on Down to the Lowest Levels of the Common People with-in this entire Common-Law Compliant Organic Body-Politic Community.

Here-under; each of these Twelve High-Level Franchisees will be Entitled to Immediate Real-Time Control of One of the Twelve Separated but Equally Empowered “Valves”, each of which Direct, Throttle, & Control, the Flow of the Credits & Debts, to & from, all people involved in any manner with our Alternative Currency System.

Multitudes of Smaller Beneficiaries Will Be Receiving similar Credits; but, eventually, All such Credit Disbursements Will Be Distributed Through One of These Twelve Supreme Stake-Holders.

We expect that our computer system will be keeping moment-by-moment accounting for all of these accounts; & here-under, the twelve politically-sub-divided leaders of each of these communities need only concern them-selves with maintaining a responsible monitoring of the manner in which all of the Accounts under their jurisdiction are reporting any complaints, self-evident discrepancies, or other possible sorts of problems.
