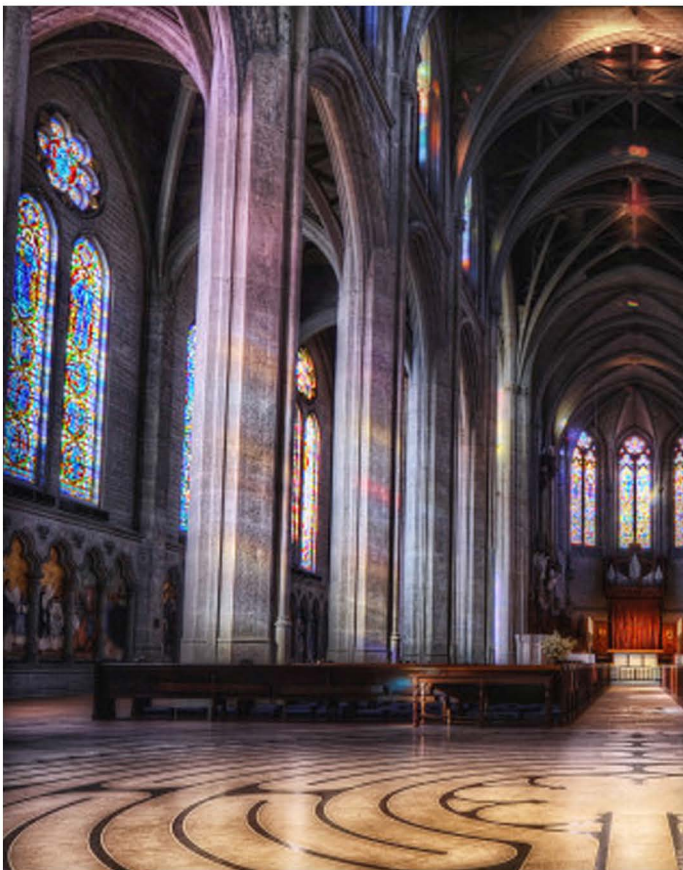

# FRFG Program Offer



This OFFER Program hereinafter referred to as the 'FRFG program' (the "Offer") is made, effective this: 21st Day of January, 2017 by and between Donors, and Ruslin Feitser, Trustee of The Elohim Geber Trust, a Washington State private trust located at 802 NE 112th Ave, Suite M114, Vancouver, Washington 98684 hereinafter referred to as ("TEgT and/or Pre-Chosen") in conjunction with Overseer Dr. Webster Moreland (WDM) World Dominion Ministries (and/or associates), legal 508c1A organizations and (TT) TETELESTAI TRUST.

- *Selected Individual and/or Business entities will be given a private opportunity to donate on levels starting at \$10k to \$200k until \$500k is obtained to complete the full donation block.*
- *An NDNC must be completely satisfied as well as a mandatory interview with TEgT Trustees.*
- *TEgT Interviews potential donor from this protocol, a decision is made to accept the Donor base on their ability to comprehend program.*
- *MOU contract will be signed as entry acceptance into Freely We Receive Freely We Give "FRFG program"*
- *Funds will be Freely transferred and donated to a State certified (508c1A) in the care of (WDM) World Dominion Ministries.*
- *World Dominion Ministries (WDM) will Freely Receive and Freely Give unto the Donor a "Donation Certificate" of the full amount donated for a tax write-off.*
- *Full amount of the donation write-off can be for personal, and/or a business may donate, or both in receiving the certificate of donation from WDM. (Donors choice on write-off's)*
- *After donor Freely Receives the donation certificate(s) from WDM, simultaneously The Elohim geber Trust (TEgT) will assign and Freely Give Raw Ore totalling 20% of the initially donated amount as a contribution to WDM in which TEgT will Freely Receive a Tax write-off donation certificate(s).*
- *WDM will Freely Give the assigned Ore to "TT" TETELESTAI TRUST for processing. Freely Receiving the Ore from WDM, "TT" facilitates the processing of Ore to concentrate and Freely Gives processed concentrate to a (PO) Private Organization who then creates an Irrevocable Trust with bank account and will convey the concentrate or equivalent in value to it.*
- *(PO) shall assign the irrevocable Trust and its conveyed value as a grant to the selected and/or elected beneficiary control. Thus providing asset protection / indemnity of deposit in the trust account owning nothing yet total control of everything within the trust.*

## Note:

Once World Dominion Ministries donation certificate is released, the overseer of WDM will enroll all donors into a Private Organization Grant Program as a candidate. The Grant in form of a Trust shall be gifted to selected candidates for their great heart of giving towards the empowerment of low to moderate income communities.

## ON DONATIONS:

In Basic terms, the donated amount to WDM (and/or associates), TEgT the Head Ore Holder in contract with the miner, TEgT will match the contribution and assign Raw Ore of equivalent Value to WDM. WDM will move the assignment to "TT' TETELESTAI TRUST for processing management by a schedule to newly granted trust account created and controlled by the "Private Organization". The amount of Ore in concentrate form equals the same value as the donated amount transferred to the Private Organization which uses this concentrate to buildout an Irrevocable Trust in two ways, (A) 20% in value of Gold concentrate and/or Gold Bullion (minus refinery fees and Taxes). (B) Return at 20% of donated amount in USD.

Example:

(A) Granted Ore-concentrate @ \$50k freely receives in the equivalent 20% Gold in concentrate base on Kitco Market spot prices. (Bullion minus refinery fees and Taxes) conveyed into trust.

(B) Granted Ore-concentrate @ \$50K freely receives 20% return of value, total (10K USD) conveyed into Trust.



Trust shall receive a schedule of their participation starting 90 days gestation period from the transference of donation to World Dominion Ministries (and/or associates). The total value conveyed is based on 20% of the level of donation.



Concentrates will come from 'TT' TETELESTAI TRUST Gold account held at David H. Fell & Company Depository either by check / transfer into trust account and/or Gold / Silver equivalent granted direct to Trust account from FELL Gold account minus refining fees / taxes and shipping.
