

“Oath of Office” **for the Township level Public-Office of:** **“Qualified Elector”.**

**“Traditional Anglo/American Common-Law Organic/Constitutional 'Township' Jurisdiction
& Social Safety-Net.” Super-Short Version, 1.0 .**

I, the under-signed, do solemnly Pledge, that, I have spent sufficient time studying our American National System of “Constitutional Government”, to clearly comprehend My “Duty” to be constantly “Bound by Conscience”, & to maintain my “Honor”, before my Fellow Constituents, & before my own personal version of a “Supreme Judge of the Universe”. I am aware that these “Duties” are “Necessary” for All Responsible People to Assume, in order to maintain harmony with the Supreme “Laws of Nature, & of Natures God”; as referenced in the opening-sentence of America’s “Declaration of Independence”.

Here-under; I have come to recognize, that, in fuller-context, America's “Original Constitutional-Plan”, contained specific “Mandates”; where-under, Our Common People had to “Keep the Peace”, in our own smaller Local Communities of approximately “Ten Heads-of-Households”; & that this is the Specific Numerical-Requirement for a Traditional Anglo/American Constitutional/Common-Law “Township”.

I here-under comprehend, that, my Township’s “Peace-Officer”, “Constable”, & “Tithing-Man”, is the Duly Elected “Leader & Representative” of our entire Township-Community; & that, this person is Responsible for “Keeping the Peace” for All Electors/Members in our Township; & that, powerfully related here-to, is our Town Constable’s Duty to insure the “Economic Security” of All Electors in our Township community, including my-self.

I here-under recognize, that, these are Very Precious “Benefits”, which all Electors derive from becoming “Qualified Electors” their community’s Townships; & that, here-under, it is “Reasonable” for all Electors, including my-self, to assume “Duties” to “Donate Regular Contributions”, of what-ever Economic-Recourses we might individually possess, to our Township-Community Treasury & Bank.

Through these “Regular Economic Donations”, I comprehend a Necessity for Our Township Community to Maintain Our Own Source of “Economic-Support” for “Essential Township Services”; & that this includes maintaining a “Social Safety-Net”, where-in Every Member of our Township has Sufficient Economic-Recourses to Cover “All Reasonable Expenses” which are Necessary in order for each Elector to Comfortably Carry the Burdens of his Duties in our Township.

I here-under recognize, that, to the Best of my Reasonable Capabilities, I am here-by Pledging to assume, as “Duties”, the following activities:

1: I Pledge to make reasonably Vigilant Efforts to Attend any & all “Town Meetings” which our Town-Constable might call to order, usually Weekly.

2: I Pledge to exercise “Good Faith” & “Logic” in working out a “Reasonable Consensus”, with my fellow Township Members, concerning Every “Matter Of Township Concern”, that Any of our Township Members Raises , in any of our Town-Meetings.

3: I recognize, that, our own smaller community's efforts at “Responsibly Self-Governing” will likely be “Doomed to Failure”; unless, we collectively have in place Mechanisms for “Judging”, Accurately, if any “Socially Irresponsible People” among us, might Act or Speak in manners which are “Disruptive” of the General Purposes of our Town Meetings; & that, if & when any Township Member is so Accused by any other Township Member, then, the remaining Members of our Township will incur a Duty to “Judge” Which of those Township Members needs to have his “Qualified-Elector Status” “Revoked”, & there-after to be completely “Excluded” from all of our future Town Meetings.

4: I comprehend, that, I here-under have a “Duty”, to Contribute, as I an reasonably capable of producing, from my own Time, Labor, & other Economic Recourses, & in an approximately Equal Proportion as my fellow Electors/Constituents; all for the Collective Betterment of our Township Community. I here-under Pledge to Regularly Contribute sufficient Economic-Recourses, from what-ever sources I might possess; as “Tithing Donations”, to our Township-Community Treasury & Bank; with that all under the Care & Keeping of our Township’s “Tithing Man” & Constable, for him to Keep Safely there-in, for the Mutual Benefit of us All.

5: I Pledge to act as a "Juror", when-ever lawfully called to do so; & there-by to Responsibly Participate in "Administering Justice" for our Township & Precinct level Communities; & that this May further Require, as I am reasonably able, for me to "Investigate" by "Inquiring" from Other People, as to whether or not they, or those they know, are Causing any "Social-Injustice" to manifest, which might be "Disturbing the Peace" of the Township with-in which I hold my membership.

6: I recognize that, regarding any & all Issues of concern which are related to my Household, & which I am not personally capable of peaceably resolving, that I have a Duty to Communicate these Concerns on Up the Chain-of-Command, to our Town-Constable, so that he can exercise his larger Township-level jurisdiction, to assist me in maintaining the Peace, Safety, & good Order in my own Household.

7: I further Recognize, that, I have a Duty to promptly Obey all Commands from our Town Constable; with my only "Exception" for Refusing to Obey such a Command here, being, if I can make a Believable Argument to My Fellow Electors, that, I Sincerely Believe, that, the Order I was Refusing was in Violation of some form of "Higher Law", such as "Natural Law", or the "Laws of God"; & that if I can Not make any such "Good Excuse" for Refusing any such Command, that, this could be grounds for my Loosing my "Qualified-Elector Status" in our Township. Of particular significance here-under, is my Duty to Support our American Constitutional Concept of "Posse Comitatus"; & where-under, I may be called to Assist my Town's Constable in Serving "Judicial Paper-Work", in "Making Arrests", &/or in other-wise "Keeping the Peace". I comprehend that this fundamentally important Duty may some-times require me to "Risk my Life".

Here-under; I further recognize, that, there are Many Different "Duties" which the Individual Members of our Township will eventually likely be asked to assume; but, that, if any among us might have "serious Conscientious-Objection, Mental-Block, or Emotional-Insecurity" about actually performing any of these Duties; that, Others in our community can likely Shoulder those Burdens, & that such apprehensive Electors should be given Reasonable Opportunities to Contribute to our Township's general Welfare, Security, & Economic Self-Sufficiency, in such Other Manners as may be more comfortable to them, at least So Long As the Over-All Burdens & Risks Remain approximately "Equally Distributed" among Each & Every Elector/Constituent/Member of our Township.

I have sufficiently reviewed documents related to this oath document, & which explain the history, duties, & benefits of my participating in this effort at smaller community self-governing; & I have no significant disagreements with the Duties described there-in; & I solemnly affirm that I will exercise Vigilance & Good-Faith in my Efforts to Full-Fill these Duties.

Here-under, I do solemnly Pledge & under-take to Bear such "Burdens" as are roughly Equal to those being similarly carried by the Other "Burden-Holders" of our Township Community; & I further Pledge to fill my similarly Necessary Duties as a "Stake-Holder", in order for our Township-Community to collectively Fill Our Duties as a Socially-Compacted & fully "Constitutional Township" Jurisdiction.
