## "Oath of Office" for the Township level Public-Office of: Constable, aka: Peace-Officer.

I, the under-signed, do here-by solemnly Affirm, before all men, & before the Supreme-Judge of the Universe; that, to the best of my ability, I sincerely do intend to Responsibly & Faithfully Perform the Duties of a "Town Constable", for the "Township Jurisdiction" here-under specified. (Version 2)

I recognize that my "Duties" here, include, but are not limited to, the following:

1: I recognize that I have a Duty to <u>exercise "Community Care-Taking Functions</u>" & to <u>Maintain Regular & Adequate Supervision over</u>, <u>Each House & other Building</u> in our Township's Jurisdiction; <u>along also with the Roads and other Public-Utilities</u>, all so-as-to Insure here-in Peace, Safety, & good Order here-in; & here-under, to <u>maintain such "Open Lines of Communication</u>" that I may <u>efficiently Respond to Every Issue of Any Concern which any person here-in might communicate to me</u>.

2: I further recognize that my Duties here also include my <u>making reasonable & good-faith</u> <u>efforts at conducting & presiding over regular "Town Meetings"</u>; & in making such other reasonable efforts as are necessary in order to <u>maintain Peace</u>, <u>Justice</u>, & <u>Harmony in our Township</u>. I recognize that this will require that I <u>Seek "Consensus" amongst all "Qualified Electors" in our Township</u>, <u>concerning "Every Issue"</u>

of "Any Concern" which any among them may communicate to me.

**3:** I further recognize that I have a Duty to consistently <u>Defer to each of the Separate & Sovereign Jurisdictions of each of these Qualified-Electors</u>; all so long as I remain reasonably convinced that All Activities Occurring on his Land are Occurring in a "Peaceful Manner".

- 4: I recognize that I have a Duty to make Reasonable Efforts to <a href="Attendall Precinct level">Attendall Precinct level</a>
  <a href="Meetings">Meetings</a>, & where-in I have the further Duty to respectfully & Vigilantly Seek "Consensus" on "All Matters of Mutual Concern" among each of the Constables of separate Township Jurisdictions which comprise our Precinct. I recognize that <a href="https://doi.org/10.1001/jurisdictions">this especially includes</a> the <a href="Maintenance of this "Consensus"</a> amongst our ten or less Township-Constables, <a href="concerning Who from among us shall occupy our Leadership position">concerning with ten or less Township Precinct Capitan</a>. I also recognize that, Any One of our Ten or less Town-Constables have the Right & Duty to <a href="Call for a "Vote of Confidence">Call for a "Vote of Confidence"</a> in our JoP Leader, <a href="At Any Time">At Any Time</a> that he might feel so Justified; & he may then & there propose that our Consensus should be Shifted to Another More-Qualified JoP/Leader.
- 5: I recognize <u>that</u>, regarding <u>any & all "Township Issues" which I am not fully capable of resolving, <u>I have a Duty to communicate these concerns</u> on up the chain-of-command, <u>to our "Justice of the Peace</u>", so that he can exercise his larger Precinct-level jurisdictional authority, on our behalf.</u>
- **6:** I further Recognize that <u>I have a Duty to our elected JoP</u>, <u>to promptly & vigilantly Obey all Commands & Directives that he may Order me to carry out</u>; save only unless, in that instant, I am firmly convinced that such commands are "Un-Lawful". In any such instances as this, I will promptly give fully adequate explanation & justification for my Refusal of his Command, before all of our Town Constables, at our next Precinct level meeting, if not sooner. I recognize that my Duties here are of most serious importance in the matter of <u>my Assisting our JoP in the Selection & of Jurors</u> in all cases that might be brought before our Precinct-level Hundred-Court Jurisdiction.
