"Oath of Office"

for the **Township level Public-Office** of:

"Qualified Elector".

"Traditional Anglo/American Organic Common-Law 'Township' Jurisdiction, & Social Safety-Net." Version-4; ... Last Up-Dated: June-2019.

I Recognize that <u>our American System of Constitutional-Law</u>, <u>Preserves our Rights of "Local Self-Government</u>"</u>, as referenced through the First, Second, Sixth, Seventh, Ninth, & Tenth Amendments, to the "U.S. Constitution" document; & that, <u>this especially includes the Rights of Our People to Assemble as "Responsibly Self-Governing Communities"</u>, <u>in our own "Township" Communities</u>, <u>of approximately "Ten Households</u>"; which is the specific numerical-requirement for these Anglo/American Communities, <u>as under our smaller traditional Organic/Constitutional "Common-Law Jurisdictions</u>".

I recognize that <u>our American Constitutional System of Organizing Our Own "Responsibly Self-Governing Communities"</u>, <u>was</u>, from the very beginning of our Nation, <u>Founded & Established by the Actions of "Courageous Men"</u>; all <u>of whom were Increasingly Suffering under</u> the Tyranny of <u>a Powerful Criminal Mob-Boss</u>, who was Scheming to Reduce them to Slavery; & <u>who there-by left our American Founding-Fathers with No Reasonable Choice Other Than to resort to "Armed Resistance" to their looming collective En-Slavement.</u>

<u>I recognize that this same basic Spirit of "Enslaving Honorable People" is again Manifesting</u> it's Appearance <u>with-in our American Nation</u>; & that, here-under, I <u>& my fellow Township Members Must be Prepared to Defend Our Smaller Communities from such Criminal Conspirators.</u>

I here-under recognize, that, our Nation's Constitution's Rules of "<u>Due Process of Law" require "Trial by Jury" with "Unanimous Verdicts"</u>; & that this implies that our <u>Community Decision-Making</u> should be based on the formation of at least <u>a "Consensus"</u>; so that the Collective "<u>Conscience of the Community</u>" can be Discovered & Affirmed as our "<u>Norm of Behavior</u>", all under which our Communities should "<u>Responsibly Self-Govern</u>".

I here-under recognize that my Duties here include my <u>making reasonably vigilant & good-faith efforts to Attend any & all "Town Meetings</u>" which our Town Constable might call; & that I have a Social "Duty", (to the best of my reasonable capabilities), to Participate in these smaller Community Meetings, all in "Good Faith", & to Respect all sincerely held Opinions of Others. I recognize further, that, this Common-Law Consensus-Building Process Requires that all Town Meetings Encourage <u>All</u> People there-in <u>to Voice Their Own Proposed "Solutions"</u> to all problems manifesting in each of their Townships.

I further recognize that there are many "Problematic People" in this world, who are Not "Socially Responsible", & who will likely Refuse to Honorably Participate in Good-Faith Discussions of how our Smaller Communities should "Responsibly Self-Govern". I further here recognize, that, unless firm & clear "Judgements" are Made to "Exclude" any such "Socially Irresponsible People" from participating here-in, then our own smaller community's efforts at "Responsibly Self-Governing" will be Doomed to Failure. I here-under Recognize our Community Needs for Mechanisms for Judging Accurately if any people in our Community Meetings might be so "Socially Irresponsible" that they will need to be "Excluded" from our Township Community Meetings.

I recognize that the Leader of our Township is to be Elected through a "Consensus Based" process; & that, basically, All Activities of our Township Community will require a similar "Consensus". I also recognize, that, the "Cause of Justice" must be Defended by our Community Members; but also that no serious Dangers should be risked unless all members of our Township community Agree to take such risk.

These potential calculated-risk Dangers include, that, <u>I may be called on to Assist in "Making Arrests</u>" of persons for whom "Probable Cause" Exists to Form the Belief that they have Committed a Crime, all as recognizable under traditional "Due Process of Law".

Broader Duties here-under, include, that, <u>I have a Duty to promptly & vigilantly Obey all Commands & Directives that our Town Constable may ask me to carry out</u>; with my only "Exception" for Refusing to Obey such a Command here being if I can make a Believable Argument to My Fellow Electors in our Township that I Sincerely Believed that the Order I was Refusing was in Violation of "Higher Law" or "Natural Law" or the "Laws of God"; & that if I can Not make any such "Good Excuse" as this for Refusing any such command, that, this

could be grounds for my Loosing my "Qualified-Elector Status" in our Township.

Other Duties I am here-by assuming, include my promise to honorably respond when-ever I might be <u>Called On to Participate in "Administering Justice" as a "Juror"</u>; <u>& that this</u> or other similar callings made to me <u>May Require that I &/or others "Investigate" by "Inquiring" from a broad spectrum of possible People</u>, including perhaps even Corporate-Executives & Government-Officials; as to <u>whether or not activities of them-selves or their associates are causing any form of Social-Injustice</u>, especially as with-in the Township Community with-in which I hold my precious membership.

Similarly here-under; I also recognize, that, <u>I may be called on to Participate in Lawfully Organized & Prudently & Strategically Engineered "Public Assemblies"</u>; & that, <u>this may include</u> Assemblies on or near <u>Court-Buildings</u>, <u>City & County Office-Buildings</u>, <u>Newspaper-Offices</u>, <u>Television & Radio Stations</u>, <u>&/or Police or Sheriff's Headquarters</u>, & <u>Jails & Prisons</u>.

I further recognize, regarding <u>any & all Issues of concern which are related to My Household</u>, & <u>which I am not fully capable of peaceably resolving</u>, that <u>I have a Duty to Communicate these Concerns</u> on Up the chain-of-command, <u>to our Town-Constable</u>, so that he can exercise his larger Township-level jurisdiction, to assist me with in maintaining the Peace, Safety, & good Order in my Household.

I comprehend, that, <u>my own "Qualified Elector" Status is dependent & contingent on my consistently maintaining the Testimony of at least "Two Witnesses"</u> to My Qualified-Elector Status, each of which also have to similarly maintain "Two Witnesses" as to their own Qualified-Elector Status; & that this can & <u>frequently should result in Smaller "Three-Member Communities" Certifying Each Others Qualified-Elector Status</u>. I comprehend further that all of this is constantly dependent on every such Qualified Elector maintaining their own Two-Witness Certified "Good Reputation" for "Honorable Behavior".

I comprehend further, that, this "Good Reputation" of Each Elector/Member of our Township Community, is the Basis up-on which I & my fellow Township's Electors are Duty-Bound to Constantly Maintain our own "Commercial-Credit Worthiness"; & that, further here-under, Each Member of our Township, including my-self, have Duties to Pledge our personal Resources of both Goods & Services, not only so that these concerns for basic economic needs of each & all of our members are fully met, but also so that the long-term Survival of our Township Community is Reasonably Guaranteed. This is the nature of the "Commercial Bonding", up-on which Our Town Treasury/Bank will have access to sufficient "Social Credit", in order for Every Member of our Township Community to have a Claim to Sufficient Funds from our Treasury/Bank, so that All of the legitimate Economic Needs of each Member of our Township are Fully Met.

<u>I have sufficiently reviewed documents related to this oath document</u>, & which explain the history, duties, & benefits of my participating in this effort at smaller community self-governing; & <u>I have no significant disagreements</u> with the Duties described there-in; & <u>I solemnly affirm that I will exercise Vigilance & Good-Faith in my Efforts to Full-Fill these Duties</u>.

I do solemnly under-take to full-fill these Duties as Socially-Compacted Member & a "Qualified Elector" in the below described "Township" Jurisdiction.
