As explained in these documents, & their web-linked supportive documents & videos, (considered in their full context); these Fraudulent Declarations of Corona-Virus Militarized Health-Care Emergency, are all Maliciously Designed to Promote a Military-Police-State form of Despotic & Tyrannical Government, where-under Our Military People are becoming Incapable of Mentally, Spiritually, & Physically Maintaining our National Security & Defenses, & further where-under, our Common Working-Class American People are either Reduced to Slavery; or, in essence, Murdered; all of which, as a matter of law, & in its essence, amounts to a Conspiracy to Commit "Treason".

**Under the Authority of the Mandate of Our Constitutionally Legitimate & Common-Law Compliant Jury, as Assembled from the Honorably Concerned People of the USA; this Supreme Court of Law here-by Judicially Orders You, General Berger, (along with all other Military & Non-Military Public-Servants in our USA), To Do All In Your Power To Cause the Immediate Restraint & Stoppage of All Coercively Imposed MRNA-Covid-19 Vaccinations, on Any Americans, Including especially Military Personnel.**

We suggest, that, you take these documents to your Judge Advocate General's Office, (JAG Office), & that you ask them to communicate to you & us if they might find any errors in any-thing that we are saying in these or in our related documents. The Navy and the Marine Corp have the constitutional and judicial investigatory duty and authority through the JAG Office, to take this role when necessary. Pursuant to your position as Commander of the Marine Corp this responsibility falls to you when the traditional channels of judicial resolution and protection have been disabled, as is the case in this instance.

General Berger; you are here-by being approached pursuant to Your Constitutional Oath to Protect Our Nation from foreign and domestic harm, and in your capacity in the line of lawful defense against abuses of American citizens' rights. We have noted with pleasure the news that you have already taken some courageous stands on this precise issue: & this is the reason why we are sending you this more personal communication about our efforts here in these same areas. More specifically; the Treasonous Conspirators here-in referenced, have not only egregiously Violated the Constitutionally Protected Rights of our Military Soldiers of all branches; but also of All Federal and State Employees, of all First Responders, and all of our American People, including all Tribal Nations. All of these Americans are in Grave Danger of Suffering Irreparable Medical Injury, Disability, and/or early Death. This issue is of Prioritized Concern for our Military People; because of Defense Secretary Lloyd Austin's Edict Threatening Court Martial or Discharge Against all Armed Forces Personnel, unless they Submit to Covid-19 Vaccinations. **If our Military People Take that Vaccine, there is Great Danger They will become So Physically & Mentally Harmed, that, they will Fail in their Performance of Their Duties to Protect our American People.**

**Our Jury has unanimously adjudicated, that, a Large Faction of our nation's Public Servants have become Corrupted, and that they can no longer be reasonably expected to protect the rights and liberties of our common People. Therefore, Courts of Common-Law Jurisdiction are Being Established to take over this function; as is the case with this Supreme Court of Law; all of which is explained in another document which also should be in accompaniment here-with, & which is web-linked as follows:**

With-in Our USA Supreme Court of Common-Law Jurisdiction, our Chief Organizer and Constitutional Law Scholar is Charles Stewart, of Texas. This Court is Organized to Provide Truth, Justice, Security, & Peace, for All of Our American People, Including Military People.

This document has been composed as a joint effort, by Charles Stewart, & also by

myself, Mike Lerman, as further described at the end of this document. Here-under; I am now acting in my capacity as a Republic Citizen's Ombudsman, & as a Common-Law Jurisdiction Judicial Investigator; whose job is to Promote Truth & Justice for our American People. **Here-under; I am now the Primary Conduit for All Communications between you, General, and our Supreme Court of Law for the USA. I pray to God, that, you will work with me & my associates in promptly addressing this very Serious Emergency Situation; & there-under securing the here-in described end goals, sir.**

As our Jury has unanimously adjudicated; this harm which we are informing you of, is manifesting in the form of Coercively Imposed MRNA- Vaccinations; all of which our Jury has further unanimously adjudicated to amount to "Bio-Warfare Weapons". The even more fundamental & foundational issue, is that, those Alarmists have Not Provided Any Reasonable Evidence that there Actually Exists Any extraordinary Serious Threat to the Health of our American People from Any Corona-Virus or it's variants that warrants such extreme actions being taken. Many **Doctors Don't take these vaccines, because, they know the Mrna Vaccines are Harmful, and that it wrecks people's immune systems.**

Our Jury has further unanimously adjudicated, that, all people of this country who are fully & responsibly informed of the Evidence related to this issue, consider this current crop of experimental Vaccinations to be of a extraordinary medically harmful & experimental concoction, all of which will very frequently result in serious harm to life and limb.

**Our Jury desires is to Avoid Bloodshed in this country; & we recognize that we are at a tipping point in our United States of America, right now, with this order for forced MRNA vaccinations. That Order & associated efforts Need to be Stopped, Immediately; or else grave Danger will exist that War in this nation will break out.**

**Our American People have the Constitutional Right to Resort to Using Armed Force to Resist Treasonous Conspirators orders which are unlawful and in full violation of the Nuremberg code who are Masquerading as public servant Government Officials, but who are intentionally Coercively deceiving and Imposing extremely dangerous Crimes against Humanity Medical Procedures that our American People now know are genetically engineered Bio-Weapons designed intentionally destroy our immune, and neurological systems to Sicken & Kill Us. These vaccines were made intentionally different by corporate agents of foreign powers for very evil and covert purposes.**

Our Jury recognizes, that, all of this amounts to a "Casus Belli"; which, as you

likely know, is the traditional justification & legitimization for common people to Rise Up, & to Use Force to remove Foreign agent domestic enemies hostile to our life safety Corrupted Leaders who are perpetrating these Treasonous horrific Crimes against our American People.

**Through this document, General, our American People are Mandating that You Exercise Your Power given to you by the people to Stop this Domestic War from breaking out. Here-by; Our People Demand, that, You Do All In Your Power to cause the Biden Administration to Stand Down on their Coercively Imposed vaccination Agenda immediately. We already have way too many other conflicts, including with foreign nations; & this issue will surely sink our nation, unless it is stopped now.**

As Our Court of Law is here-in Proceeding in the Name of, & on the Behalf of, the People of our USA; here-under, our Court here-by Notifies You, General, that, in this case, the “Interests of Justice” Mandate & Require that You Provide Responsive Communication to this Judicial Mandate, Order, & Inquiry, from this Court Assembly of our American People.

Preferably, please provide us with your “Written Answer”, to my office, as addressed at the end of this document; & inform us please there-in, as to whether or not you intent to carry out this lawful order and mandate.

Please accomplish all of this in a “timely manner”, due to the pressing nature of this emergency; which we consider to be roughly 10 days. We are of the opinion, that, Your Constitutional Oath to Protect Our Nation from all enemies foreign and domestic, Requires this from you. If you believe our interpretation of applicable “Law” here is “In Error”; then, we demand that you explain to us, in a timely manner, your “Reasons Why”.

General, this situation is extremely hot, tense, and serious. Please consider this document to be your intelligence briefing and lawful order, directly from our American People. Please put your best officers on this immediately, especially your JAG officers; and please communicate back to me as soon as possible.

**General, in my capacity as a representative of our American People, I am here-by delivering to you this Court Order, that, You do all In Your Power to Stop the Biden Administration from Coercively Imposing the here-in referenced Vaccinations upon our American soldiers, sailors, marines, and airmen, & all of our fellow country men, women, and our children. Protect them from these mad men.**

**The lives of our fellow brothers and sisters in arms, are precious. You must do all in your power to Stop those ignorant or evil people, General, while there is still time. Generally, & now especially through your receipt of this document; You have the lawful Orders and Right and Duty to Tell All Biden Administration**

**Personnel 'No', regarding their coercively imposed vaccination. You and all Americans have this Lawful Authority pursuant to the Fourth Amendment: “The right of the people to be secure shall not be violated”.**

**This is extremely urgent, Def-con-1, Urgent! Corrupted Conspiratorial Command and Control Leadership have ordered the Coercive Imposition of Vaccinations on our soldiers. The logical implications there-of, are that, we are only days or weeks away from losing our ability to defend our nation from this mrna laboratory made rushed into use bio-weapon. The full medical harm and danger it poses has not yet become fully apparent.**

This coercive imposition of this genetically engineered medical experiment will severely damage most of our constitutionally protected rights, including our health care management rights, our right to travel and to do business, and our right to a life that is free from forced injury and death.

**The 'vaccines' are known to cause severe neurological damage to the brain and nervous system, cause severe and uncontrollable seizures, micro blood clotting, irreparable damage to our DNA and to the vital organs involved in the proper functioning of our immune systems.**

Our Courts Jury has found Probable Cause to form the Belief, that, there is a “Proven Conspiratorial Agenda” at work here, as Evidenced by the common-knowledge Fact of the Active Campaign to Cherry-Pick & Obstruct Discussions & Public Access to All Evidence & Information, including Medical Professional Testimony, concerning the COVID 19 virus, its variants, and the 'vaccines'.

This “Alternative Evidence” is So Massive in Volume, & is being presented by so many top notch Credible Sources from around the world, that, all reasonably thinking people are brutally driven to consider that malicious & criminal intent is the only reasonable explanation to continue to allow and promote these dangerous injections to still be used.

Our Jury finds probable cause to form the belief, that, both the original virus, and now these variants, and the experimental vaccine injections, are all “Bio-Weapons”, aimed at Disabling & Killing large parts of our population. Corrupted Leadership here-under seems to be strategically & militarily calculating, that, a nation whose people and military have been weakened and disabled will be unable to defend itself against their parasitical and foreign state acts of aggression.

The possibility of a military take over of our country, seems a real possibility now; and the commercial mass media, the internal intelligence agencies, and Big Pharmaceutical Corporations, all appear to be fully and criminally engaged in this massive cover-up.

Though reports are starting to come in from around the world, the scope of the damage may not yet be fully apparent for a while. Medical specialists that the worsening effects of these vaccines experimental injections will become more and more obvious within 2 to 6 months. There are even reports of some people being severely affected, including dying, immediately or within a week or two of taking either of the shots but especially the second shot. Most of these reports are being suppressed by the main stream media. See a more comprehensive list of adverse side effects in our supplemental document.

Credible experts are saying that the vaccines will begin to make those who took it very very sick, and those who are sick will become super spreaders of the spike protein we are trying to stop.

The more injections a person takes the less effective their immune system becomes. This makes them a perfect host for more and more dangerous Bio-Engineered Pathogens. These individuals will in turn will become a new health hazzard to the vaccinated and unvaccinated alike, all of which will increase this larger cycle of disease and death.

These coercively imposed vaccinations are a catastrophic time bomb. Since the experimental vaccine starts to destroy the brain's neuro-motor functions, and the blood's clotting systems, it is only a matter of time until the recipient will not be able to drive a car or boat or fly a plane safely.

It is my understanding that the commercial airlines are having to cancel flights due to a shortage of pilots, because, their mandatory vaccination policy has lead to the loss of a number of pilots due to blood clots at high altitudes.

If even 50 percent of our soldiers, sailors, and airmen fall severely ill, become medically incapacitated, disabled or die from the COVID shots, we will lose so much of our capacity to protect our nation from war that we likely will have lost our nation forever. As you are aware, F35 pilots take years to train. Our competent & loyal military leadership will face serious disaster, if, these pilots are medically incapacitated through these coercively imposed Bio-Warfare Vaccines.

There appears to be no down side to not vaccinating. Experts say that between 97 to 99.75% of the people who get COVID recover from it. They naturally develop

antibodies creating their own immunity. For most people, the illness is a disruption for a week or two. Genocide, as defined by the Nuremberg Convention:

Genocide is defined as "any of the following acts committed with intent to destroy, in whole or in part, a national, ethnic, racial or religious group, as such": "killing members of the group," "causing serious bodily or mental harm to members of the group," "deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part," "imposing measures intended to prevent births within the group," "forcibly transferring children of the group to another group." 4 In addition to "genocide," so defined, other acts are made punishable: "conspiracy to commit genocide," "direct and public incitement to commit genocide," "attempt to commit genocide," and "complicity in genocide." 5 All persons "whether they are constitutionally responsible rulers, public officials or private individuals" who commit "genocide or any of the other [enumerated] acts" are to be punished 6 and the "Contracting Parties undertake to enact, in accordance with their respective Constitutions, the necessary legislation to give effect" to the Convention and to provide "effective penalties." 7 Trial is to be "by a competent tribunal of the State in the territory of which the act was committed.

Adverse reactions and complications with MRNA experimental vaccines discovered to date:

- **Guillain-Barré Syndrome:** A disorder in which your body's immune system attacks your nerve system. This may eventually paralyze your whole body.
- **Acute Disseminated Encephalomyelitis:** An inflammation that affects the brain and spinal cord, usually in children. It damages the coating that protects nerve fibers, called myelin. Symptoms may be severe.

- **Transverse Myelitis:** An inflammation of both sides of one section of the spinal cord. This neurological disorder often damages the insulating material covering nerve cell fibers (myelin). Transverse myelitis interrupts the messages that the spinal cord nerves send throughout the body.
- **Encephalitis:** An inflammation of the brain.
- **Myelitis:** An inflammation of the spinal cord which can disrupt the normal responses from the brain to the rest of the body, and from the rest of the body to the brain.
- **Meningitis:** An inflammation of the meninges. The meninges are the three membranes that cover the brain and spinal cord.
- **Encephalopathy:** A damage or disease that affects the brain. It happens when there's been a change in the way your brain works or a change in your body that affects your brain. Those changes lead to an altered mental state.
- **Convulsions/Seizures:** Seizures cause rapid, rhythmic and sometimes violent shaking movements of the body, often with loss of consciousness.
- **Stroke:** A stroke is a sudden interruption in the blood supply of the brain. Most strokes are caused by an abrupt blockage of arteries leading to the brain. Other strokes are caused by bleeding into brain tissue when a blood vessel bursts.
- **Narcolepsy:** A sleep disorder characterized by excessive sleepiness, sleep paralysis and hallucinations.
- **Cataplexy:** A sudden loss of voluntary muscle tone. The condition is often associated with narcolepsy.
- **Anaphylaxis:** A serious, life-threatening, allergic reaction.
- **Acute Myocardial Infarction:** A heart attack. Occurs when blood flow to the heart muscle is abruptly cut off, causing tissue damage.
- **Myocarditis:** An inflammation of the heart muscle. Symptoms can include shortness of breath, chest pain, decreased ability to exercise and an irregular heartbeat.
- **Pericarditis:** An inflammation of the pericardium (the fibrous sac surrounding the heart). Symptoms typically include sudden onset of sharp chest pain, which may also be felt in the shoulders, neck or back.
- **Autoimmune Disease:** A condition in which your immune system attacks your body because a drug or vaccine that was received contains human cells foreign to

your own.

- **Pregnancy and Birth Outcomes:** Preterm delivery (premature birth), growth restriction, low birth weight, stillbirth (dead baby) and long-term chronic diseases.
- **Acute Demyelinating Diseases:** Any condition that results in damage to the protective covering (myelin sheath) that surrounds nerve fibers in your brain, optic nerves and spinal cord. This includes multiple sclerosis (when your immune system attacks the myelin sheath or the cells that produce and maintain it), optic neuritis (inflammation of the optic nerve in one or both eyes) and adrenoleukodystrophy/adrenomyeloneuropathy (inherited metabolic disorders).
- **Non-Anaphylactic Allergic Reactions:** Failure of an organ system.
- **Thrombocytopenia:** A condition in which you have a low blood platelet count.
- **Disseminated Intravascular Coagulation:** A condition in which blood clots form throughout the body, blocking small blood vessels.
- **Venous Thromboembolism:** A condition in which a blood clot forms most often in the deep veins of the leg, groin or arm and travels in the circulation, lodging in the lungs.
- **Arthritis and Arthralgia:** Joint pain.
- **Kawasaki Disease:** An illness that causes inflammation in arteries, veins and capillaries. It also affects your lymph nodes and causes symptoms in your nose, mouth and throat. It's the most common cause of heart disease in children.
- **Multisystem Inflammatory Syndrome:** A condition where different body parts can become inflamed, including the heart, lungs, kidneys, brain, skin, eyes and gastrointestinal organs. Children who suffer from this condition may have a fever and various symptoms, including abdominal (gut) pain, vomiting, diarrhea, neck pain, rash, bloodshot eyes and feeling extra tired.
- **Vaccine Enhanced Disease:** When the disease that you have is worsened by the vaccine that is supposed to protect you.

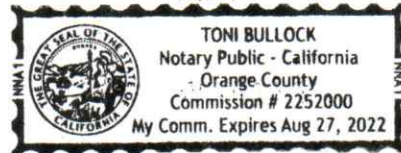
