Nature of this Complaint:

This Plaintiff, Roxanne Dye brings this Complaint before this Court, that, Eric Dingis not only Stole \$116,000.00 from our small community of patriots here in Tennessee, but that he maliciously schemed & planned ahead to "set us up" & to deceive & mis-lead us in-to trusting him with our money.

I believe the Evidence will prove, that, Eric has enchanted many people in-to working with him, at least some of whom were not purposefully malicious, but also at least a few who were his knowing co-conspirators, & who likely received some form of kick-back or other benefit from Eric in exchange for their complicity in helping Eric to deceive & steal from us all.

In my efforts to bring Justice in this case to the People of the Republics of Tennessee & the USA, I am willing to personally submit this same testimony, in open & public video conferences; & there-under, to subject my-self to being cross-examined for Truthfulness, not only by Eric, & his supporters; but also by all people acting in good-faith as Jurors in this case.

I only want Justice here,  
& this is very important to me, & to numerous other people.

To Begin, My Formal & Truthful "Testimony", here-in, Is:

This Plaintiff, Roxanne Dye, first met Eric Dingis with Angie Kitchen near late 2021.
They came to our Tennessee patriot group,
volunteering to teach us how to gain our sovereignty back,
and to help us to get out of the private-corporation defacto-government.

On one occasion near this time, Eric brought in four people,
whom he introduced to us as being a part of the "Nesera/Gesera" Organization.

(I do not presently recall the names or
home-ground areas from where these other four people came;
but i will try to find this important data from others involved in this case.)

There-under, Eric & these others said, that,
they were Ready to Deliver to our Republican State of Tennessee,
a large amount of Gold & Silver;
but that, before that could be completed,
we Tennessee Patriots needed to First Contribute Cash Money
in-to some form of a "Cash Depository".

Eric then also Presented His Own Elaborate Plan,
for us all to safely but quickly Accomplish all of this;
& one important part of his Plan here,
& Involving Why This Money was Needed, & What it was to be Spent On;
was that, as soon as possible, we needed to
Find Some Small Banking-Institution, some-where,
& Pay Money to "Buy That Bank".

Eric then informed us, that, he had already been looking around at
differing Banking-Institutions that were Possibly Available for us to Purchase for this
purpose;
& that He Already Had One Small Bank Lined-Up & very Likely Available for us;
if we could just get all of our money together quickly & complete it's purchase.

Eric then also said, that, part of His Plan, was to:
Set-Up an Internet-Based Web-Page "Server",
in order that, once we purchased our Small Bank,
that, our Tennessee Patriots could then Quickly & Efficiently

Transfer Their Own Credits & Debits Back & Forth;
& to there-by Create Our Own Very Efficient "Alternative Banking-System".

But, here-under; We were Never Told, that,
Our Money was Going To Be Used To Pay Him, Eric,
For His Efforts At Setting-Up That Alternative-Banking Internet-Server.

But; Eric & his associates here Had Lots of Words directed to us all;
where-under they were All In this Very Big & Excited Rush
to Get All of This Money Collected as Quickly As Possible for his elaborate project.

At this time, & at all times after this;
Eric has Never Informed Us, that,
He was Going To "Charge Us Money", in exchange for,
the Efforts which He Was then Contributing
to get this entire project up & running properly for us all.

I recall I then specifically asked Eric, about,
How Much Money was Needed, & related details;
but Eric Evaded Answering my Question,
by then Directing Me to seek answers to my questions
from his associate "Lynn Wagner".

At this point, I did not know Lynn Wagner; but i did know her sister, "Carrie Wagner".

When I contacted Lynn, Lynn then said, confidently, that,
I should expect to make an 8% interest return on my investment in their project.

At this point, Eric began Constricting all of his Communications;
& No Discussion was Reasonably Available about the Details & Safe-Guards
that were supposedly making this project as safe
as they were all confidently posturing like it was.

All of them were then only In a great Big Hyper-Energized Rush
to Focus Exclusively On "Getting Money Quickly" for this entire project.

Nothing was then offered to be formalized in-to
any contract, or other form of written-agreement.

I confess, in my hind-sight here, i can now much more clearly see & comprehend,
that, I then had Become "Emotionally Caught-Up" in this this Very Emotionally-Energized
& Seemingly Righteous, (but Poorly-Thought-Out), Larger "Mass-Group-Effort".

I can now much more clearly see & comprehend, that,
the "Emphatic Focus", then, by Eric & his associates;
for our Patriotic-Group to "Act Quickly", to "Collect This Money",
in our Group Efforts at Completing this Seemingly Very Important,
Very Needed, & Very Safe Patriotic-Project;
was actually Not a "Safe Project" at all.

Rather, (in its most favorable light);
it was a Poorly-Thought-Out & "Recklessly-Negligent Project";
& that, the much more likely explanation, is, (& which i believe the evidence will prove),
is that Eric & at least some of his (border-line-hysterical) Associates
were Maliciously Scheming, From The Start, to Deceive & Plunder
the Limited Economic-Resources of we Honest & Hard-Working
Grass-Roots Tennessee Republic Patriots.

I am among this same group of "Limited-Economic-Resources Working-Class Patriots";
& I Was "Maliciously De-Frauded" by Eric Dingis & his associates,
in-to Contributing & Loosing My Own \$15,222.12 in
this Maliciously-Engineered "Scheme of Deception & Theft".

I think about this evil situation every day;
& I have cried many tears over it;
& it feels constantly to me like i am carrying a very heavy load on my back!
Can't hardly sleep at all; because I am Stressed about this evil All of The Time!

A serious part of my stress, is coming from the fact, that,
my son has injured him-self, & is out of work for at least 3 months.
Normally, i would be in a position to help him with his difficulties here.

But, because of the Evil-Schemes of Eric Dingis & his associates,
I am now not able to do that.

Others also have also been "Economically Damaged" by
this same evil scheme from Eric & his Associates;
& i do hope that they will also ask this Court for
Adjudication of Economic-Resources Owed By Eric Dingis To Them.

But, here-under; I request, that, Eric be adjudicated as
Owing Me not-only My Actual Monetary-Loss, of "\$15,222.12";
but also, that Eric be adjudicated to be Owing "Punitive-Damages" to me;
up to some nicely rounded-number,
of approximately double, or perhaps triple, this amount.

I do hope this Court might be able to at least adjudicate what is right before God in this
case.
We can worry about possible "enforcement" at any more convenient time there-after.

Who knows; perhaps Eric might repent of his evil ways,
& perhaps he will voluntary under-take to make serious reasonable efforts at
compensating those of us who have been so seriously economically-damaged
by his recklessly-negligent &/or maliciously-evil actions.

There-under, perhaps, there may never even be any need
for this Court to contemplate any "enforcement" actions.

But, if Eric Refuses to Repent, & to do his best to Repair the Damage which he has done to my-self, my son, & others;
then, here-under, I request, that, this Court Publicly Adjudicate, that:
Eric Dingis is Not an "Honorable American-Patriot"; that, he is Not a "Qualified Elector in Any Legitimately Self-Governing & Common-Law Compliant Community;
& that, perhaps most importantly, Eric Dingis is Not a Member of the "Body of Christ",
Nor is he any Legitimate Member of Any Form of "God's Kingdom On This Earth".

I do thank all people inclined to assist in Bringing Justice in response to My Accusations here in this Court.

Perhaps I am Wrong, before God;
& perhaps a Due-Process & Common-Law Compliant Jury of 12 might here-under so Unanimously Adjudicate.

I will be willing to live with that,
if i might be making some sort of really whacked-out error in my judgement about all of this.

But i sincerely believe no 12-member jury of conscience-bound American Patriots would ever adjudicate in that manner.

I do hope that we all might soon be able to discover, if,
i might be the one making some sort un-reasonable &/or un-justified judgement here-in.

I do look forward to discovering the answers to these questions.

I do here-by solemnly Swear, before Al-Mighty God; that,
to the best of my knowledge, information, & belief, formed after my reasonable inquiry;
that, All Declarations presented here-in, are so presented in Good-Faith,
they are Well Grounded in the Situational-Facts Declared in this Complaint;
& they are Well Grounded, Justified, & Warranted by existing "Law";
& that, No Declarations in this Complaint are Intended for any Bad Purpose,
such as for that of Harassment.
