This Plaintiff, Roxanne Dye, brings this Complaint before this Court, by & through my Sworn True Allegation, of my sincere & well reasoned & thought-out belief, as I express here-in, that, the available Evidence, including sworn testimony from others besides my-self, will prove beyond all reasonable doubt, that, Eric Dingis not only Stole \$116,000.00 from our small community of patriots here in Tennessee, but also that he maliciously schemed & planned ahead in advance of that event, in order to "set us up", & to deceive & mis-lead us in-to trusting him with our money.

Here-under; <u>I believe the Evidence will prove</u>, that, over the larger history related to this case; <u>Eric has enchanted many people</u> in-to working to assist him in his malicious schemes; & that, while at least some of those other people were not purposefully malicious, <u>at least a few of those others were his knowing & malicious co-conspirators</u>.

In <u>my efforts to bring "Justice" to this case</u>, not only <u>for my-self & directly harmed others</u>, but <u>also for</u> the larger Organic Body-Politic Republic Communities of <u>the People of Tennessee & the USA</u>; here-under, <u>I am willing to personally submit this same "Sworn True Testimony"</u>, in open & <u>public video conferences</u>; & there-under, <u>to subject my-self to being cross-examined</u> for Truthfulness, not only by Eric, & his supporters; but also by all people acting in good-faith as Jurors in this case.

<u>I only want Justice here</u>, & this is very important to me, & to numerous other people.

To Begin, <u>I present My Formal & Truthful "Testimony</u>", here-in, <u>as follows</u>:

An important full-context element of all of this, is that, <u>a large number of people</u> <u>active in our Tennessee Patriot Group have also been active with</u> an organization which is known as "<u>The Republic for the USA</u>", & which maintains web-pages here:

https://republicfortheunitedstatesofamerica.org/ https://www.facebook.com/republicfortheunitedstatesofamerica In fact, the general over-arching structure of our Tennessee Patriot Group has frequently been considered by most members in our group, as just a smaller & more localized member of this same larger USA-National-Republic Group Organizing Community.

Further; the Named Defendant in this case, Eric Dingis, has been Actively Involved with this same USA-Republic Group; & he may have actually been maintaining formal membership there-in. Eric was at least Actively Involved with this USA-Republic Group During the Events Complained Of here-in.

Here-under; this Plaintiff, Roxanne Dye, first met Eric Dingis when he was still working with Angela Kitchen, near late-2021. They came to our Tennessee patriot group, & they were then volunteering to teach us procedures which they claimed to know, about how to gain back our fully complete & inherent sovereignty; & there-under, how to help us to get out from under the despotic social-engineering schemes of the private-corporation defacto-government.

Near this same late-2021 time, & under the heavy influence of this USA-Republic Group, numerous activists among us began discussing the subject of "Nesera/Gesera".

At that time, many good people in our Tennessee Patriot Group had embraced this entire Nesara rumor, theory, or proposition; &, for readers who are not familiar with this, it will be good to here to direct such readers to a Wikipedia article which is fairly accurate in its description of this entire development, here:

While this Wikipedia article is critical of the merit of this entire Nesara/Gesara patriot group effort; I only cite it here for its general larger-context informative value; & I do not here wish to imply, one way or the other, about my own views about the merit or credibility of that Nesara/Gesara development.

My only purpose here, is to affirm, that, <u>many good people in our Tennessee group</u>, <u>had then</u>, & still do, embrace this entire Nesara/Gesara proposition, theory, or development.

And, here-under, at those first late-2021 Tennessee Patriot meetings, Eric then clearly & specifically said, that, this Nesara development was not something which he considered to be credible, & that we should not put any of our trust or faith in it, & that we should not reasonably expect its predictions of future events to actually happen.

But, more currently, & after Eric & Angela had previously become involved with our Tennessee Patriot Church, & after Angela had already stopped working with Eric for a fairly long time; Eric & our Patriot-Group then Hosted a Big Group-Meeting, on the date of 2024-June-09, on a Sunday.

Eric was then also repeating to us all, some really positive rumors, that, some really big & positive changes in our American National political & economic policies were going to happen on this same date of June-09; & that, here-under, many American Patriots were referring to this same day as "Liberty Day". Eric was then generating a whole lot of really Positive Energies about all of this, & he generally affirmed that he was quite confident that all of these really big & positive changes were really going to happen soon.

Here-under, Eric was so confident & positive about all of this, that, he ordered, & paid for, a big Catered Group-Community Barbecued-Meal, to be brought in & delivered from a local restaurant, to us in our meeting.

It was at this same June-09 meeting, that Eric now declared, that, he Now Believed, that, this entire Nesera/Gesera Community Leadership Was both Trust-Worthy & Credible. Eric's Reasons for Why he had so drastically Changed His Beliefs about Nesara, & that He was Now Promoting Faith & Trust in the Leaders of that entire Nesara-Advocates Community; was because, he had then more currently been actually Meeting With Their Community-Leaders, & that he was then actually Continuing to Maintain Close, Direct, & Regular Communications With those same Nesara Community-Leaders.

In support of Eric's changed & now more-supportive position regarding the Nesara Community & their predictions about the future; Eric then had brought with him Four New People, whom none of us had previously met. Eric then clearly introduced these New People to us, as being a Part Of that "Nesera/Gesera" Organization.

The first of these Four New People was named as "<u>Mark Cecelia</u>", who claims to have ancestry-lineage which links his blood-line back to families involved with what has been known as "The Cabal" Families. Another note-worthy member of these Four People, is named as "<u>Lidia Madrid</u>", who has established a reputation for her-self as a "Spiritual Leader". The other two people involved in this Group of Four New People, are named as: "<u>Matt Schueter</u>", & "<u>Megan Martinez</u>".

At a Later Tennessee-Patriot-Group Meeting, (where-in these four Nesara People were Not Present, & approximately a week or two weeks later); Eric then informed us all, that, the Nesera/Gesera Group-Leadership was then Holding a Large Amount of Gold & Silver; & that, their Group-Leadership was then also Actively Looking For some Responsible & Legitimate Local Grass-Roots Self-Governing-Community, who were Sufficiently Organized & Professionally Responsible, in order that they could safely function as a Patriotic "Depository", with-in which They could then Put that Gold & Silver To Work For Good Patriotic Purposes.

Eric here-under further elaborated, by saying, that, the Nesara Group-Leaders were Ready, At That Time, to Actually Deliver To Us Their Large Amount of Gold and Silver, & to Actually Deposit It With Us.

How-ever; Eric also then informed us, that, the Nesera/Gesera Group-Leadership would first need to see some form of Evidence, that, Our Local Tennessee Patriot

Community was sufficiently Responsible & Professional, in order that they may have sufficient Confidence in us, to actually Deposit their large holding of Gold and Silver in-to our care & custody. But Eric also was then communicating to us, that, the Nesara Group Leadership was also then in a Big "Rush", to find some sort of a local community depository as this, & with-in which they could safely transfer & deposit their large holdings of Gold & Silver.

Here-under; Eric then began describing to us, his own elaborate "Plan", which he personally had developed; & where-under, Eric was now proposing, that, before all of these wonderful things could actually be completed, we Tennessee Patriots first Needed to Contribute Cash Money in-to some form of a "Cash Depository"; & this where-under, & more specifically, we could Find Some Small Local Tennessee Banking-Institution, & then

<u>just "Buy That Bank"</u>. As Eric described it, <u>this Bank could then be used by our Tennessee Group to function as a "Depository</u>"; where-in various forms of legitimate Economic Resources were Deposited, including Gold & Silver from Nesara, & also from our own local community members.

Eric continued on, by further discussing with us, how <u>all of these Newly-Created Economic-Resources could here-under be allocated</u> by our group <u>towards the Funding of our Tennessee Grass-roots Local Self-Governing Communities</u>, including <u>Local Community Banking & Local Community Organizing</u>.

But, Eric then also said, that, <u>another part of His Plan</u>, <u>was to: Set-Up an Internet-Based Web-Page "Server</u>", in order that, once we purchased our Small Bank, & had our Deposits properly in place there-in; then, <u>our Tennessee Patriots could Quickly & Efficiently Transfer Their Own Credits & Debits Back & Forth; & to there-by Create Our Own Very Efficient "Alternative Banking-System".</u>

At one of our group meetings, Eric actually showed us this "Server" hard-ware box which he had created.

Never, at that time, nor at any other time, <u>did Eric Ever Mention that he was going to be Charging Us a Fee for his Personal Services in helping us to get all of this project up & running properly</u>. We all thought that Eric was "Working With Us"; & none of us ever had any clear impression, in contrast there-with, that, Eric was "Working For Us", as some sort of a Private Consultant or Contractor, as he now seems to be alleging.

Eric here-under further informed us all, that, this then really was a serious American & Tennessee Patriotic Need, & that <u>our Tennessee Group should be making moves to accomplish this "As Soon As Possible"</u>.

The <u>main Reason Why we supposedly Needed to "Act Quickly</u>", was so that we all might promptly begin all working together with enough serious economic-resources to <u>actually begin thwarting the oppressive tyranny, despotism</u>, & bloody lawless prosecutions & war-mongerings, that corrupted officials & agents of our oppressive de-facto local state & national governments were routinely perpetrating against our common & innocent people. People's lives are being destroyed every day by those evil enterprises; & every member of our Tennessee Patriot Group at least professed to be seriously concerned for bringing a stop to those evils, as quickly as possible.

But another Reason for this Big Rush, as clearly Implied by Eric & his supporters; was so that we could <u>Assist the Nesara Leaders with Their Need</u> to Deposit Their Large Amount of Gold & Silver With Some Worthy Patriotic Organization. <u>That would Build Trust between our Tennessee Group & the Nesara Leadership</u>, all of which <u>could have very powerful long-term beneficial effects</u>.

A third reason, that Eric was seemingly implying; was that, <u>This Was a "Grand Opportunity" for our Tennessee Patriot-Group</u>, from both the Nesara Group-Leadership, & from Eric; both of whom Eric & his supporters had stated were then working closely together.

Eric was here-under at least implying, that, <u>he was "Doing Us All some Big & Special Favors"</u>, <u>by Sharing this supposedly "Grand Opportunity</u>" With Only Us Tennessee Patriots; <u>& that We Really Needed to Rush to Raise Sufficient Funds Promptly</u> to Capitalize On This Grand Opportunity, before it might possibly disappear.

This then was the generally Rushed Spirit & Mind-set of Eric's discussions with our Tennessee Patriot-Group Discussions. When we asked detailed questions; we got shuffled off to corners of ambiguity & confusion; all where-under the implication was clear, that we needed to be more appreciative of the grand opportunity which Eric was here presenting to us.

Later on, when our group was searching for a Banking-Institution to buy, this was the time-period with-in which we discovered, that, Eric had spent \$116,000.00 for his own personal use, from the money which we were then raising-funds for purchasing the Bank.

But; <u>a bit of larger-context</u> here, is that, <u>two days after our June-09 Catered</u>
<u>Barbecue Meeting</u>, on Tuesday, <u>June-11</u>; & well before Eric began presenting his grand
Plan to us all; <u>Eric then began advocating</u>, <u>that</u>, <u>our Tennessee Patriot Community should</u>
<u>move promptly to Serve Patriotic Documents on our De-Facto Tennessee-State-Governor</u>.

Eric was then suggesting, those sorts of Documents should be composed in manners which Informed our acting State Governor of the Constitutional Duties which He Had to more seriously begin actually Serving the Needs of We the People of Tennessee.

In response to Eric's bold proclamations here, Carrie Dugan stood up & said that we should all move forward just as Eric had suggested, & actually prepare & Serve Documents like this on our De-Facto Tennessee-State Governor.

Carrie then also suggested, that, Eric should lead us all when we so Served these Documents on the Governor.

We then all agreed to proceed in this precise manner; & we then went to the place where we usually meet, & we stayed there until 10:30-pm or so, working on properly composing these documents. We then spent hours rough drafting this letter to the Governor.

The Four New Nesara-People with Eric, were supportively accompanying us in all of this; & I believe we can produce actual group-pictures of us all together.

Eric & his Four New Nesara-People went with us to Nashville; when <u>We Then</u> <u>actually Served these Documents on our De-Facto State Governor</u>.

Eric had frequently used words which prompted us to Trust him more than we would normally do for other people. Particularly, <u>Eric frequently said</u>, that, <u>our Tennessee Patriots-Group was "Leading The Way" For Establishing Legitimate Constitutional-Republic Governments in all of the Other States</u> in our nation.

But, in response to this effort at Serving Documents on our Tennessee Governor; <u>a</u> note-worthy response came from a large number of members of the USA-Republic Group, all as it was then being led by James Geiger, & this all as I have previously introduced them & their two main web-pages on the first-page of this Complaint Document.

A large number of these Republic Group Members responded to us, by informing us, of their belief, that, Eric's entire effort here to direct us to Serve Documents on our Tennessee-State De-Facto Governor, was a "Counter-Productive Strategy"; & that, Their Group Leaders were Not at all then Prepared to do any-thing like that; & that, They Believed, that, We should Never Have Done It.

And because Eric was then so intimately Involved with this USA-Republic Group; here-under, when these Other State-Level USA-Republic Leaders later learned, that, Eric

had Taken Money From our Community Account, & Used It For His Personal Benefit, & this All With-out Authorization from our Tennessee Patriots-Group; well, this series-of-events really pushed many of these more local Republic Community Leaders To The Limit.

More specifically; They did Not Want to be Associated with Any Person whom they believed was so blatantly Behaving in this grossly Irresponsible & Unethical manner; &, here-under, a Large Number of Republic Members who were then Holding Offices of Governors & Senators in other States; "Stepped Down" from the Republic-Offices which they were then holding.

Here-under; <u>as the Direct Result of Eric's Actions</u>; Eric has not only Harmed our Tennessee Republic Patriot Group; but <u>he has Also Harmed our Whole USA-Republic Group-Community Organizing effort</u>.

When we later learned of such massive nation-wide dis-approval of our following Eric's plan here, & more especially, after our "Funding-Loss Developments"; here-under, we all felt like this effort at "Serving Documents on the State Governor", has most likely just been an early component in Eric's larger Plan, where-under, he had just likely been "Grooming Us" early on like that, building up our Trust in him; all in order for him to later take more significant advantage of us, under his second Plan to do the Funds-Raising efforts which were designed to establish the Depository & Alternative-Banking System.

Directly related to this point about Serving Documents on our Tennessee-State defacto Governor; is that, when Eric first brought the Four Nesara-People with him to our Tennessee Patriot Meetings; the topic which Eric was then leading us towards discussing, was largely focused on Serving these Documents on our Tennessee State Governor.

In pursuit there-of, those Four Nesara-People did courageously accompany us in our trip to Nashville there. But, we later we learned, that, their motives may have merely been to see whether or not we were really-serious real-deal Patriots.

Part of the larger context evidence here, is that, when Eric next came back & met again with us to talk about establishing our alternative-banking depository; those same Four Nesara-People were no longer then in their previous diligent & supportive accompaniment with Eric.

A different larger-context issue here, is that, our Tennessee Patriot Group only meet Eric and Angie Kitchen long before Carrie Wagner became a part of our group; &, Carrie's sister, Lynn Wagner, never did formally join with us as a group-member. Also; Carrie Wagner owns a nicely comfortable house, which she regularly shares with her sister Lynn Wagner. There-in, & for at least one short period of time when Eric was in town presenting this elaborate plan to all of us; Eric was staying at this house where both Carrie & Lynn were living.

Here-under; & in his more recent communications about this case; <u>Eric seems to be presenting argument</u>, to the effect, that, at least <u>some of the problem here</u>, was because of <u>Poor Communications dynamics between Carrie and Lynn</u>. But, in light of the fact, that, Eric was staying in the same house as both of these women; Eric should have been fully aware of the communications dynamics between them both, if indeed there even was any problems between them; &, if there was, then, Eric should have been responsible enough to make reasonable compensations for any such problems, & to there-by insure that all of us were fully informed of these important details about this project.

Further; <u>Eric seems to have more recently presented argument</u>, effectively, that, <u>Carrie &/or Lynn had assumed some sort of a natural & organic position as our "Group Leaders"</u>; & that, here-under, <u>it was the Duty of our Entire Larger Group Community to Maintain Efficient Communications among our-selves</u>.

Here-under; <u>Eric seems to be further alleging, that, He had Fully Informed Carrie &/or Lynn Wagner of His Intent to Charge Us all Fees for His Private Consulting Work, on helping us to get this entire project up & running properly; & that, there-under, it was "Not <u>His Problem</u>", that, as he alleges, <u>Carrie &/or Lynn had Not Informed the Rest Of Us</u>, about where our money was actually being allocated.</u>

Here-under; <u>Eric seems to be alleging</u>, that, he, <u>Eric</u>, <u>Only Had Duties to</u> Communicate His Personal Profits from this elaborate scheme to Carrie &/or Lynn.

Here-under, My Personal Sworn-True Testimony, is, that, <u>Our Group Members</u>
<u>Never looked to Carrie or Lynn to Lead us</u>, nor to function as intermediaries to Eric for us.

<u>We Only Looked to Eric for Fully Informing Us All of the Precise Details of this entire Scheme</u>, Including the Details of Precisely What Our Money was going to be Spent on. Here-under; <u>We were Never Told</u>, that, <u>Our Money was Going To Be Used To Pay Him</u>, <u>Eric</u>, For His Efforts At Setting-Up That Alternative-Banking Internet-Server.

Especially in light of the fact, that, <u>We Met Eric & Angie Before We Met Carrie or Lynn Wagner</u>; here-under, <u>We Had No Logical Reason or Motive to Look To Carrie or Lynn to keep us informed</u>, of the numerous critically-important details of this project.

This especially included the important detail, that, as Eric is now claiming; Rather Than "Working With Us", Eric was actually "Working For Us", as our Private Contracting Consultant, for which he was going to be getting Very Handsomely Paid out of our hard-earned money.

But; Eric was then In a Very Big & Excited "Rush", to Get All of This Money Collected as Quickly As Possible for his elaborate project; & he had Lots of well-thoughtout & fast-talking Words directed to us all. At this time, & at all times after this; Eric has Never Informed Us, that, He was Going To "Charge Us Money", in exchange for, the Efforts which He Was then Contributing to get this entire project up & running properly.

Also; Eric now seems to be claiming, that, the Decision to Not Accept Eric's "Server" Hardware-Box, when he attempted to actually deliver it, was Not Made by Only "Carrie Wagner"; but rather, that decision was a Group-Decision. Carrie had previously Sent Out Emails to Every Investor on this precise issue; & there-in she asked us all, individually, to tell her if we wanted to Accept Delivery of Eric's "Server" Box.

We All Voted "No".

None of us knew how it worked, or what it might actually be worth, or who might actually be inclined to purchase it from us. Since Eric had been posturing to us as being the big expert on such Computer Hardware as this; then, here-under, we all felt Justified in our refusal, because, if that Server hard-ware box was actually as valuable as Eric had been saying that it was; then, Eric should know the sort of people who would be inclined to purchase it; & there-under, Eric should just be able to offer it for sale to those other people

for a 10% or so discount from its normal market price.

The fact that Eric has not already taken such an initiative as this to sell that Server box, seems to us to indicate, that, that hard-ware it is not nearly so valuable as Eric has been claiming.

Further; the "Bank" which Eric was directing our group to focus on attempting to purchase, was clearly going to cost a lot more money than what our current investors had then put together. Here-under, Eric was verbally Pressuring Us all to Raise More Money in order for us to be able to complete this entire project properly. That was the Main Point of Why we were Contributing Money, so that, our entire group effort, with Eric seemingly "Working With Us", would collectively Have Enough Money to Purchase this small Bank, & to properly set up his fancy Internet Server to effectively use that Bank.

Here-under, <u>it is Absolutely a False & Malicious Lie</u>, for <u>Eric to be alleging</u>, that, <u>Any Of Us Agreed to Authorize him</u>, Eric, <u>to Pull Out over \$100,000.00 For His Own</u> Personal Use!

That Brand-New \$85,000.00 Truck that Eric Purchased Directly From the Car-Dealer's Show-Room Floor, & which Eric said he needed in order for him to be able to effectively complete his supposed duties to continue on with his travels to other states, was of absolutely No Good Use for our Tennessee Group.

When some of the people that had been working with Eric saw the New Vehicle which Eric had purchased with the money Eric got from our Tennessee Group; they asked Eric, in essence: 'who gave you the authority to purchase the vehicle'.

These people have affirmed, that, Eric answered this question from them, by saying, that, the 'Executive Group of the Trust' had given him that authority.

But <u>at that point our Tennessee Group Money had not then even been put in-to any "Trust"</u>. <u>It had then only been put in a Bank-Account</u> that <u>Eric had been sharing</u> with Bob Sisson & Gaston Cornu Labat. Using that Shared Bank-Account was suppose to be only as an "Interim Measure", un-till after a proper Trust-Fund had been fully & properly set-up.

As this entire project was progressing; I recall I specifically asked Eric, about, How Much Money was Needed, what it was being allocated for, specifically, & other related details. But <u>Eric Evaded Answering my Questions</u>, by then <u>Directing Me to seek answers to my questions from his associate "Lynn Wagner"</u>.

At this point, I did not know Lynn Wagner; but i did know her sister, "Carrie Wagner". When I contacted Lynn, <u>Lynn then said</u>, confidently, that, <u>I should expect to make an 8% interest return on my investment in their project</u>.

At this point, <u>Eric began Restricting all of his Communications</u>; & <u>No Discussion</u> was Reasonably Available about the Details & Safe-Guards that were supposedly making this project as safe as Eric was confidently posturing like it was. <u>Eric was then In a great Big Hyper-Energized Rush to Focus Exclusively On "Getting Money Quickly"</u> for this entire project.

Nothing was then offered to be formalized in-to any contract, or other form of written-agreement.

<u>Eric continuously Acted & Spoke in manners which Led Us all To Believe</u>, that, <u>Eric Was "Working With Us"</u>; <u>as opposed to</u> these entrenched & current arguments from him, to the effect, that, he was "<u>Working For Us</u>"!

Again; <u>Eric Never Ever Said he was Charging a "Fee</u>"! And Eric Still has Never Shown me Any Written Documents, of any form, where-in any such Private Consulting "Fees" were ever mentioned, as he now seems to be saying that he gave to Carrie Wagner!

More recently, <u>Eric seems to be continuing on with his claims</u> similarly, that, <u>he was</u> fully up-front with us, about him simply being our hired "Consultant".

<u>I Solemnly Swear</u>, <u>that wording is "Not True"</u>! Eric has purposefully & maliciously Scammed Us All.

And here-under; I do hope, through this Complaint Document, that we might be able to get some form of actual "Justice", through the hearings & investigations which Charles Stewart is here-in helping me to bring forward to our larger community of Tennessee & American Patriots.

Also; during other group meetings, we elected Carrie Dugan as our State "Governor"; under the organizing efforts being led by the USA-Republic group which was then & remains headed by James Geiger. When we all became alarmed about how our money was being allocated, Carrie Dugan then wisely contacted the other state governors of this Republic group. They all said that no states we ready to buy any sort of a "Depository" as that which Eric had been proposing to us; & that, their entire group leadership under James Geiger was not nearly sufficiently advanced then to actually do any-thing so bold as that, & that it was all like "putting the cart before the horse".

I confess, in my hind-sight here, i can now much more clearly see & comprehend, that, <u>I then had Become "Emotionally Caught-Up" in this this Very Emotionally-Energized</u> & Seemingly Righteous, (but Poorly-Thought-Out), Larger "<u>Mass-Group-Effort</u>".

I can now much more clearly see & comprehend, that, <a href="the" then, the "Emphatic Focus", then, by Eric & his associates; for our Patriotic-Group to "Act Quickly", to "Collect This Money", in our Group Efforts at Completing this Seemingly Very Important, Very Needed, & Very Safe Patriotic-Project; was actually Not a "Safe Project" at all.

Rather, (in its most favorable light); it was a Poorly-Thought-Out & "Recklessly-Negligent Project"; & that, the much more likely explanation, is, (& which i believe the evidence will prove), is that Eric & at least some of his Associates were Maliciously Scheming, From The Start, to Deceive & Plunder the Limited Economic-Resources of Ween Maliciously Honest & Hard-Working Grass-Roots Tennessee Republic Patriots.

I am among this same group of "Limited-Economic-Resources Working-Class Patriots"; & <u>I Was "Maliciously De-Frauded"</u> by Eric Dingis & his associates, in-to Contributing & <u>Loosing My Own \$15,222.12</u> in this Maliciously-Engineered "Scheme of <u>Deception & Theft</u>".

I think about this evil situation every day; & I have cried many tears over it; & it feels constantly to me like i am carrying a very heavy load on my back! I Can't hardly sleep at all, because I am Stressed about this evil All of The Time!

A serious part of my stress, is coming from the fact, that, my son has injured himself, & is out of work for at least 3 months. Normally, i would be in a position to help him with his difficulties here. But, because of the Evil-Schemes of Eric Dingis & his associates, I am now not able to do that.

Others also have also been "Economically Damaged" by this same evil scheme from Eric & his Associates; & i do hope that they also will ask this Court for Adjudication of Economic-Resources Owed By Eric Dingis To Them.

But, here-under; <u>I request</u>, that, <u>Eric be adjudicated as Owing Me</u> not-only <u>My Actual Monetary-Loss</u>, of "\$15,222.12"; <u>but also</u>, that Eric be adjudicated to be Owing "<u>Punitive-Damages</u>" to me; up to some nicely rounded-number, <u>of approximately double</u>, or perhaps triple, this amount.

I do hope this Court might be able to at least adjudicate what is right before God in this case. We can worry about possible "enforcement" at any more convenient time thereafter. Who knows; perhaps Eric might repent of his evil ways, & perhaps he will voluntary under-take to make serious reasonable efforts at compensating those of us who have been so seriously economically-damaged by his recklessly-negligent &/or maliciously-evil actions. There-under, perhaps, there may never even be any need for this Court to contemplate any "enforcement" actions.

But, if Eric Refuses to Repent, & to do his best to Repair the Damage which he has done to my-self, my son, & others; then, here-under, <u>I request</u>, that, <u>this Court Publicly Adjudicate</u>, that: <u>Eric Dingis is Not an "Honorable American-Patriot</u>"; that, <u>he is Not a "Qualified Elector"</u> in Any Legitimately Self-Governing & Common-Law Compliant Community; & that, perhaps most importantly, <u>Eric Dingis is Not a Member of the "Body of Christ"</u>, <u>Nor is he any Legitimate Member of Any Form of "God's Kingdom On This Earth"</u>.

I do thank all people inclined to assist in Bringing Justice in response to My Accusations here in this Court.

I remain willing to consider the possibility, that, perhaps, my accusations against Eric here-in are not fully "Justified", before God; & that, perhaps, a Common-Law Compliant Jury of 12, properly following constitutional due-process, might here-under possibly & unanimously adjudicate exactly that.

If that actually happens; then, I am prepared to live with any such developments as that; & where-under I can be shown that some sort of some-what reasonable argument can reasonably be made, that, I have just been making some sort of really whacked-out errors in my own personal judgement about all of this.

But, i sincerely believe, after fully reviewing all of the evidence, including relevant testimony; that, no 12-member jury of conscience-bound American Patriots would ever adjudicate like that in that manner.

I do hope that we all might soon be able to discover, if, i might be the one making some sort un-reasonable &/or un-justified judgement here-in.

I do look forward to discovering the answers to these questions.
