David Schied asks how we might Get the Constables Recognized by the Sheriffs.  
Charles responds by explaining his strategy for Sending to the Sheriff & others, the documents entitled similarly as “Constructive Notice of Treason”, & “Notice of Formation of Responsibly Self-Governing Communities”.

We continue on to discuss how these documents frequently will be “Ignored”, but that creates a “Default” on the part of the Sheriff &/or other Public-Servant; where-under our Town Constables can then begin appearing in Court Sessions &/or County Commissioners/Supervisors Governing-Body Meetings; & there-in exerting legitimate pressure to move governing policies in the direction of keeping the peace instead of their routine policy of violating/breaching the peace.

By & through presentment of these documents to the Sheriff & other local officials, & if & when those officials entrench in their lawless efforts at Monopolizing the “Peace-Keeping” Process in the County; then, these documents have Laid a Lawful Foundation for Prosecuting a Complaint against the Sheriff &/or others, so-as-to Remove Them from the Public Offices which they hold.

Here-under, the Sheriff should be highly motivated to recognize our locally volunteered “Town Constables”; & if he still refuses, then we will need to be prepared to seek the more powerful lawful remedy of Invoking Judicial Process to have him Forcibly & Lawfully Removed from the Public-Office which he holds.
