<u>Specific 'Additional Incentives</u>', assigned as Rewards, <u>for Investing In & Circulating the Alternative Currency of</u> the Bible/Torah-Law & Common-Law Compliant Religious Jural-Society Community which is known under such names as <u>the "Natural Law Church</u>"; the "<u>Constitutional Government of the USA</u>"; & also as the "<u>Supreme Court of Law for the USA</u>".

1: <u>The Highest-Level of these 'Additional Incentives</u>' <u>will Only Be Available during the First</u> <u>Threshold Time-Period</u>, where-under this Currency is being First Introduced, & where-under it has Not Yet Gained Any Significant Popular Usage.

We expect this time-period to last no longer than three months; but it may last as long as a year, or it may be as short as a single month. This Cut-Off Date is expected to be more precisely Determined by the Consensus of the Twelve Supreme Judicial-Officers of Our Supreme Court of Law, as we are openly & publicly discussing this issue.

<u>During this First Threshold Time-Period</u>, <u>this Highest-Level</u> of Additional Incentives <u>will be</u> <u>Pegged at "Ten Per-Cent</u>", <u>aka: "10%</u>".

This means, in good-faith, & in reasonable Exchange for 'Valuable Consideration', such as Goods or Services Delivered; <u>Each Natural Person who Receives Any Amount of Our Alternative</u> <u>Currency</u>, <u>will Immediately have Added to His Account an Additional 10%</u> of the Amount <u>of the</u> <u>Currency which he has so received</u>.

2: <u>The Middle Level of these 'Additional Incentives</u>' <u>will Be Available during the Second</u> <u>Threshold Time-Period</u>, where-under this Currency has Gained Some Significant Popular Recognition & Usage, but it is not yet competing seriously with any of the numerous other Alternative & Crypto Currencys which are modernly, popularly, & fashionably circulating.

<u>We expect this Second Threshold Time-Period to continue in existence</u>; for close to One Year. We expect this decision to be Determined more precisely by the Consensus of the Twelve Supreme Judicial-Officers of Our Supreme Court of Law, as we are openly & publicly discussing this issue.

<u>During this Second Threshold Time-Period</u>, <u>this Middle-Level</u> of Additional Incentives <u>will be</u> <u>Pegged at "Seven Per-Cent</u>", <u>aka: "7%</u>".

This means, similarly as under our above-described First Threshold Time-Period; that, <u>Each</u> <u>Natural Person who Receives Any Amount of Our Alternative Currency</u>, <u>that Person will Immediately</u> <u>have Added to His Account an Additional 7%</u> of the Currency which he has so received.

3: <u>The Lowest Level of these 'Additional Incentives' will Be Available during the Third Threshold</u> <u>Time-Period</u>, where-under this Currency has Gained Significant Popular Recognition & Usage, & it is beginning to compete seriously with the numerous other Alternative & Crypto Currencys.

<u>We expect this Third Threshold Time-Period to continue in existence</u>; for close to Two Years. We expect this decision to be Determined more precisely by the Consensus of the Twelve Supreme Judicial-Officers of Our Supreme Court of Law, as we are openly & publicly discussing this issue.

<u>During this Third Threshold Time-Period</u>, <u>this Middle-Level</u> of Additional Incentives <u>will be</u> <u>Pegged at "Three Per-Cent</u>", <u>aka: "3%</u>".

This means, similarly as under our above-described First & Second Threshold Time-Periods; that, <u>Each Natural Person who Receives Any Amount of Our Alternative Currency</u>, <u>that Person will</u> <u>Immediately have Added to His Account an Additional 3%</u> of the Currency which he has so received.
