The Actual Source of this Commercial-Credit, is the "Full Faith & Credit" of the People of Sevier County. These words are True; because, "All Power is Inherent in the People", & also because, under both "Biblical Torah-Law", & "Constitutional Common-Law"; Sevier County Is a "Responsibly Self-Governing Community".

Organizers of this effort Will Not Issue More of this Currency, than that which we are Reasonably Capable of Producing Goods &/or Services in support of. We Maintain Open & Public Accounting of Our Total Out-standing & Circulating Commercial-Credit, in the web-pages linked here-in below.
