(A “Lyceum” is a high school.)

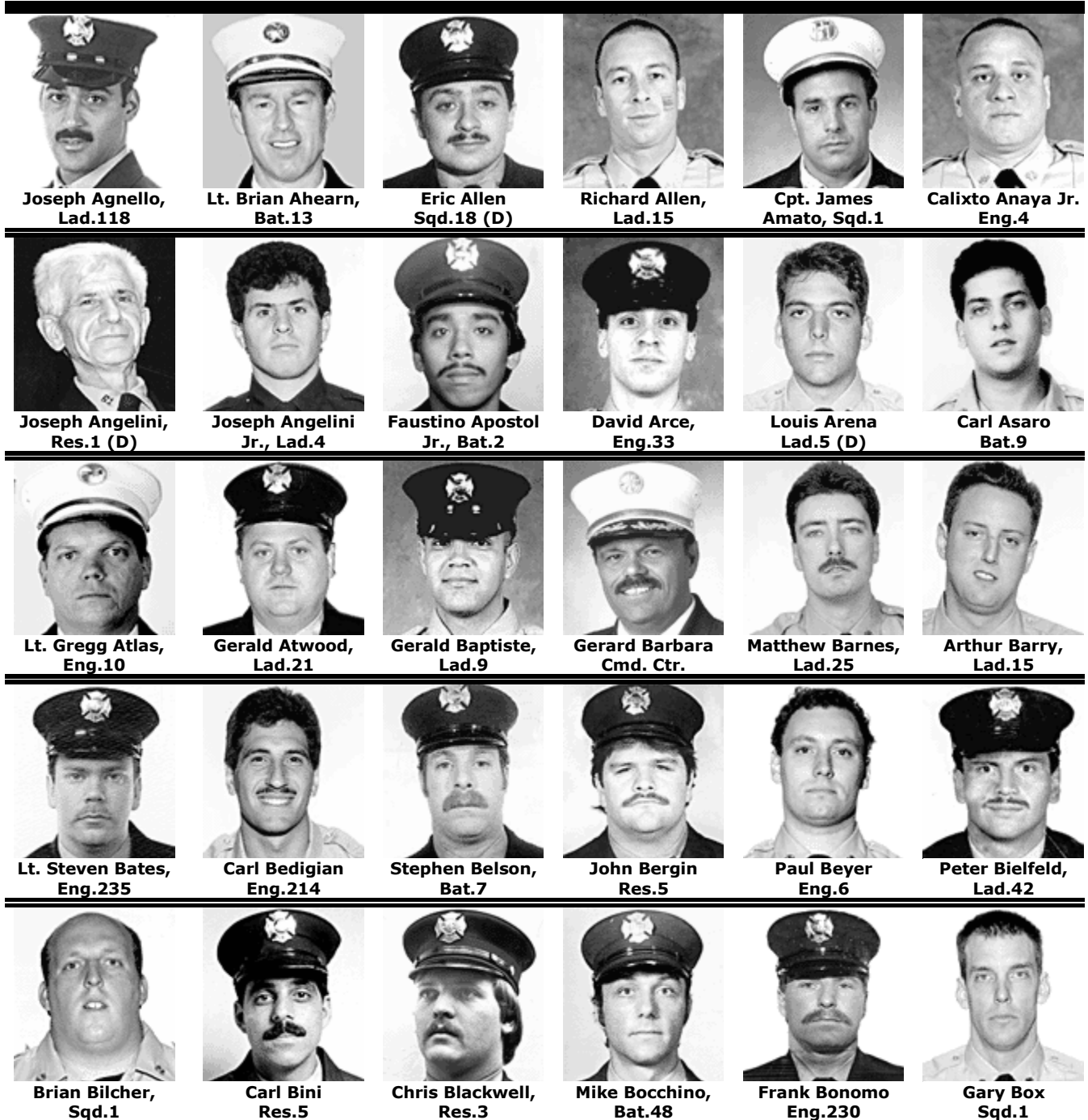

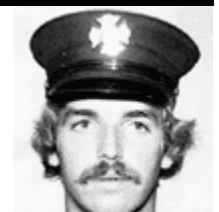

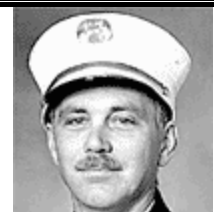

No Sprinklers? The Twin Towers Were Twin... Chimneys

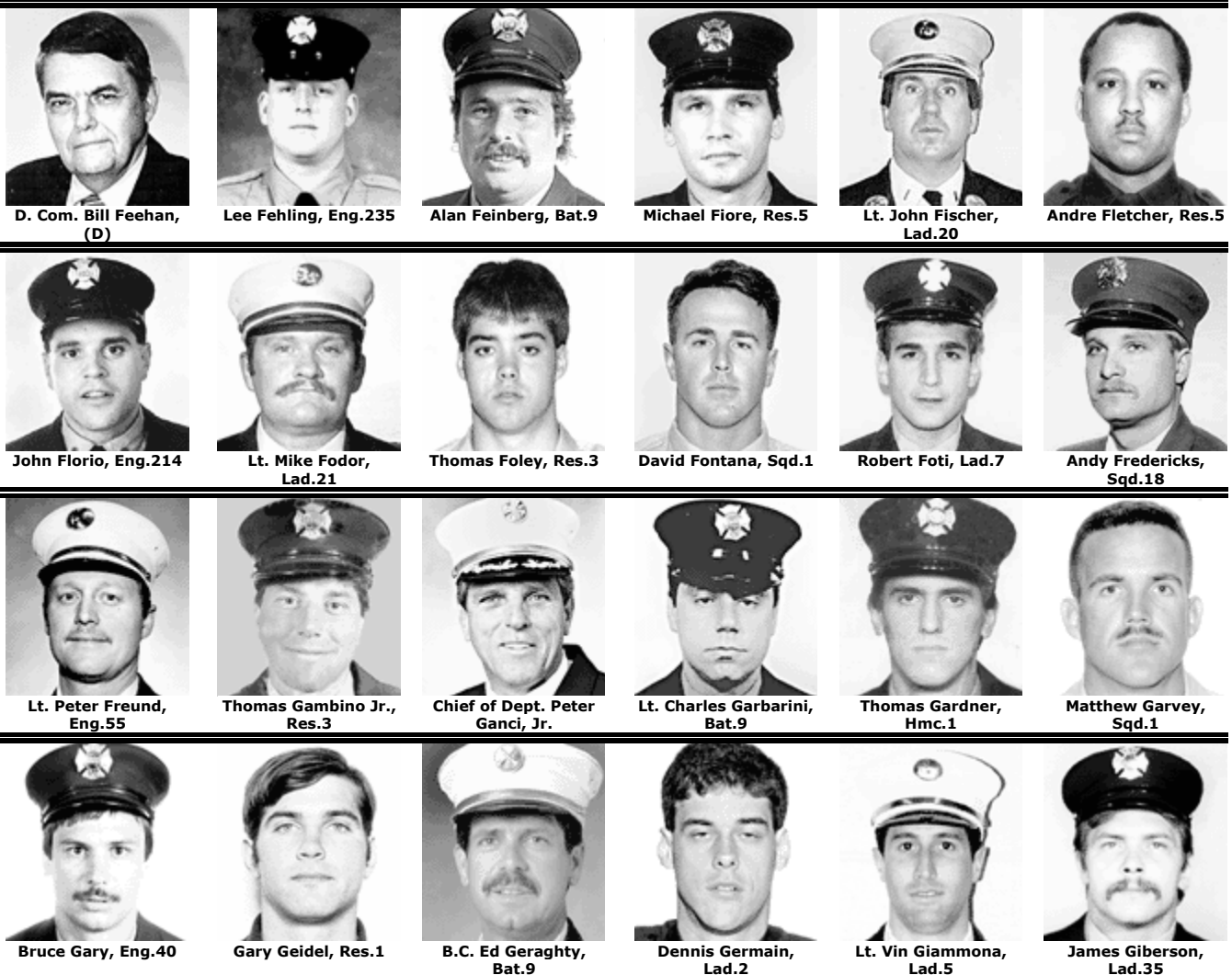
With all of the controversy surrounding the *demolition* of the NY/NJ WTC towers Vs the "Official" Report sweeping the truth under the rug, why hasn't anyone brought proper attention to the draconian NY/NJ Port Authority FIRE CODE? **It was made tougher every two years** to compete with Boston and LA.

The Rest Of The Story

I had reason to interface with PA Chief Architect Gordon Lorimer for the years before even the stores that sold the old Vacuum Tubes were demolished to pave way for construction of the WTC. Mr. Lorimer was the PA *go-to guy* over on Rector Street for installation of anything into the towers. Everything that went into the buildings had to meet stringent FIRE CODES. We contractors were prepped years in advance. NOTHING – could be brought into the buildings before passing the most strenuous fire testing standards.

Draperies, ceiling tiles, carpeting, polyurethane, foam cushioning, fabrics. both for seating as well as panel systems, plastics used for anything, desk top laminates and chair casters included. Even at the beginning, wood surfaced tops and the chip core used to make laminate tops had to be soaked in formaldehyde. This petrified the wood and essentially turned it into stone. Finally after 3 years this particular requirement was relieved inasmuch it took too many saw blades just to cut one work surface. All materials had to **SELF-EXTINGUISH both smoke and flames in seconds** once the test fire source was removed.

The stringent FIRE CODE was **THE** reason for never installing sprinklers. It was decided that the FDNY would extinguish any fire from a colliding airliner better than sprinklers. In no event however, airplane collision included, would any fire bring the majestic Towers down. Not without help that is. **Smoke** from yet unidentified sources **continued to waft over the Hudson until JAN 2002**. *Where'd it come from?*

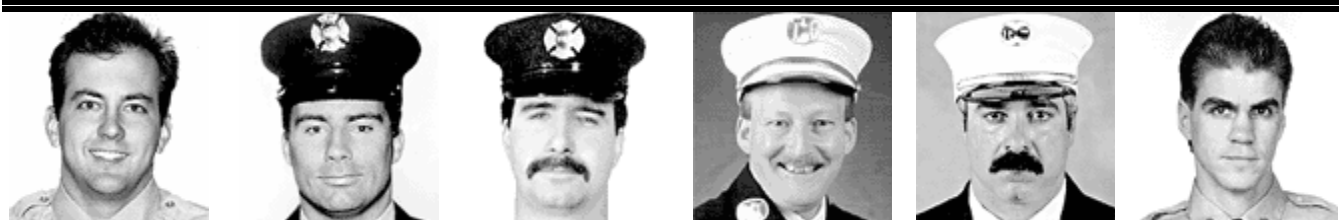

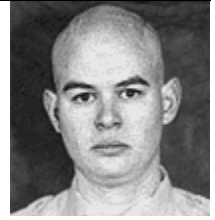

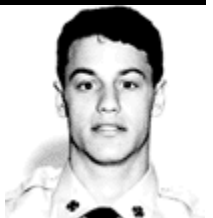

NY Firefighter 343



Firefighter Raymond York, Engine 285 (D) Laid to Rest on September 15, 2001

Raymond R. York spent nearly two decades fighting blazes and loving the New York Fire Department when a shoulder injury 18 months ago forced him into light duty. But he found a second calling, teaching children about fire safety at the Fire Zone at Rockefeller Center. There, he was "Fireman Ray" to the youngsters whom he captivated.

But on Tuesday, he learned of the World Trade Center attack from a television crew that was doing a story on the Fire Zone, jumped onto a nearby fire truck and headed downtown. After traffic held him up, he hitched a ride on an ambulance and reached the Fire Department's command post at the trade center.

"We're so proud and we just want everybody to know what a great guy Ray was," his wife, Joan, said. "Everybody's saying, 'He's a hero, he's a hero.' He always was my hero. Now the world knows he's a hero."

*She described her husband as a man in love with life, a man who insisted on flying the flag. "He was a Little League coach, he was a scout leader — when it came to his kids, he was there for everything," she said. That included building an ice skating rink in the backyard of their Valley Stream, N.Y., home when his son, **one of four children**, wanted to learn how to skate.*

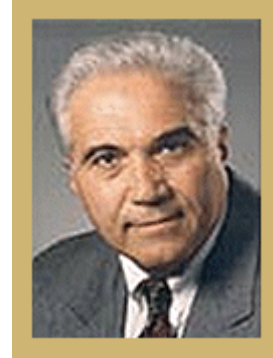

This Medal of Honor was given to the families of the 37 Port Authority Police Department Heroes MURDERED on 9/11

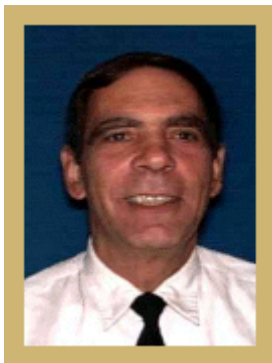

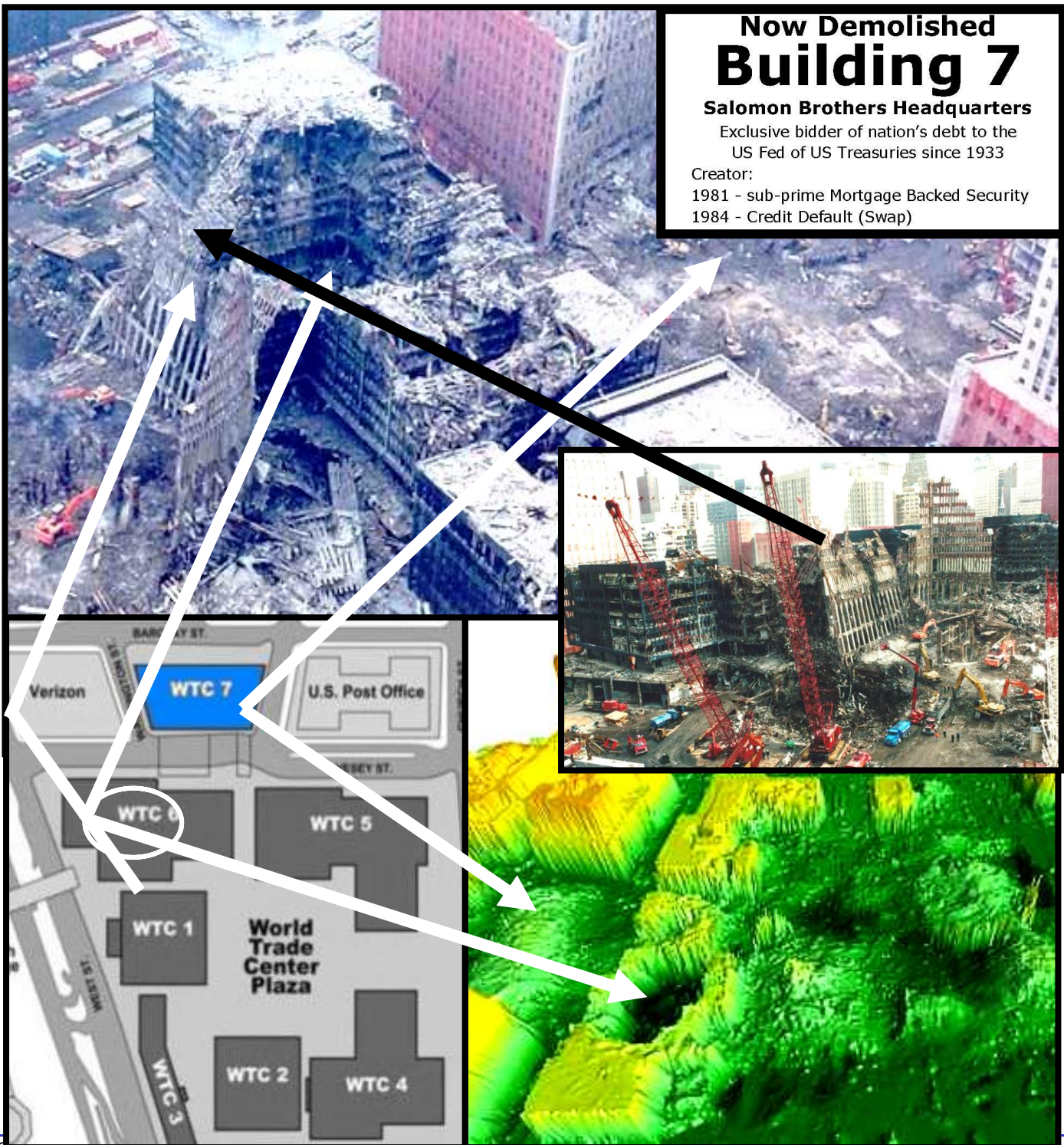

(Look at the relative height of Building 7 against the Verizon building to its right in the above pictures.) Abstract: We have discovered distinctive red/gray chips in all the samples we have studied of the dust produced by the destruction of the World Trade Center. Examination of four of these samples, collected from separate sites, is reported in this paper. These red/gray chips show marked similarities in all four samples. One sample was collected by a Manhattan resident about ten minutes after the collapse of the second WTC Tower, two the next day, and a fourth about a week later. The properties of these chips were analyzed using optical microscopy, scanning electron microscopy (SEM), X-ray energy dispersive spectroscopy (XEDS), and differential scanning calorimetry (DSC). The red material contains grains approximately 100 nm across which are largely iron oxide, while aluminum is contained in tiny plate-like structures. Separation of components using methyl ethyl ketone demonstrated that elemental aluminum is present. The iron oxide and aluminum are intimately mixed in the red material. When ignited in a DSC device the chips exhibit large but narrow exotherms occurring at approximately 430 °C, far below the normal ignition temperature for conventional thermite. Numerous iron-rich spheres are clearly observed in the residue following the ignition of these peculiar red/gray chips. **The red portion of these chips is found to be an unreacted thermitic material AND HIGHLY ENERGETIC.**

Keywords: Scanning electron microscopy, X-ray energy dispersive spectroscopy, Differential scanning calorimetry, DSC analysis, World Trade Center, WTC dust, 9/11, Iron-rich microspheres, Thermite, Super-thermite, Energetic nanocomposites, Nano-thermite.

Evaporate the Evidence?

Before beginning, here are the principal data (questions) that must be explained to allow for a “CONTROLLED” demolition. The lack of answers can lead to only one conclusion: evidence normally contained within the debris of a conventionally demolished effort was evaporated by a Directed Energy Weapon (DEW) of unknown pedigree: Israel/Russia? (All Israelis are Russians.)

1. The Twin Towers were destroyed faster than physics can explain (at free fall speed "collapse").
2. They underwent mid-air **pulverization** and were turned to **dust** before they hit the ground. (There is FACTUAL seismic proof.)
3. The order and method of destruction of each tower minimized damage to the protective *bathtub* (five stories underground below Hudson River water level) and adjacent buildings. 4. The protective *bathtub* (five stories underground below Hudson River water level) was not significantly damaged by the destruction of the Twin Towers.
 - a. The **WTC Mall** survived well, with ceiling tiles hanging and 1st responders all standing up with “miner’s hate”. Factually provable.
 - b. The rail lines, the tunnels and most of the rail cars had only light damage.
5. The seismic impact from the “collapse” was minimal, far too small based on comparison with the Washington Kingdome *controlled* demolition.
6. The Twin Towers were destroyed from the top down, not bottom up.
7. The *demolition* of WTC7 was whisper quiet and the seismic signal was no greater than background noise.
8. The upper 80 percent, approximately, of each tower was turned into fine dust and did not crash to the earth.
9. The upper 90 percent, approximately, of WTC7 was turned into fine dust and did not crash to the earth.
10. Only ONE file cabinet of more than an estimated 100,000 survived.
11. Office paper was densely spread throughout lower Manhattan, inexplicably unburned, often alongside the burning metallic parts of cars.
12. Vertical round holes appeared to be *cut* into buildings 4, 5 and 6, plus a cylindrical *arc* into Bankers Trust and into Liberty street in front of Bankers Trust.
13. All planes except top secret missions were ordered down until 10:31 a.m. (when only military flights resumed), after both towers were destroyed, and only two minutes after WTC 1 had been destroyed.
14. Approximately 1,400 motor vehicles were toasted in strange ways (metal mass – engines disappeared – were “eaten”) during the destruction of the Twin Towers. Some were almost a mile from the WTC site.
15. Without damaging neighboring buildings, in fact all seriously damaged or destroyed buildings had a WTC prefix, and no others.
16. The north wing of WTC 4 was left standing, neatly sliced from the main body which virtually disappeared.
17. The WTC1 and WTC2 rubble pile was far too small to account for the 110 story mass.



18. The WTC7 rubble pile was too small and contained a lot of *mud*.
19. Eyewitness testimony about toasted cars, instant disappearance of people by "unexplained" waves, a plane turning into a mid-air fireball, electrical power cut off moments before WTC 2 destruction, and the sound of explosions.
20. There were many flipped cars in the neighborhood of the WTC complex near trees with full foliage.
21. This compiler installed more than 5,000 thin wall file cabinets and not one was found in the debris. That's why paper was "floating" in the air during and after the collapse. The paper was left undamaged but the thin wall 22 gauge steel was evaporated long before the collapse. The paper had no home when falling, hence drifted about like snowflakes.

"Disappearance" of Demolition Evidence In the WTC "Debris Pile"

Did a laser beam weapon cause the collapse of the World Trade Center? A physicist who worked on the original infrared beam weapon has reason to believe so.

More than five months after the sudden and total collapse of the World Trade Center (WTC), the cause of the towers' structural failure has yet to be properly investigated and remains unexplained, according to America's leading fire engineering experts. As part of an on-going investigation into the disaster, American Free Press has interviewed a German physicist who believes a laser beam weapon, employing infrared technology originally developed in the Soviet Union, may have caused the collapse of the towers.

Directed-Energy Weapons Have Been Around Since Before the '70s

A former East German physicist who studied Soviet infrared technology and plasmoids during the 60s and 70s, and who was directly involved in a demonstration of a Soviet laser beam weapon in 1991 for the U.S. Air Force in Weimar (DDR), told AFP {NB NAME NOT PROVIDED} that there is evidence that a **Directed-Energy Weapon** using "deep infrared" radiation was used to bring down the WTC. Although infrared weapon technology is not widely discussed in the West, the Soviet infrared beam weapon is nothing new and was already used during a Soviet dispute with China in 1969 to destroy "a wall" at the Ussuri River, which separates Manchuria from Russia's Far East, according to the physicist.

Infrared radiation is heat-producing and invisible wavelengths lying between visible light and microwave on the electromagnetic spectrum. "Near" infrared is closest to visible light and "far" or "deep" infrared is closer to microwave. Far infrared waves are thermal and cause increased molecular vibrational activity. In other words, infrared radiation is heat.

Israel's Laser Weapon

There are indications, according to the physicist, that such a weapon was used when the KAL plane was shot down over Kamchatka (Soviet Union) in September 1983. In the early 90s, this technology returned to scientific discussions in the West and the technology itself appears to have been transferred from the Soviet Union.

Since 1995, the United States and Israel have actively developed an advanced infrared beam weapon under a joint "anti-missile" program known as the Tactical High-Energy Laser (THEL). The THEL is a mobile, high-energy laser weapon.

Although the THEL laser weapon was designed, developed and produced by a TRW-led team of U.S. and Israeli contractors for the U.S. Army Space & Missile Defense Command, Huntsville, Ala. and the Israel Ministry of Defense, "***requirements for the system have been driven by Israel***," according to TRW and industry reports. Lasers are the leading edge of **Directed Energy Weapons**. Laser weapons have been under active development for twenty years and easily constitute the most advanced of the directed-energy devices. **In 1984**, Jeff Hecht, author of *Beam Weapons: The Next Arms Race*, wrote, "***The military 'destructor beam' definitely is in our future tactical arsenal.***" The advanced technology and plasma physics involved in directed-energy weapons give them unprecedented lethal power. Among their more important features are:

- the ability to fire energy "bullets" at or near the speed of light

- the ability to redirect their fire toward multiple targets very rapidly
- their very long range and
- their ability to transmit lethal doses of energy in seconds or even a fraction of a second.

No conventional ammunition is required — only fuel for the power generator is needed.

The THEL is part of a joint program known as Nautilus, in which the US Army and the Israeli Ministry of Defense (IMOD) have developed infrared laser weapon systems. The prime contractor, TRW Space and Electronics Group, has been involved in the development of high-energy laser systems since the early 1970s. A host of Israeli engineers and companies are involved in the program including the aerospace companies Rafael, Israel Aircraft Industries and Tadiran.

The THEL is a mobile system ostensibly designed to destroy rockets, such as the Russian-made Katyusha.

The physicist told AFP, *"From my experience as a physicist and research scientist with the GRU (Russia's Central Intelligence Agency) I have enough experience to judge that the WTC towers have been burning too quickly, too hot, and too completely to have been caused by the kerosene [jet fuel] fires that resulted from the crashes. Furthermore, the demolished buildings nearby [the 47-story Salomon Bros. Bldg.] are an indication that there was a plasmoid cloud involved, which probably affected the buildings nearby."*

A plasmoid cloud is a heated and ionized gas that can be created and projected using far infrared thermal waves. Plasma occurs when a gas is heated so that some electrons have been separated from their atoms or molecules. Ball lightning is considered by experts to be a plasmoid phenomenon.

The physicist told AFP that he believes that a plasmoid may have been projected onto the towers before the planes struck. "The planes may have had a plasmoid in front of them. Just two or three seconds before the planes hit the towers, a plasmoid on the towers would have caused the Faraday cabin effect, like a car being hit by lightning." ...

"Old" Soviet Technology

In 1991, before the Soviet military withdrew from East Germany, the GRU demonstrated for the U.S. Air Force Electronic Security Command (AFESC) the capabilities of its infrared beam weapon by reducing a ceramic plate into dust from a distance of one mile. This display of Soviet weapon technology was meant to impress upon the U.S. Air Force "how a stealth bomber could be turned into dust in the same way," the physicist said.

The physicist placed a slightly warmed plate on the floor of a kitchen in an apartment on the fifth floor, just below the roof. GRU headquarters in Weimar (DDR), where the infrared beam originated was less than one mile away on the other side of the valley and the second transmitter or reflector was 200 meters away, with no obstacles between. An infrared beam weapons requires two sources.

The TV and the oven were turned on and the TV's remote control was put in the refrigerator. The physicist left the room and watched the TV screen, which went black for a few seconds. The physicist left the apartment for a half hour to allow AFESC personnel to examine the results.

The plate had been reduced to a form of dust that was difficult to pick up **even with a vacuum cleaner**, according to the physicist. *"The plate was not destroyed suddenly as if hit by a bullet, rather it disintegrated in a process **taking about 15 minutes.**"*

SO... JUST HOW WAS A... "*Directed Energy Weapon*" USED ON 911? (VeriZon or "Ver Zion" (In Spanish... "I see Zion"))

First things first. About six (6) months after 911 on 3.11.02 an announcement was made in the Wall Street Journal that Ivan Seidenberg, then VeriZon co-CEO, a dual US and Zionist Israeli Citizen, would succeed Charles Lee as **exclusive** CEO. The location of the second source answers a plethora of questions. Most notably: "*where did the immense power/VOLTAGE that was required to dissolve/evaporate the steel and concrete in the WTC originate?*" Thank you NY **Local 3**!! The **second Building Seven** is at MetroTech Brooklyn (MetroTech #7). Curiously, it's *another* VerZion building with hidden access to hundreds of thousands, if not millions, of volts via the NY subway system directly below its street level. Adding to this growing curiosity is the absolute FACT that entry to VerZion's MetroTech #7 is virtually impossible unless you are an employee of the company. Therefore, under the control of Mr. Ivan Seidenberg, a dual US and **Zionist ISRAELI Citizen**. Just for the record there are no windows and very limited points of entry to VeriZon's MetroTech #7. Will we ever know how many MOSSAD agents work out of Verzion's MetroTech #7? 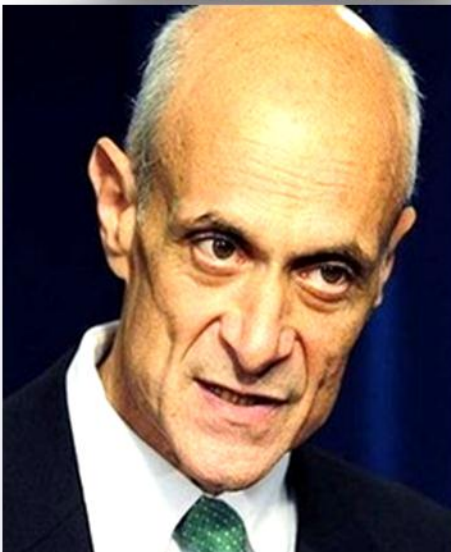

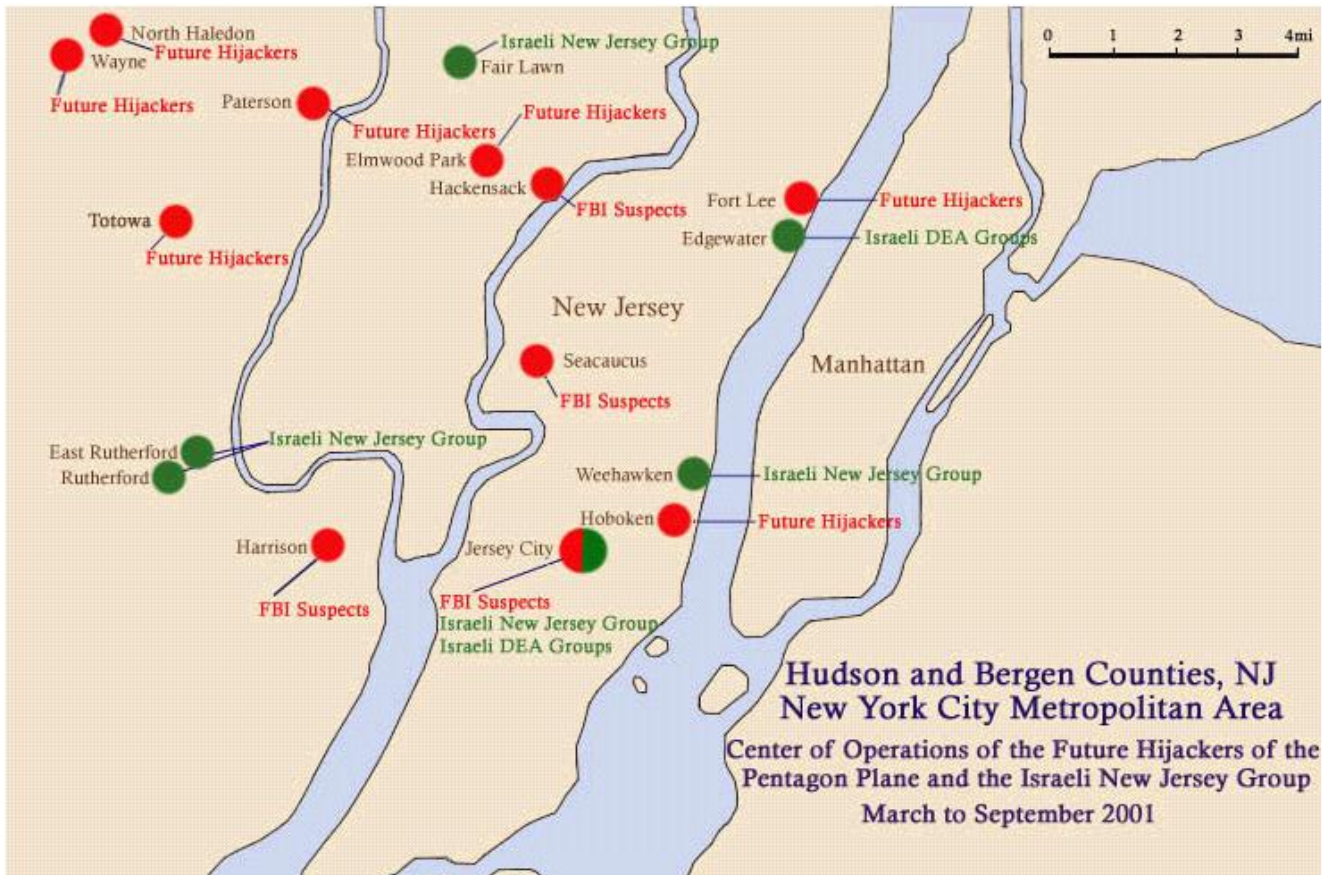
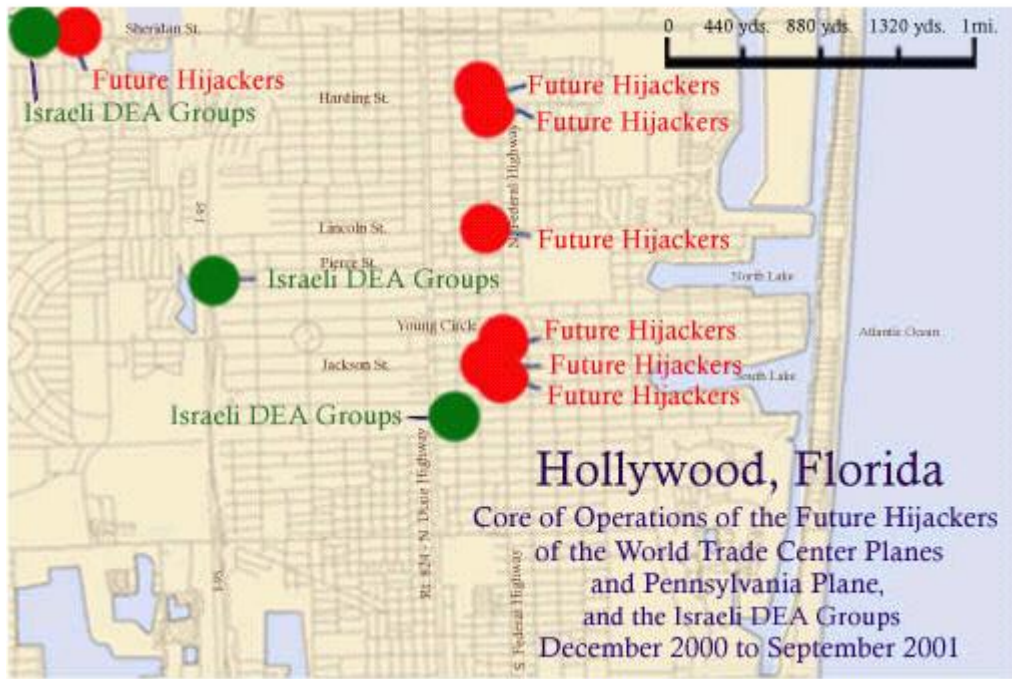
Jan. 11, 2005 Bush nominates Chertoff for Secretary of Homeland Security.

Israel's "Unbreakable Bond" with Dual US/Israeli Zionist US Federal Judges Controlling All 9-11 Litigation

As expected, the nominee to be next Attorney General of the United States has a long history of obstructing justice, preventing discovery, and covering up the evidence of Israeli involvement in the terror attacks of 9-11.

If Israeli agents were not prime suspects in the "false flag" terror attacks on the World Trade Center, and if a passenger screening company owned by Israeli intelligence agents were not a defendant in the 9-11 litigation, the fact that the crucial 9-11 lawsuits have been handled by two Zionist judges from the same synagogue might be considered a coincidence.

But with so much evidence of Israeli involvement in 9-11 in plain view, the intimate connection with the State of Israel of these judges cannot be discarded as mere coincidence. It should rather be viewed as evidence of the on-going, high-level,

and well-planned cover-up.

The Zionist judges controlling the 9-11 litigation have acted like the Israeli bulldozers after the massacres in the Palestinian refugee camps of Sabra, Shatila, and Jenin. Like judicial bulldozers, the mission of these orthodox Jewish judges is to bury the evidence of Israeli involvement in the "false flag" terror attacks of 9-11.

ZIONIST JUDGES

In what might otherwise be seen as coincidence, the two presidentially-appointed federal judges who have presided over the most crucial 9-11 cases are both orthodox Zionist Jews who attend the same Manhattan synagogue and support its Talmudic yeshiva.

The federal judges Alvin K. Hellerstein and Michael B. Mukasey, the nominee to be the next U.S. attorney general, are both members of a Zionist congregation, the orthodox Kehilath Jeshrun synagogue of Manhattan, and are active supporters of its yeshiva, the Ramaz School.



A yeshiva is an orthodox Jewish school affiliated with a synagogue where Talmudic interpretation of Mosaic law is taught. In an orthodox yeshiva, the Talmudic interpretation of the Torah is based on rabbinical teaching that completely changes the meaning of Mosaic law.

Talmudic interpretation effectively negates the meaning of the Ten Commandments as the late Israeli scholar Israel Shahak pointed out in his book on Jewish supremicism, Jewish History, Jewish Religion: The Weight of Three Thousand Years.

To an orthodox Jew, Shahak wrote, Talmudic scholars interpret the commandment "Thou shall not kill," to mean that a Jew is proscribed only from killing another Jew. Non-jews, on the other hand, are fair game and can be killed like animals. The rest of the Mosaic law is interpreted likewise concerning treatment of non-Jews, according the Shahak's book.

Unbeknownst to most Americans, the key judges who have overseen the most important 9-11 lawsuits and Michael Chertoff, the Asst. Attorney General who directed the non-investigation of 9-11, are all members of this extremely racist and un-American religious sect. They, like the other key officials involved in the 9-11 conspiracy, were all raised and educated in this tradition.

The judges, officials, and advisors involved at every critical point of the 9-11 conspiracy and cover-up are all Jewish Zionists dedicated to the State of Israel. This is how Zionist agents have been able to cover up the truth of what really happened on 9-11.

THE SYNAGOGUE

The Congregation Kehilath Jeshurun is a Zionist synagogue, according to its mission statement. It defines itself as a "modern Orthodox" synagogue, which is "deeply committed" to "an unbreakable bond with the State of Israel and its citizens."

The orthodox branch of Judaism is a minority sect making up about 10 percent of American Jews. This minority sect, however, wields immense power in the government and courts of the United States.

The Kehilath Jeshurun congregation has a long history of shaping the Zionist agenda. In the 1920s, for example, it hosted orthodox Zionist conferences where plans were discussed to bring all the Jews of Russia to the southwestern United States.

"Our identification with the State of Israel and our fellow Jews extends well beyond the more conventional UJA/Federation, Israel Bonds and tree-planting campaigns," the congregation's mission statement says – **and indeed it does.**

The Kehilath Jeshurun congregation acts as an agency of Israel on the Upper East Side of Manhattan and many who occupy positions of power within the government of the United States, are its members.

The "modern" orthodox congregation also has a long history of calling for segregation and separation of Jews from Christians and Christian influences in the community. Like other orthodox Jews, the congregation is opposed to Reform Judaism, the largest branch of Judaism. Orthodox religious expression is the only form of Judaism that is recognized by the State of Israel.

As a religious sect that is based on race, intermarriage between Jews and Christians is anathema to orthodox Jews like Chertoff, Hellerstein, and Mukasey.

ROOTS IN THE PALE OF SETTLEMENT

Like most Zionists, the parents or grandparents of Chertoff, Hellerstein, and Mukasey are from the largely uncivilized frontier region between the Russian and German spheres of influence known as the **Pale of Settlement.**

The Pale of Settlement refers to the expanse that reaches from Lithuania to the Black Sea, a region between Prussia and the Russian Empire of Catherine the Great, who created the Pale in 1791. The Pale existed until 1917 and is occupied today by Ukraine, Poland, Belarus, and Lithuania.

Chertoff was the key Zionist gate-keeper and controller of the "non-investigation" of 9-11.

The areas around Brest-Litovsk, Grodno, and Bialystok had the largest concentrations of Jews and were hotbeds of Zionist activity in the late 1800s. Jews outnumbered Christians in some of the towns, such as Grodno, an old Lithuanian city.



When Catherine the Great annexed this western region, she banned the Asiatic Jews who lived there from coming to Russia. These Jews were primarily descendents of the displaced Khazars who had converted to Judaism in the 8th Century.

In the **Pale of Settlement**, the Khazar Jews, generally referred to as Ashkenazi, usually lived in communities separated from the non-Jewish people they lived among.

MUKASEY & HIS YESHIVA

Michael Bernard Mukasey and his wife are members of Kehilath Jeshurun, the orthodox synagogue that is connected to the Ramaz yeshiva. The Ramaz School was started in 1937 by Rabbi Joseph H. Lookstein.

Lookstein served concurrently as principal of the Ramaz School in New York and as president and chancellor of Bar-Ilan University in Israel, where he was chancellor from 1958 to 1979. This illustrates the intense Zionist character of the Ramaz school and synagogue.

Mukasey attended the Ramaz School and graduated in 1959. His wife, the former Susan Bernstock Saroff, was a teacher and headmistress of the Ramaz Lower School. Both of Susan's children, who were adopted by Mukasey, attended the Ramaz yeshiva.

Mukasey, the nominee for attorney general, attended the Ramaz yeshiva and reportedly "*remains heavily involved in that community.*" That "community" would be the orthodox, Zionist, and Israeli community of Manhattan.

In 1948, according to the Ramaz school's website, children of Israeli diplomats on "special missions" began enrolling in the Ramaz School. These Israeli students attended Ramaz with Mukasey, who speaks Hebrew.

Isaac Herzog, the son of Chaim Herzog, the former president of Israel and head of the Israeli military intelligence, attended the Ramaz school in the 1970s. Isaac Herzog was government secretary under Ehud Barak and is currently a minister in the Israeli government.

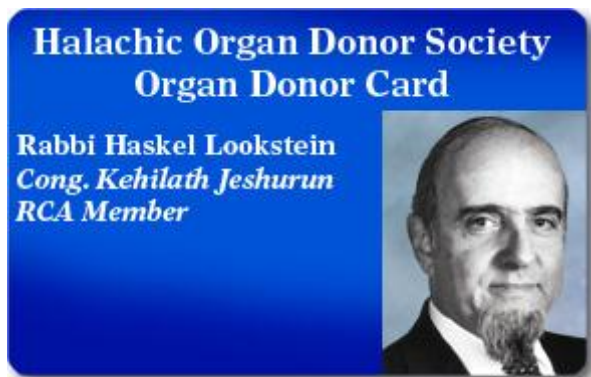
Mukasey will be the second Jewish attorney general, if confirmed. Ed Levi, who served under President Gerald Ford was the first.

Mukasey was nominated as a federal judge in New York in 1987 by President Ronald Reagan and became the chief judge in 2000.

Mukasey was elevated to Chief Judge of the U.S. District Court for the Southern District of New York, succeeding Judge Thomas P. Griesa, on March 12, 2000. Mukasey remained in this position until August

1, 2006. As chief judge for New York City, Mukasey was well placed to control the entire legal process concerning 9-11.

"From 1967 to 1972, Mukasey was in private practice, where his clients ranged from right-wing lawyer Roy Cohn to the Daily News," the newspaper reported. "He then switched sides and joined the Manhattan prosecutor's office, where he forged a life-long friendship with future Mayor Rudy Giuliani."



In an article entitled "Local Rabbi Thinks Michael Mukasey Perfect for AG Job," the New York Daily News reported that after President Bush announced his intention to nominate Mukasey, the FBI called on his rabbi in Manhattan.

"Rabbi Haskel Lookstein said the G-men wanted to know if there was anything in the 66-year-old judge's background that could scuttle his nomination," the Daily News reported. Lookstein reportedly told the agents that Mukasey was "a mensch."

"There's nothing wrong with him," the rabbi said. "He's as close to perfect as you can be. And that's the way he was at 15."

Very little is known about Mukasey's family background. There are very few articles that mention the name Mukasey prior to 1960. The Mukasey name is a Jewish surname from a place named Lachowicze, in the region of Brest.

Judge Mukasey's wife was the headmistress of the Ramaz Lower School in the 1990s when he was handling the case of the first "false flag" terror bombing of the World Trade Center. **This case was primarily meant to prepare public opinion for what was planned for 9-11.**

A "STRONGLY BIASED ZIONIST JUDGE"

At the beginning of the trial of Sheik Omar Abdel Rahman, the sheik's lawyers filed a motion requesting Mukasey recuse himself from the trial.

The motion argued that Mukasey's allegiance to Israel created a bias against the Muslim defendants. Mukasey dismissed the motion as "utterly irrelevant."

"A strongly-biased Zionist judge," is how Dr. Edward W. Miller described Mukasey in his 1997 article about the trial of the blind sheik.

"Mukasey is a committed Zionist, a long-time supporter of Israel," Miller wrote. "His wife is also a Zionist."

"Sheik Rahman was denied the lawyer of his choice by Judge Mukasey, and when he asked the court to permit an expert to explain the practices of Islam to an ignorant American jury, he was refused this due process. Eventually, on January 17, 1996, Sheik Omar Abdul Rahman was sentenced by a Jewish judge of strong Zionist leanings to imprisonment for life plus 65 years."

"After receiving his lifetime sentence," Miller wrote, "this elderly, sick and blind sheik, standing before the Jewish judge, spoke quietly and at length in Arabic."

"He pointed out the on-going 'historical junction' at which 'the spiritual power of Islam was confronting the military/material juggernaut of a Zionist White House.'

"Sheik Rahman continued, debunking the prosecution's theory that he heads an international terrorist organization. He emphasized that he was sequestered in a jail in Cairo in the early 1980s at the time the so-called 'international terrorist group' was allegedly being formed.

"Judge Michael Mukasey was visibly irritated by the Sheik's remarks, and interrupted the scholarly cleric repeatedly and rudely, finally remarking that 'religion has nothing to do with the case.'

A lawyer who tried a case before Mukasey described him as "Dour and condescending; imperious and egotistic." "I seriously doubt whether he has the 'people skills' that the DOJ needs in a new AG," the attorney said.

HELLERSTEIN & RAMAZ SCHOOL

Alvin K. Hellerstein, who has presided over all the 9-11 cases brought by victims and relatives of victims, is also a trustee and sponsor of the Ramaz School on the Upper East Side, where his children also studied.

Hellerstein has been president of the Board of Jewish Education of Greater New York and serves on a taskforce for the Jewish Orthodox Feminist Alliance, which addresses the needs of Orthodox Jewish women who want a divorce.

Hellerstein's wife, Mildred, and Audrey Lookstein, the wife of the rabbi of Kehilath Jeshrun, are Zionist colleagues and senior officers of an Israeli organization named AMIT.

Mildred Hellerstein is listed as being a National Treasurer of AMIT, an organization dedicated to fostering "religious values and Zionist ideals" in the Israeli children in its schools and programs in Israel. Lookstein has been vice president of AMIT several times and was chair of AMIT's national board of directors in 2006.

TEVI TROY – ASHCROFT'S POLICY DIRECTOR

Tevi Troy (formerly Troyansky), Deputy Secretary of the United States Department of Health and Human Service, is another graduate of the Ramaz School.

Troy was the policy director for Sen. John Ashcroft (R-MO) in the late 1990s before he was appointed to be Bush's first Attorney General, an appointment Troy enthusiastically supported in his article "**My Boss the Fanatic**" published in **The New Republic**.

Ashcroft now has a consulting business and earns much of his money by representing Israeli military companies.



In 2006, Israel Aircraft Industries (IAI) was reported to be a major client of the Ashcroft Group, LLC.

Prior to his May 2007 appointment as Deputy Secretary of the DHHS, Troy was Deputy Assistant to the President George W. Bush for Domestic Policy. In August 2003, Troy was appointed to serve at the White House as Deputy Cabinet Secretary and Liaison to the Jewish community.

An orthodox Jew, Troy is the son of Elaine Gerson Troy and Bernard Dov Troy, the former "*Executive Director of the Jewish Educators' Assembly in Manhattan.*"

Troy is the grandson of Thomas and Pauline Troyansky,

Russian Jewish immigrants who came to the United States in the early 1900s.



He is married to Kami J. Pliskow, the daughter of Dr. Raymond and Vita Pliskow of Tacoma, Washington. Raymond studied medicine at the University of Michigan.

The Pliskow family, a Russian Jewish family that immigrated to the U.S. in the early 1900s has its own interesting history of terrorism.

Barbara Pliskow, a former instructor in psychology at Wayne State University in Detroit, attempted to hijack an American Airlines Boeing 727 on September 24, 1971 armed with a gun, dynamite, and other explosives. She was reportedly

When dealing with financial crimes as planned and executed over the past two (2) centuries by the **House of Rothschild**, it's necessary to go back in the history of the specific events. We must look at the genesis of (who created) certain *Debt-Instruments* surrounding the contemporaneous crisis; I.e. sub-prime **Mortgage Backed Securities** (sub-prime MBS at Salomon Brothers, circa 1981), Credit Default Swaps (Lehman or Salomon Brothers circa 1984/87) Collateralized Debt Obligations, CDO's, (Michael Milken 1987) and their attendant use in Options as *Derivatives*; yet another brilliant instrument for the leveraged creation of **unlimited** debt.



Ms. Brooksley E. Born is a former American public official who, from **August 26, 1996, to June 1, 1999**, was chairperson of the **Commodity Futures Trading Commission (CFTC)**, the federal agency which oversees the futures and commodity **OPTIONS** markets as well as the individuals who participate in those markets. In 2008, she appeared on the *Legal Times* list of "**The 90 Greatest Washington Lawyers of the Last 30 Years**" and was described as a "**Champion**".

After graduating, in 1964, from **Stanford Law School**, where she received the "**Outstanding Senior**" award and served as president of the *Stanford Law Review*, Born became a **law clerk** to D.C. Circuit Court judge Henry Edgerton.

The following year, she joined, as an associate, the Washington-based international law firm of **Arnold & Porter**, where she subsequently rose to a partner. Her appointment as a member of the **CFTC**, on April 15, 1994, came after a career as **head of the firm's derivatives practice**, where she represented clients in numerous complex litigation and arbitration cases involving financial market transactions.

While on the commission and after becoming its chair two years later, Born tried to bring derivatives, specifically **Swaps** that are traded **at no central exchange, known as the Dark Market**, and thus have no transparency except to the two counter-parties, under the regulatory oversight of the CFTC. **Ms. Born was strenuously opposed in this effort by Federal Reserve chairman Alan Greenspan, Glass-**

Steagall killing Treasury Secretary Robert Rubin and Asst. Sec. Lawrence Summers.⁴ (By way of Mr. Rothschild's "Law of Return", all three of these men are Israeli Citizens. Mr. Summers name was originally Samuelson. ☹)

Specifically, on May 7, 1998, former SEC Chairman **Arthur Levitt** (also an Israeli Citizen) was the fourth to join the other members of the President's Working Group – Treasury Secretaries Rubin and Summers PLUS Federal Reserve Board Chairman Greenspan – in objecting to the issuance of the CFTC's concept release, **in which Born attempted to shed light on the *Dark Market*, citing grave concerns about the possible consequences of the CFTC's inaction.**

Ms. Born called for greater disclosure of trades and reserves to cushion against losses. Ms. Born's views incited fierce opposition from Fed Chairman **Mr. Greenspan** and then Treasury Secretary Rubin,.

"Greenspan told Ms. Born that she essentially didn't know what she was doing and she'd cause a financial crisis," said Michael Greenberger, who was a senior director at the commission. *"Brooksley was this woman who was not playing tennis with these guys and not having lunch with these guys. There was a little bit of the feeling that this woman was not of Wall Street."*

In early 1998, Mr. Rubin's deputy, Lawrence H. *Summers*, a.k.a. Samuelson, called Ms. Born and chastised her for taking steps he said would lead to a financial crisis, according to Mr. Greenberger. On April 21, 1998, senior federal financial regulators convened in a wood-paneled conference room at the Treasury to discuss Ms. Born's proposal. Treasury Secretary Rubin and Mr. Greenspan implored her to reconsider, according to both Mr. Greenberger and Mr. Levitt. Ms. Born pushed ahead.

Finally, on June 5, 1998, Mr. Greenspan, Secretary Rubin and Mr. Levitt called on Congress to prevent Ms. Born from acting until more senior regulators developed their own recommendations. Mr. Greenspan and Mr. Rubin were *"joined at the hip on this,"* Greenberger said. *"They were certainly very fiercely opposed to this and persuaded me that this would cause chaos."*

Since hindsight is always 20/20 we now know that the **Credit Default Swap** and its revered place in the growing derivative market had to be protected by Rothschild's small band of Israeli Citizens at all cost. If Mrs. Born's report had been made we would not be watching the economic meltdown of 2006 forward.

As the financial crisis of 2008 gained momentum, newspapers began reporting on what might be some of its causes, including the adversarial relationship Greenspan, Rubin, Summers and Levitt had with Brooksley Born, **with Greenspan leading the opposition**, and how Born's recommendations were suppressed. She is retired from Arnold & Porter and has declined to comment on the unfolding crisis.

Unfortunately, Ms. Born soon gained a potent example. In the fall of 1998, the hedge fund **Long Term Capital Management** nearly collapsed, dragged down by **disastrous bets** on, among other things, **derivatives**. Infamous John Meriwether whose department at Salomon Brothers was caught rigging the bids to the US Federal Reserve in 1991 was at the helm of LTCM when disaster struck. A trial run for what we are watching today?

More than a dozen banks pooled \$3.6 billion for a private rescue to prevent the fund from slipping into bankruptcy and endangering other firms.

However, despite that event, under intense pressure from Mr. Greenspan and Secretary Rubin, Congress froze the Commodity Futures Trading Commission's regulatory authority for six months. The following year, Ms. Born departed. In November 1999, senior regulators — including Mr. Greenspan and Mr. Rubin

— recommended that Congress permanently strip the C.F.T.C. of regulatory authority over derivatives. Israeli Citizen Hank Greenberg's fortunes at AIG were for the most part saved. No doubt any losses will be accommodated by the more than a few billions in tax exempt earnings Mr. Rothschild earns annually from his ownership of Capital Stock of the Federal Reserve. (See Title 12, Section 531.)

Penultimately amazing, the CFTC, headed back then by Born, is now headed by Obama appointee Gary Gensler, a former Goldman Sachs executive who was as instrumental as anyone in blocking any regulations of those derivative markets (and then enriched himself by feeding on those unregulated markets). Gensler was Undersecretary of the Treasury (1999-2001) and Assistant Secretary of the Treasury of the United States (1997-1999). Mr. Gensler is also a dual US/Israeli Citizen.

Finally, on Thursday, May 14, 2009, the Obama administration wants to regulate **Credit Default** transactions. While sounding like the right thing to do, this writer guarantees you that this new zeal for regulatory action of the "Dark Market" will carefully sweep all that has past under whatever rug dual US/Israeli Citizen and Obama Chief of Staff (slash) *handle Rham Emanuelr...* points to. Ben Shalom Bernanke's Fed has already just used its "Creditor Rights" to take control of Mr. Greenberg's **London** (Rothschild) based **AIG Financial Products**. It Becomes More Amazing By The Minute AP Sources: Obama Wants Fed To Be Finance Supercop

WASHINGTON – The [Rothschild/Rockefeller privately owned] Federal Reserve could become the supercop for "too big to fail" companies capable of causing another financial meltdown under a proposal being seriously considered by the White House.

The Obama administration told industry officials on Friday that it was leaning toward making such a recommendation, according to officials who attended a private one-hour meeting between President Barack Obama's economic advisers and representatives from about a dozen banks, hedge funds and other financial groups.

Treasury Secretary Timothy Geithner and other officials made it clear they were not inclined to divide the job among various regulators as has been suggested by industry and some federal regulators. Geithner told the group that one organization needs to be held responsible for monitoring system wide risk.

"Committees don't make decisions," said Geithner, according to one participant.

Officials from the Treasury Department and National Economic Council, which hosted the meeting, told participants that the Fed was considered the most likely candidate for the job, according to several officials who attended or were briefed on the discussions.

The administration officials said a legislative proposal would likely be sent to Capitol Hill in June 2009 with the expectation the House Financial Services Committee, **led by Rep. Barney Frank**, D-Mass., would consider the measure before the Independence Day recess.

Barney Loves Fannie

However, just as Mr. Greenspan and his merry band of Israeli Citizens stifled Ms. Brooksley Born into silence, along comes dual US/Israeli Citizen Barney Frank whose ex-lover, (wife?) Remember that for over two centuries the House of Rothschild thrives on Revolution and civil wars. Rothschild has always viewed a nation's wealthy as the last protector of its People. An angry mob will never understand that the success of the wealthy in any nation is always synergistically dependent upon its People. In other words, in a free society, each needs the other for survival. Otherwise we'd have Mr. Rothschild's Socialism dictating to the People. AIC owners at the time were all instrumental in financing Mr. Trotsky's return to Russia from Brooklyn in 1917. These AIC men were teased into and had hoped to acquire, by negotiation or stealth, access to Russia's oil fields and other natural resources. Unfortunately they had underestimated Mr. Rothschild's power and were shortly thereafter double-crossed by the Bolsheviks of the time. For the most part whose leadership were all Jewish and all directed by the House of Rothschild in 1917 and forward. Hence never really being aware they were double double-crossed. *For a century the **American International Corporation** succeeded in remaining invisible because its founders thrived on absolute secrecy. And, those founders—were? AIC was incorporated in 1910. While **Charles Stone**'s name appears as the historic founding head of AIC, the company was the brainchild of **John D. Rockefeller, Sr., Andrew Mellon, J.P. Morgan, and Andrew Carnegie**. An assortment of American industrialists, bankers and merchant princes joined the AIC parade over the next couple of years because they were convinced that, with the financial clout of the world's wealthiest men behind it, the new 800-lb economic gorilla on the horizon was going to be Russia. They all wanted a piece of the action in a new economy devoid of thousands of government restrictions that hamstringing business.*

"AIG Financial Products" Corporate History

Joseph Cassano and Thomas R. Savage **helped** Mr. Greenberg start AIGFP in 1987. "Help" is a key word. AIGFP was clearly Mr. Greenberg's baby however.

AIGFP focused principally on OTC derivatives markets and acted as principal in nearly all of its transactions involving capital markets offerings and corporate finance, investment and financial risk management products. AIGFP played key roles in the acquisition of London City Airport and, in one of the largest private equity transactions announced in 2006, the management-led buyout of Kinder Morgan Inc.

AIGFP's commodity derivatives and commodity indices helped stimulate the development of this new asset class. AIGFP created a specialized credit business. AIGFP focused its business on structured products like CDO's. (Collateralized Debt Obligations) In 2003, it absorbed subsidiary, AIG Trading Group (AIG-TG) which dealt primarily in over the counter derivatives and created the Dow Jones-AIG Commodity Index (DJ-AIGCI) from their offices in Greenwich, CT. The DJ-AIGCI is a leading commodity benchmark composed of 19 futures contracts on physical commodities. Mr. Greenberg's (inset) AIGFP was dripping with respectability. No one would question the legitimacy of any financial product where AIGFP made a market. (Who could have ever predicted the events surrounding US markets following 911 much less predicted 911? Mr. Greenberg?) As of the end of June 2007, there was an estimated \$38 billion invested in financial products that track the DJ-AIGCI on a global basis.[2]

From 1987 to 2004, AIGFP contributed over \$5 billion to AIG's pre-tax income. During that period, AIG's market capitalization increased from \$11 billion to \$181 billion, and its stock price increased from \$4.50 per share to \$62.34 per share.

Crisis of 2008

AIGFP's trading in credit derivatives led to enormous losses. These losses at AIGFP division essentially bankrupted the entire AIG operation, and forced the United States government taxpayer to bail out the insurance giant. Conveniently, Mr. Greenberg was no longer at AIG to feel the pain.

Exit Strategy

Like any war in history, planning must cover all aspects, including withdrawal. The House of Rothschild rarely leaves any principals at the helm of a company when the ship begins to list. Much less sink. Reputations should be saved and all diminishing currency assets converted into hard assets: gold, or a gold based currency, i.e., the Israeli New Shekel. (Yes you read that right. The Israeli Treasury representative last year – 2008 -- even went so far as to tell her US counterpart that the BILLIONS in US aid, usually given outright to Israel, would no longer be welcome in US Dollars. They would only accept our aid in EUROS. Russian Jews have a Yiddish word for that... chutzpah!)

After a more than 20 year successful run at AIG, on March 15, 2005, AIG's board forced Greenberg to resign from his post as Chairman and CEO under the shadow of criticism from *fellow Israeli Citizen Eliot Spitzer*.

Mr. Spitzer as you'll remember was the call-girl challenged Attorney General/Governor of the state of New York. On May 26, 2005, as part of a series of actions against leaders of large corporations, Spitzer filed a complaint against Greenberg, AIG, and Howard I. Smith (ex-CFO of AIG) alleging fraudulent business practice, securities fraud, common law fraud, and other violations of insurance and securities laws. Greenberg's public statements show that he found the Spitzer investigation to be very troubling. He maintained his innocence throughout the investigation, and alluded to the possibility that Eliot Spitzer might be conducting a high-profile witch-hunt in the interests of furthering his political ambitions. He was! Greenberg's prosecution was to be a twofer and Mr. Spitzer was elected to the Governor's seat. However, he was quickly dethroned.

Criminal charges

After a subsequent investigation, however, **all criminal charges were dropped**, and Greenberg was not held responsible for any crimes. Spitzer did, however, bring civil charges against Greenberg, though he dropped two of the six initial charges in September, 2006. Greenberg's attorney claimed vindication with the dropping of the two charges, but Spitzer's office maintained that the four remaining charges are the core of the State's original charges. To date Mr. Greenberg has not suffered loss of prestige. Except to the IRS, Mr. Greenberg hasn't lost a cent. In fact it would be interesting to see where Mr. Greenberg has had his money since 2000, just before 911.

End Result For Mr. Greenberg Tells the Whole Story

Remember we spoke of an "exit strategy"? These folks that I believe are criminals are the most clever in the history of the world. They'll always be miles away when the explosions (debt bombs) go off and usually in a position to capitalize a second time. 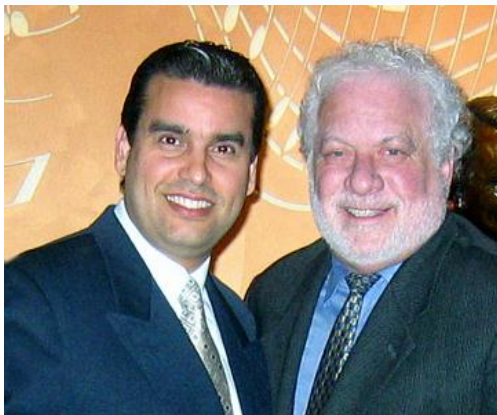

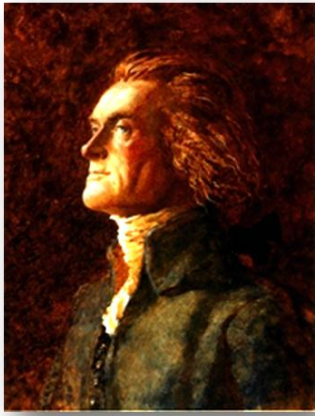
