All complaints must be submitted within sixty (60) days of the victim's knowledge of a violation by the Department of Justice employee, but not more than one year after the actual violation. Receipt of complaints will be acknowledged in writing.

The information may be furnished to designated officers and employees of agencies and departments of the Federal Government in order to resolve or otherwise determine the merits of this complaint.

Note that my "statements" are all already a matter of public record, as submitted numerous times to a litany of USDOJ employees, including United States prosecutors and assistant prosecutors, civil rights department employees, as well as "judges" for the USDC for the EDM (to include those who have gone through the "revolving door" from being the U.S. Attorney to become federal judges).

Essentially, there are numerous "patterns and practices" that have been identified in operation by "the accused" as all being members of the State BAR of Michigan, at both the state and federal levels, operating in the EDM. These "complaints" have been brought to Barbara McQuade on numerous occasions by many people, several citing 18 U.S.C. § 3332 in demand to bring these reports of crimes directly to "We, The People" - the real "government" of this nation - of the federal "special grand jury." There has been documentation of written denials, despite the expressed language of the federal code requiring "reports of crimes" to be brought directly to the special grand jurors. These "patterns and practices" include family dynasties operating between the federal and state courts. One good example is Jason Zatkoff, who was related to federal "judge" Lawrence Zatkoff, who began working as the "clerk" for the Michigan Supreme Court after "interning" for the judicial usurper Zatkoff. Zatkoff was the "judge" that dismissed my "complaint" years ago in federal court naming FBI agents, U.S. Attorneys, and other USDOJ "employees" who are all "aiding and abetting" their "peer group" of other "domestic terrorists" operating in this territory to "coerce the population" and to "coerce the government" policies and practices. The recent unrebuted "Affidavits" sent to Loretta Lynch as affiliated with the referenced court case in the USDCEDM is a good place to start retracing all of these reported "chains" of crimes being committed by numerous of "the accused."

Note also that I am NOT the only one to be reporting these crimes of state and federal racketeering, corruption, and domestic terrorism taking place in the territorial area ranging from the Detroit federal building all the way to the Sixth Circuit camp of "judges" who have also turned a blind eye and deaf ear to the many "reports" and "complaints" of this ongoing "chain" of activities. One particular "date" that sticks out in which the reports of these crimes was brought to U.S. Attorney General Eric Holder is by the "Sworn and Notarized Criminal Complaint of David Schied (2/10/2010)" as is publicly posted in its entirety on the Internet showing that it was submitted also to the "clerk" and the "judges" of the U.S. Court of Appeals for the Sixth Circuit on 2/11/10 representing the scope and breadth of the domestic terrorism as it was occurring six years ago relative to a completely different set of circumstances.
