ORDER

Pending before the court is a motion to dismiss this appeal filed by the Michigan Municipal Risk Management Authority (MMRMA). The plaintiff has submitted in response a 14-page response, a 30-page brief in support of the response, and an appendix that appears to be well in excess of 1500 pages.

A response to a motion must not exceed 20 pages. Fed. R. App. P. 27(d)(2). Taken together, the plaintiff's response and brief in support exceed that limitation, and he has not



moved for leave to file a response in excess of the page limitation. Additionally, an appendix is not authorized in this appeal because the entire district court record is viewable to the court of appeals electronically via the district court's docket. 6th Cir. Rule 30(a).

Therefore, the response in opposition to the motion to dismiss is accepted for filing. The brief in support of the response will be tendered upon the docket in view of the excess length for whatever consideration, if any, that the court may choose to give it. Finally, the appendix is rejected for filing as unauthorized by the applicable rules and too voluminous for placement upon the docket.
