Dear Jacob Lew, Mark LaVia and All Management at the UNITED STATES Department of Education and the USDOE's Federal Student Aid, Unknown "FOIA Officer," All Management of the Office of the Chief Information Officer, Unknown Chief Information Officer, and All Management of Regulatory Information Management Services employed by the UNITED STATES, in your corporate person and by address to your flesh-and-blood persons actually doing the work under clandestine cover of corporate and/or quasi-government "*persona*",

Again, I address all of you, individually and collectively, in your "official" and "individual" capacities and demand to know the human beings behind your corporate and/or quasi-government "shell". In the event that this situation turns to litigation, I aim to have accountability for everyone involved. As such, you should note that I will not accept any further actions coming from any of you unless there is an accountable human being conducting the communication with me. Period.

I am writing to all of you again because I have received no direct response to my previous correspondence, which included among other things, a number of requests for documents and answers to numerous questions, which I have provided again below in this follow-up letter to each of you. As a reminder of my previous correspondences, I am providing to you with three cover pages of my previous letters, one dated 10/12/16 and the other two letters dated 10/19/16, for your reference. Please check your records because I am still awaiting your responses to all three of these timely documents, inclusive of their respective FOIA requests for documents which are due or past due in return to me by law. As an added courtesy, I am also including "proofs of mailing" receipts provided by USPS showing the mailing of my previous documents

to your "*agents*" of the UNITED STATES, your debt collectors at Central Research, Inc. to the Default Resolution Servicing Group, and to John Kerry, the UNITED STATES Secretary of State.

First, I wish to respond to your recent untitled notice/billing statement dated 10/24/16 sent from Mark LaVia of the UNITED STATES (Department of Education) claiming \$84,812.49 in defaulted student loan debts, which I neither admit nor deny to owing. However, with reference to the reverse side of his "form" letter, above Mark LaVia's typewritten name (i.e., there was no valid and authorized signature), was the statement, "We can refer your debt to the Department of Treasury for offset of Federal and/or State payments due you..."

In answer to that "offer," I am willing to have your claim of a debt owed by me to the UNITED STATES "offset" and paid for in full, by deducting your claim of \$84,812.49 from the \$230 MILLION that I am claiming is owed to me by the UNITED STATES. Note that if you will accept that arrangement, I will overlook the FACT that I have sent you and your agents numerous "Cease and Desist" notices with penalties and fees assessed at \$2,000,000 per occurrence and that Mark LaVia's recent correspondence without dispute of my previous claims marks his defiance of my "cease and desist" order and his agreement to my assessment of penalties and fees against his – and your – "collection" actions. Again, should you accept my "counter-offer," I will forgive the \$2,000,000 amount for violation of my "cease and desist" order, and will deduct the \$84,812.49 from the \$230,000,000 that the UNITED STATES owe to me, leaving a balance of 229,915,187.51 owed to me after the completion of that "offset" action. Please let me know if this is acceptable to you for starters in finding an amicable resolve to this sorry situation.

Secondly, in reiterating the content of my previous letter to Mark LaVia and others of your cohort, I wish to remind all of you that I have attempted to obtained "verification of the debt" you continue to claim – in explicit terms – and by submitted "interrogatories" as demonstrated by my last TWO sets of correspondence to the UNITED STATES Department of Education and your "agents" operating in Greenville, Texas and Washington, DC (which was dated 7/30/16 and 10/19/16), to no avail. All I have gotten back is typewritten documents WITHOUT my familiar signature, some of which reference a "promissory note" that includes a statement about "fraud" or if "the school did something wrong or failed to do something that it should have done," which, like your recent correspondence 8/23/16 was unsigned, "unverified," and without any form of "affidavit" or sworn statement by an accountable human being issued "under penalty of perjury."

Thirdly, I must reiterate also that you need to be reminded that I have formalized my "claim of damages" upon the UNITED STATES in the amount of \$230 MILLION, associated with a federal civil court case froth with criminal allegations and claims established against federal officials MADE IN COMMERCE. In addressing your previously unsigned debt collection "letter," which asserts, "The Department is exempt from the Fair Debt Collection Practices Act (FDCPA), 15 USC 1692 because the department is not a debt collector as defined by the Act...The Department's Default Resolution Group and National Payment Center service and collect debts that are owed to the Department,"

I simply reassert my previous UNSUCCESSFUL attempt to simply obtain "verification of the debt" by means of "<u>FOIA Request</u>," "<u>Agent/Department Interrogatories</u>," and "<u>Agency/Department, Loan Servicer and/or Debt Collector Disclosure Statements, a.k.a., 'Debt Collector Disclosure Statements</u>" which you have received already but failed to acknowledge failed to respond.

You have instead taken steps to fraudulently ignore, misinterpret and/or misrepresent the content of my last TWO correspondences to you, the agents for the UNITED STATES. One such example is your claim, "You request loan discharge because the school you attended violated a state law related to your loans," when that is blatantly incorrect. What I had stated in my letter to you dated 7/30/16 was that the "USDOE fail[ed] to respond to written reports of fraud dated 2/9/15 and 4/24/15 sent to Washington, DC" (i.e., see the subject line of that letter at the top of page 1 marked as item #1). In fact the content of that first page explained, "The purpose of [that[letter [dated 7/30/16] is FIRST to call attention that I received NO ANSWER to my two detailed letters of correspondence which still NEED to be addressed, personally, by someone in management at your offices, with the signature affixed of a flesh-and-blood human being that is to be held accountable for the information being conveyed back to me."

Again, those claiming to be your "agents" of debt collection – being "FedLoan Servicing, Inc." and other renditions of the "fictitious name" – I have discovered through previous FOIA documents sent to me by the UNITED STATES has no such contract and is thus destroying my credit reputation without contractual authority and through fraud upon the public and fraud upon the credit bureaus. This has thus, long been a criminal matter about which I have reported to you; and your constructive refusal to do anything substantive about a "fictitious name" using your UNITED STATES (i.e. taxpayer-funded) logo and name in its unlawful debt-collection activities constitutes felony crimes of "aiding-and-abetting" and/or "accessory after the fact". Moreover, it constitutes a "conspiracy" to deprive of rights to due process with regard to my protections under the FDCPA (15 USC 1692) whether you are "exempt" or not from that specific federal code. I assert that there are plenty of other federal codes to which all of you are subject in your individual and "official" capacities.

What is outlined in the above paragraph is why I not only demand that the content of my previous "FOIA DEMAND" be reinstated and answered properly with documents, inclusive of the previously submitted "FOIA Request," "Agent/Department Interrogatories," and "Agency/Department, Loan Servicer and/or Debt Collector Disclosure Statements, a.k.a., 'Debt Collector Disclosure Statements". Further, I reiterate my previous demand, again herein, under an "addendum" to that initial FOIA DEMAND dated 7/30/16, the names and titles of EVERY person employed by the UNITED STATES in the following listed areas for the last 7 years:

- 1) Default Resolution Group Servicing Center;
- 2) Management at the UNITED STATES Department of Education;
- 3) Management at the USDOE's Federal Student Aid;
- 4) All persons employed as or referred to as "FOIA Officer" or answering inquiries addressed to the "FOIA Officer;"
- 5) Management of the Office of the Chief Information Officer;
- 6) All persons employed as or referred to as "Chief Information Officer;"
- 7) Management of Regulatory Information Management Services

Additionally, I demand (under FOIA) the following:

8) Copies of all contracts between the UNITED STATES (Department of Education) and Central Research, Inc. the National Payment Center (US Department of Education), and AJCNRE01, who is acting individually and collectively in claim that they are the debt collectors acting on behalf of the UNITED STATES (Department of Education);

9) Copy of any and all contracts with FedLoan Servicing, Inc. allowing them to use the logo and/or name of the "UNITED STATED OF AMERICA DEPARTMENT OF EDUCATION" or "United States of America Department of Education" with the logo as found below:



10) Copy of any and all contracts with any other company, corporation, association, or "person" for the use of the logo (depicted above) or name "Department of Education";

Finally, I wish to remind each of you that you had previously been placed on notice that – assuming that your "US" is your way of writing the initials for "U.S.", referring to the UNITED STATES – I have formalized my "*claim of damages*" upon the UNITED STATES in the amount of \$230 MILLION, associated with a federal civil court case froth with criminal allegations and claims established against federal officials MADE IN COMMERCE. I fully intend to collect upon the \$230 MILLION debt owed to me by the UNITED STATES; cr at minimum, to work to cancel the debt claimed by the UNITED STATES ("Department of Education") against me by simple deduction of your claimed amount (i.e., claimed without "verified" signature of anyone making their claim) from my superior and proven claimed amount supported by a long history of Evidence and sworn Affidavit(s). I wish to remind you that Thad Bartowiak, the "Team Lead", nor anyone else from your Federal Student Aid Office of the U.S. Department of Education, ever responded to the correspondence or FOIA request that I sent on 7/25/14. In that document, I requested FOIA documents to substantiate the following, which I outline in that letter, and which I hereby demand to be provided in response to this reiteration of that (over two years ago) earlier FOIA demand:

Documents which clarify and explain the gross OMISSIONS of Bartkowiak's letter to me dated 7/2/14 which "*clearly and concisely*" was stated as follows:

1) Please provide the "*correspondence*" that Bartkowaik appeared to be claiming to be in possession of that he stated that I had otherwise addressed to the Consumer Financial Protection Bureau. Please also explain how documents that purportedly sent through the United States Mail ended up in Bartkowaik's hands and provide some form of sworn Affidavit or other notarized statement that asserts how such possession of documents

addressed to another came to be in your possession if not by way of a felony interference in the service of the United States Mail and interception of documents sent to entirely different addressees at an entirely different address;

- 2) Please provide the "correspondence" that Bartkowiak appeared to be claiming to be in possession of that he stated that I had otherwise addressed to the "Ombudsman Group". Please also explain how documents that purportedly sent through the United States Mail ended up in Bartkowiak's hands and provide some form of sworn Affidavit or other notarized statement that asserts how such possession of documents addressed to another came to be in your possession if not by way of a felony interference in the service of the United States Mail and interception of documents sent to entirely different addresses at an entirely different address;
- 3) Given that all correspondence I have sent out through my lifetime has been in plain English and on other language, with regard to my requests under #1 and #2 above, please provide me with the specific pages and paragraph numbers of what it is in my previous correspondence that Bartkowiak claimed NOT to understand as "clearly" written in plain English. Please also provide me with the highest level of Bartkowiak's education, as well as the specific names and highest levels of education of those within Bartkowiak's association or "Group" that also reviewed my previously submitted documents and did not find clarity in the plain English with which I wrote, while referencing specific page numbers and paragraphs they did not understand;
- 4) Please explain and supply all forms of evidence of what the relationship is of the Federal Student Aid office where Bartkowiak works (at 830 First St., N.E. Washington, DC 20202) and the FSA Ombudsman Group that is also located at 830 First Street, N.E. Mail Stop 5144, Washington, D.C. 20202-5144 where I mailed a full set of correspondence which was itemized, fully explained, and fully supported by numerous documents presented along with a Certificate of Service that was officially notarized on 5/13/14;
- 5) Please explain what exactly Bartkowiak has claimed in his letter is NOT "clear" and what he did NOT understand on Page 8 of the 8-page cover letter which beings a paragraph in the middle of the page with the phrase, "In short, I wish to know..." followed by 5 simple itemized items;
- 6) Please explain why neither Bartkowiak nor the addressees of the Consumer Financial Protection Bureau, nor the "Ombudsman Group" failed to provide answers to the documents referenced by the "Certificate of Service" as: a) "Agency/Department Interrogatories" and, b) "Loan Servicer and/or Debt Collector Disclosure Statement," a.k.a. "Debt Collector Disclosure Statement";
- 7) Please identify the signature on the copy of the "Certified Mail: Article Number 7013 0600 0002 3806 7773 (which was provided to Thad Bartkowiak as an attachment to my letter on 7/25/14) as the person claiming to represent the "Ombudsman Office" (that is registered at the above-referenced address as the same as Bartkowiak's address) that appears to have acted criminally on 6/15/14 to interfere with the United States Mail delivery and (perhaps in conspiracy with one or more U.S. Post Office employees) stolen mail I otherwise "certified" for delivery to an entirely different addressee of the "U.S. Department of Education Headquarters in the Lyndon Baines Johnson Department of Education Building located at 400 Maryland Avenue, S.W., in Washington, D.C. 20202";
- 8) Please explain the process of the creation of the "Ombudsman Case 1-4ASI" as cited in Bartkowiak's letter, and provide evidence of his authority to act on behalf of the Office of Ombudsman in writing his letter to me dated 7/2/14. Please also provide all documents in evidence of the relationship Bartkowiak's "Federal Student Aid" office has with the "Ombudsman Group" that he had apparently represented in his correspondence back to me;

- 9) Please explain and provide evidence of all relationships and contracts between Bartkowiak's "Federal Student Aid" office, the Ombudsman Group, and the U.S. Department of Education, and each of their relationships with the "fictitious name" of "FedLoan Servicing (FedLoan)" that Bartkowiak claimed manage(d) "my" student loan "on behalf of the USDOE";
- 10) Please provide me with certified and authenticated copies of BOTH SIDES by notarized Affidavit of Truth – of any documents that Bartkowiak or anyone else at the U.S.D.O.E. (USDOE) claim establishes the claim that "FedLoan Servicing (FedLoan)" claimed (in his letter of 7/2/14) manage(d) "my" student loan "on behalf of the USDOE";
- 11) Please provide me with copies of ALL COMPLAINTS received by the USDOE or any corporate or government subsidiary or administrative subdivision with regard to FedLoan Servicing (or any derivatives of that name) or the PHEAA (Pennsylvania Higher Education Assistance Agency);
- 12) Please send all documents that identify "Federal Student Aid" as either a government entity, a corporate entity, or a quasi-government agency. Include copies of all government Oaths of Office, pledges of allegiance to the Constitution, associated surety bonds, blank bonds, blanket insurance, self-insurance, risk management insurance policies, and "terrorism" insurance coverage (riders), that offer protection on the elected, and/or appointed employees. Include all documents of corporate entities related to Articles of Incorporation, risk-management insurance, "errors and omissions" insurance, or other insurance offering protection against claims that are against USDOE employees.

I await your next response, which should provide a full address of my 7/30/16, my 10/12/16, and my 10/19/16 FOIA demands, inclusive of "*FOIA Request*," "*Agent/Department Interrogatories*," and "*Agency/Department, Loan Servicer and/or Debt Collector Disclosure Statements, a.k.a.,* '*Debt Collector Disclosure Statements*'. Again, anything not containing the signature and clear spelling of any person responding back to me with accountability in "verifying the debt", being a flesh-and-blood human being capable and accountable to me *individually* as well as officially, will be disregarded as you have disregarded my previous correspondences of 2/9/15 and 4/24/15 and (for the substantive part) 7/30/16. Note that if this way of handling this situation is not for you then I adamantly demand that you "CEASE AND DESIST IN YOUR DEBT COLLECTION ACTIVITIES AGAINST ME" and accept the fact that you will be assessed \$2,000,000 in fees, penalties and other damages <u>each time</u> you contact me in any way related to your claim that I owe you or the UNITED STATES anything.


