Comes now, Jason James Goodwill (also known as Complainant), a non-resident non-alien of United States, Incorporated, having been born in Michigan and currently inhabiting in Michigan and in the current Meets and Bounds under The United States of America of the government known as The United States of America 1781. CHAP. CCXLIX --An Act concerning the Right of American Citizens in foreign July 27th 1868 states: "WHEREAS the right of expatriation is a natural and inherent right of Rights of all people, indispensable to the enjoyment of the rights of life, liberty, and American citizens in foreign the pursuit of happiness; and whereas in the recognition of this principle this government has freely received emigrants from all nations, and invested them with the rights of citizenship; and whereas it is claimed that such American citizens, with their descendents, are subjects of foreign states, owing allegiance to the governments thereof; and whereas it is necessary to the maintenance of public peace that this claim of foreign allegiance should be promptly and finally disavowed: Therefore,

-- Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, that any declaration, instruction, opinion, order, or decision of any officers of this government which denies, restricts, impairs, or questions the right of expatriation, is hereby declared inconsistent with the fundamental principles of this government. "

The indoctrination can arguably be said to start at the time of birth of every American whereby, according to 8 U.S.C. § 1101 (a)(23), the term *"naturalization means the conferring of nationality of a state upon a person after birth, by any means whatsoever."*

I swear to uphold the Constitution For The United States of America, which was re-inhabited by quorum, re-instituting allegiant to the Sovereign as defined in the Supreme court, being a Covenant and that solemnly rejects the "United States" (Inc.), a municipal corporation illegitimately claiming
