Grand Rising Sandy and President Geiger,

Here is a summary so far of what we know.

We met Dean and Dave Roberts yesterday morning. The two of them informed Nina Cronan, Wayne Cronan, My husband Dain Dugan and myself that Eric Dingis informed them that he received money in the amount of \$100,000 from the PMA (Private Ministerial Association) which belongs to the Trustees and Investors for a private Depository and Exchange that would support the Republic. He did this without any permission or authorization from the said trustees to purchase a vehicle. He did not notify anyone that he did this. His Administrator Lynn Wagner, found out about this and was arguing with Eric Dingis to give the money back. She found out and moved the remainder of the funds out into another account at another bank. She has control of the funds now from what she explained to us yesterday.

Dean and Dave both thought that the funds belonged to the Republic Free State of Tennessee and that they needed to warn us. Dean and Dave stated that Eric said that the trustees gave him the money. I am not aware of the exact day that he took this money, perhaps Dean and Dave may know the day, since they were travelling with Eric for several days.

Since the PMA was private, and not connected to the Republic, this was not the case. However, this Exchange was intended to fully support the Tennessee Republic economy and give financial support/assistance for bartering, investment club offerings as well as purchasing of either Silver Certificates or accomplishing the minting of a new Tennessee coin as required under the Constitution that each state shall mint their own currency for trade.

I hope this gives you a fairly accurate description of the situation that we are dealing with, and we want to warn all the other states and assemblies to be aware of this scheme. I hope your investigation is successful and that justice is served for the people of Tennessee that trusted him for many months and invested funds to help the Republic. Our hearts were only to serve the Republic and the Free State of Tennessee.

PLEASE NOTE: Everyone copied this email, please keep this information extremely confidential as an investigation is ongoing and no one needs to know the specifics of this. We don't want ANY

WORD to get back to Eric that we are aware of this scheme until the time is right, or when it is instructed by President Geiger that is okay to do so.

Hi Carrie,
I watched the entire video. Remember that I know sketchy details of what this is all about, so I have a slightly inside perspective. With that knowledge, I saw nothing suspicious in the video. The word that Dave used was "affirmation" which is a statement of facts. Dave and his folks were clear that they needed to give you and your group important information, and it needed to be in person because of the sensitivity of the information in order to protect you and your group.

The affirmation would ONLY be needed if a face to face meeting was not possible. That was a less than ideal second choice, but it is the logical second choice if the first choice (face to face) was not possible. And it needed to be delivered to a physical address, hence the questions about an address to send it to.

One thing that you might have noticed is that everyone was looking down at the coffee table. What they did was set up two laptops. One was set up on a stool for the video (so you could see everybody on the couch) further away, and one was set up on the coffee table for the audio (because the other laptop was too far away for good audio). So they weren't being evasive, they were simply looking at the closer laptop.
