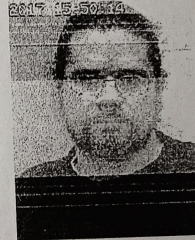

Waterford Man Charged with Raping Juvenile, Impregnating Another Waives Right to Hearing

Some may find the details of this story graphic and disturbing.

The case is moving forward against a Waterford man who investigators said raped a juvenile female and impregnated another on several occasions.

Jason Daniel Goodwill, 51, of Dunn Valley Rd., waived his right to a preliminary hearing Wednesday morning. He faces charges including sexual assault; rape forcible compulsion; involuntary deviate sexual intercourse forcible compulsion; two counts each of rape, corruption of minors and indecent assault without consent; and three counts involuntary deviate sexual intercourse with a child.

A count of endangering the welfare of children was withdrawn Wednesday. Four misdemeanor counts of indecent assault of a person less than 13 years of age were upgraded to third-degree felonies, and a felony charge of aggravated indecent assault of a child was added.

Goodwill has been denied bond and remains behind bars in the Erie County Prison due to the seriousness of the charges.

Pennsylvania State Police said the investigation spans from 2006 to 2020, and the victims - a 12 year old and 20 year old - were in Goodwill's custody when the crimes occurred.

The investigation started May 7 when investigators were called to UPMC Hamot Children's Care Clinic for suspected child abuse at a residence in McKean Township involving the victims, according to State Police.

The 12 year old was taken to UPMC Hamot for testing and observation after she told the 20 year old that she was being sexually abused by Goodwill, the criminal complaint said.

The 12 year old told investigators she was sexually abused more than one time within the home, starting when she was approximately ten years old. The daughter said she told Goodwill "no" on several occasions, and he threatened that she would be taken to the hospital, put on a table and stuff would be pulled out of her if she told her mother about what he did, according to the criminal complaint.

She also told investigators Goodwill showed her child pornography on her phone when she was approximately 11 years old. He forced her to have sex with him and inappropriately touched her during those sex acts, the investigator wrote in the criminal complaint.

The 20 year old told investigators she had been sexually abused by Goodwill starting when she was approximately 7 years old. She said Goodwill inappropriately touched her and forced her to have sex with him regularly, almost daily, and said "she would lose her family and the house in which she lives" if she did not, the criminal complaint said.

She said she believes Goodwill impregnated her on several occasions, according to State Police. He reportedly injected her with a chemical to unnaturally induce labor, so he could abort the pregnancies, the investigator said.

The 20 year old said she gave birth to a child in 2014, and Goodwill took possession of the baby, which eventually passed away and was buried on the property of the McKean residence, according to the criminal complaint.

State Police investigators tell Erie News Now they served a search warrant at the home on May 12 and recovered evidence on the property in connection to the death of a child.

State Police investigators said they are looking for additional physical evidence related to the 20 year old's report and will file more criminal charges, if necessary.

Hearing delayed for McKean man in child rape

A McKean Township man accused of repeatedly raping and sexually assaulting two girls, and of burying a baby born by one of the victims after the child died a short time after birth, remains in jail without bond as he awaits a June court date in the case.

Jason D. Goodwill, 51, was scheduled to appear before McKean District Judge Denise Stuck-Lewis on Thursday morning for his preliminary hearing on charges including multiple felony counts of rape, involuntary deviate sexual intercourse and endangering the welfare of a child.

The hearing was continued at the request of the Erie County District Attorney's Office Thursday morning. A new hearing date was set for June 10 at 11 a.m.

The continuance was requested to allow prosecutors more time to prepare for the hearing, First Assistant District Attorney Elizabeth Hirz said.

Goodwill has remained in the Erie County Prison with no bond set in the case since his arraignment on May 12.

Goodwill's online criminal docket notes that no bond was set at his arraignment because of the seriousness of the charges and possible additional charges. No additional charges have been filed in the case since his arraignment.

Pennsylvania State Police investigators accuse Goodwill of raping and assaulting two girls between 2006 and earlier this year. State police began investigating the allegations earlier this month after troopers were called to a hospital to investigate a report of suspected child abuse.

Troopers wrote in Goodwill's criminal complaint that they were told that Goodwill sexually assaulted and forced sex on the girls. The complaint also charges that Goodwill administered a harmful chemical to one of the victims on multiple occasions.

Investigators also revealed that Goodwill reportedly impregnated one of the girls several years ago. The baby was born prematurely and reportedly died shortly after birth. Goodwill is accused of burying the baby, investigators wrote in a news release issued six days after Goodwill's arraignment.

A search warrant was served on Goodwill's property on May 12 and evidence related to the investigation was seized, according to the release.

DA adds felony charges in McKean child rape case

MCKEAN — Erie County prosecutors have added charges and upgraded others in the case against a McKean Township man accused of raping and sexually assaulting two girls over several years.

Prosecutors on Wednesday morning added a first-degree felony count of aggravated indecent assault against 51-year-old Jason D. Goodwill and regraded four counts of indecent assault from first-degree misdemeanors to third-degree felony counts.

Prosecutors also withdrew one of three third-degree felony counts of endangering the welfare of children.

Goodwill faces a total of 20 charges, including multiple first-degree felony counts of rape and involuntary deviate sexual intercourse, in the Pennsylvania State Police investigation.

Prosecutors amended Goodwill's criminal complaint during his scheduled preliminary hearing before McKean District Judge Denise Stuck-Lewis. Goodwill waived the hearing.

Goodwill remains in the Erie County Prison without bond.

State police charge that Goodwill raped and assaulted the two girls between 2006 and earlier this year. Police launched the probe in early May after troopers were called to a hospital to investigate a report of suspected child abuse, according to information in Goodwill's criminal complaint.

The complaint also charges that Goodwill administered a harmful chemical to one of the victims on multiple occasions.
