

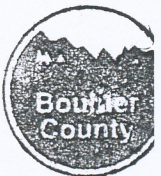


I became aware of the following security, using my equity without my knowledge or permission:




