**COMMERCIAL AFFIDAVIT – NOTICE OF INTEREST**  
For a three week (21 day statutory) Grace Period  
18 USC 4 Issue: Motion in Limine, the elimination  
of the right of self-defense.

I, Laurence R. Goodman, state and affirm as follows:

I am being deprived of the right of self-defense, other rights, liberty, and property.

I am being subjected to false prosecutions, and cruel and unusual punishment, by prosecutor Robert Shapiro and Judge Michael Spear, by them prosecuting an Indictment not sworn to be true, and imposing a Motion in Limine, to eliminate my right of self-defense, amounting to a procedural Motion in Rape like bending a woman over a barrel, in Denver District Court in Case No. 17CR10088, in violation of Amendments I, IV, V, VI, VII, VIII, and IX of the Constitution for the United States of America (1789).

I filed a brief, entitled EMERGENCY REQUEST FOR IMMEDIATE INJUNCTION, in the UNITED STATES DISTRICT COURT FOR THE DISTRICT OF COLORADO, as Case No. 17-cv-01680-RM-KLM, for the purpose of removing Denver District Court Case No. 17CR10088, to the United States District Court, to obtain some justice in the Colorado case. The judge in this federal case, Raymond P. Moore dishonored my process without cause, thus supporting the original Motion in Limine/Motion in Rape, further eliminating my right of self-defense, and making himself the third offender by the Motion in Limine. (See: Mixed War.)

Now, I am approaching the 10<sup>th</sup> Circuit Court of Appeals, Case No. 18-1025, to obtain some justice in the next three weeks. How much is this Appeal process going to cost me?
