EMERGENCY PETITION FOR WRIT OF HABEAS CORPUS

Goodman v. Persons Posing as Public Officers Within Colorado State Government

Petitioner, Laurence R. Goodman, alleges and avers that there are no State or Federal Courts available in Colorado on the basis that no public officer has filed verifiable evidence of the mandated fiduciary bond pursuant to the Colorado Enabling Act the covenant between Colorado and the United States guaranteeing a republican form of government and Schedule, Section 2 and 22, Colorado Constitution, also a federal law, because it took an act of Congress to approve it and the President to sign it into law. By reason of Article X, Section 13, Colorado Constitution, without a valid verifiable fiduciary bond every imposter posing as a public officer is committing felony embezzlement of public funds each time they collect a paycheck.

The petitioner, was doing his duty pursuant to 18 U.S.C. § 4 of reporting the criminal activities of imposters posing as public officers. By reason of 18 U.S.C. §§ 2340 - 2340A considered to be breaches of Article III of The Hague Convention IV and 18 U.S.C. § 1513, petitioner is being threatened, intimidated, and retaliated against by spurious prosecutions in Denver District Court Case No. 17CR10088. Imposters posing as judge and prosecutor are knowingly holding the petitioner in a condition of forced labor and restraint under house arrest in violation of 18 U.S.C. § 1589 and threatened with immediate jail if petitioner speaks out in his defense or assemble/communicate with others contrary to the First Amendment, U.S. Constitution.

Petitioner needs an immediate emergency injunction, to prevent future harm and damages, against the Denver District Court on the basis that imposters posing as judges are violating federal law and have scheduled Goodman for additional injuries and dangers on January 8, 2018. Goodman wants this court to enjoin the Denver District Court to cease and desist all harassment; return everything that was stolen; and order the removal of the ankle restraint and house arrest.
