All actions required by Accusers/Plaintiffs of the Accused/Defendants to avoid the consequences of this Criminal Complaint must present, in affidavit form, all objections by the defendants and must be presented within three months (90 days) from the issuance of this criminal complaint.

Any actions and /or inactions by the Defendants, both named and unnamed, contrary to the lawful Constitution for the united States of America, 1789, will immediately bring the full force of this Criminal Complaint upon them. The above - named defendants have broken these Constitutional Laws. This citation concerns the felonies committed according to the lawful Constitution for the united States of America, 1789, and ignores all law in Admiralty (Private Law).

PURPOSE OF CRIMINAL COMPLAINT

The officials of MONTROSE COUNTY COLORADO have and are continuing to violate the Creator endowed unalienable rights secured by the Constitution for the united States of America, ratified in 1789, of the People, the private natural men and women, in Colorado who have sovereignty and the right to initiate lawful remedy.

STATEMENT OF FACT

The above-named Defendants are accused by this instrument of the offenses of violation of the, herein listed and marked, parts of the Constitution for the united States of America, ratified in 1789, the SUPREME Law of the Land.

On November 10, 2015, at or about 12:41 PM Sandra Lee Tyler, a seventy one (71) year old woman, was assaulted, battered, and kidnapped with abandon impunity from her private driveway. It is unmistakably posted **no trespassing**. Ten to twenty heavily armed men/women, dressed in military combat uniforms participated in the raid at her place of domicile: at 21250 Dave Wood Road in Montrose County. Tyler was taken to Montrose

County Jail, 1200 North Grand Avenue, Montrose, Colorado, and imprisoned against her free will under a system of peonage imposed upon her by the named Defendants and others who deny the power of the Constitution and defy the 13th Amendment enforced by the authorities of 14 Stat. 27 and 14 Stat. 546 codified as 42 U.S.C. § 1994 and 18 U.S.C. § 1581 *et seq.* As a political prisoner, without valid mittimus paperwork, or being informed of any of the charges, the restraint and imprisonment of the Tyler is without jurisdiction, unlawful, and illegal to wit;

The above-named Defendants in collusion with other unknown parties are attempting to steal Tyler's property. As a result Tyler is being subjected to the most hideous, cruel, and unusual form of punishment imaginable, that is to say, is being denied her freedom of religion; the right to speak, be heard and defend her property in court. The People have the unalienable, god given right, to study the law, teach the law, and practice the law without a license from a criminal oligarchy impersonating god, commonly known as the BAR Association.

The People who did ordain and establish the said governments by virtue of Article I, Section 9, Clause 8, Article I, Section 10, Clause 1, Constitution for the united States of America, ratified in 1789, the Original XIII Article of Amendment, Constitution for the united States of America, ratified in 1819; Article V, Section 25, Article X, Section 13, Article XVIII, Section 4 of the Constitution for the State of Colorado, ratified in 1876; never gave the aforesaid criminal oligarchy, a private foreign power, permission consent, or authority to operate or hold any public office in the united States of America, Colorado state or Montrose County.

None of the above-named public officials in Montrose County have valid oaths filed with official bonds and are embezzling public funds while unlawfully holding a vacant office. Montrose County commissioners were given two **Notices of Fraud** by certified mail as demonstrated in Document No. 03477315 on 10/02/2015 11:02 AM Boulder County Colorado. By reason of the General Laws of the State of Colorado, ratified in 1877, Chapter XXIV, 668 Section 73 Montrose County Commissioners neglected their duties to timely examine, inquire, into the sufficiency and did falsely authenticate the oaths/official bonds

By reason of the General Laws of the State of Colorado, ratified in 1877, Chapter LXXI, 1936 Section 6, Montrose County commissioners are in breach of their Covenant with the People in Montrose County, Colorado state, and the United States. By denying the powers of both constitutions, demonstrating that there must be a "meeting of the minds" to act in concert to conceal and cover up their crimes. Montrose County commissioners have failed to remove themselves or the other impostors from office.

A diligent search of the Constitution for the United States of America, ratified in 1789, the Constitution for the State of Colorado, ratified in 1876, the Original XIII Article of Amendment, Constitution for the United States of America, ratified in 1819, and the General Laws of the State of Colorado, ratified in 1877, has been made. Nowhere can it be found where the People gave their public servants, government officers, authority to hold any public office without personal recognizances or subvert the requirement of personal recognizances with a blanket insurance policy from any private insurance company (CTSI inc.) purchased with public money. Nevertheless the evidence of such an unconscionable, reprehensible and unconstitutional contract between Montrose County commissioners and CTSI inc., part of a foreign criminal oligarchy, can be found in Montrose County Resolution 02-2013. The penalty for such insurrection to both constitutions is found in the recital of 26 Stat. 209 (1890).

By reason of the Separation of Powers Doctrine Articles I - III and Article IV, Section 4, of the Constitution for the United States of America the People of Montrose County and the State of Colorado have been denied a Republican form of government, ratified in 1789, those Defendants who joined with the criminal oligarchy have collectively agreed to commit and continue to commit crimes against the United States, which is enforced by the authorities of 62 Stat. 701 and 62 Stat. 808 codified as 18 U.S.C. §§ 371, 2384, and 2385.

The doctrine of Legal acumen is that if a defect in, or invalidity of, a claim to land in such as to require, Legal acumen to discover it, whether it appears upon the face of the record or proceedings or is to be proved aliunde, then the powers or jurisdiction of a court of equity may be invoked to remove the cloud created by such defect or invalidity.

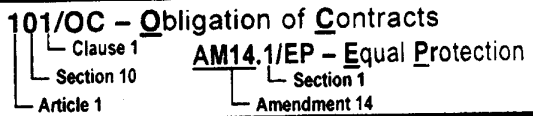

If two or more persons conspire to injure, oppress, threaten, or intimidate any citizen in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same; or if two or more persons go in disguise on the highway or the premises of another, with intent to prevent or hinder his free exercise or enjoyment of any right or privilege so secured - they shall be fined not more than \$10,000 or imprisoned not more than 10 years, or both: and if death results they shall be subject to imprisonment for any term of years or for life.

The Defendants have violated the law (U.S. Constitution, etc.) by the thirty five (35) foregoing acts and omissions, and are severally and jointly assessed pursuant to the Constitution for the United States of America, ratified in 1789 and pursuant to the Statutes at Large and the United States Code for their acts and omissions in the amount of at least THREE HUNDRED FIFTY THOUSAND DOLLARS (\$350,000), per actual (not proxy) Claimant, of unlawful imprisonment for (two) 2 days arising from and set forth and ledgered in the attached Criminal Complaint which was filed with the United States District Court, date and time stamped on sheet one, is equal to SEVEN HUNDRED THOUSAND DOLLARS (\$700,000) for the unlawful imprisonment of one (1) Claimant. 18 USC 241 (1948) violations have been adjusted for inflation to 2014 values at the rate of \$97,230.75 per \$10,000.00. Violations have been adjusted for inflation to 2014 values at the rate of \$25,949,500.91 per \$1,000,000.00. THEREFORE, the total value of this Complaint without interest is TWO BILLION EIGHT HUNDRED TWENTY EIGHT MILLION FOUR HUNDRED NINETY FIVE THOUSAND FIVE HUNDRED DOLLARS AND NINETEEN CENTS (\$2,828,495,599.19). Now the reader understands the commercial meaning and importance of obeying the law.

Affidavit of Truth

Be it known to all who call themselves "government," their "courts," agents, and other parties, that I, Sandra Lee Tyler, am a natural, freeborn sovereign individual, without subjects, living on the land and not the sea. I am neither subject to any entity anywhere, nor is any entity subject to me. I neither dominate anyone, nor am I dominated.

I am not a "person" as defined in "statutes" when such definition includes "artificial entities." I refuse to be treated as a "federally" or "state" created entity which is only capable of exercising certain rights, privileges, or immunities as specifically "granted" by "federal" or "state" "governments."

I may voluntarily choose to comply with the "laws" which others attempt to impose upon me, but no such "laws," nor their "enforcers," have any authority over me. I am not in any "jurisdiction," for I am not of subject status. Since I was not born within the district of Washington, DC, I am not a united States of America citizen.

I have not committed any crime, and am therefore not subject to any penalty.

Thus, be it known to all, that I reserve my natural right not to be compelled to perform under any "contract" that I did not enter into knowingly, voluntarily, and intentionally. Furthermore, I do not accept the "liability" associated with the compelled and pretended "benefit" of any hidden or unrevealed "contract" or "commercial agreement."

As such, the hidden or unrevealed "contracts" that supposedly create "obligations" to perform, for persons of subject status, are inapplicable to me, and are null and void. If I have participated in any of the supposed "benefits" associated with these hidden "contracts," I have done so under duress, for lack of any other practical alternative. I may have received such "benefits" but I have not accepted them in a manner that binds me to anything.

Any such participation does not constitute "acceptance," because of the absence of full disclosure of any valid offer, and voluntary consent without misrepresentation or coercion. Without a valid voluntary offer and acceptance, knowingly entered into by both parties, there is no "meeting of the minds," and therefore no valid contract. Any supposed "contract" is therefore void, from the beginning.

From my age of consent to the date affixed below I have never signed a contract knowingly, willingly, intelligently, voluntarily, and intentionally whereby I have waived any of my natural inherent rights, and, as such, **take notice** that I revoke, cancel, and make void from the beginning my signature on any and all "contracts," "agreements," "forms," or any "instrument" which may be construed in any way to give any agency or department of any "government" any "authority," "venue," or "jurisdiction" over me.

Here follows is my recollection of what happened on Tuesday, Nov. 10, 2015.

On Nov. 10, 2015, I drove out to go into town to run errands. Steve always drives out with me to open the gate and then close it, lock it, and return to the house.

Unbeknown to us, Deputies of the Montrose County Sheriff had already trespassed onto our posted private property, were wearing camo desert clothing, and hiding in the sage brush and or around the house. There were from 10-20 officers. Exact count unknown.

When Steve walked back from the gate to the house, he was attacked and handcuffed. Meanwhile I am on the road just about 0.2 miles from the house when I was passed on the left side by 2 Sheriff vehicles going at least 65 in a 45 zone. I turned around and came back home, I had to park in the access road next to our driveway as their vehicles were blocking me. I quickly got out of the car and tried to reach my husband to talk to him and find out what was happening.

I was grabbed and held by my forearms with 2 hands on both the left and right forearm and was completely surrounded. I told them I just wanted to talk to my husband.

Having no courtesy or feeling of compassion to allow this, they said no to me asking to talk to my husband several times without any explanation. They could have said, "Yes but we have to search you first."

I asked to see the warrant for the arrest and they ignored me. I asked to see their oaths of office, and they ignored me.

The hands on my forearms were squeezing so hard that it hurt and I slapped one of them with an open hand not a fist, on the wrist and said, "Stop, you are hurting me!" It was a gut reaction to the pain they were administering. Being 71 and with a diagnosis of bipolar manic depressive anxiety disorder since 1985, I acted out. I meant no harm, I just wanted them to stop hurting me. He turned away and said, "You are under arrest." At one point I begin to pass out and sat down on the ground. I have been diagnosed since the late 1990's with positional vertigo (this means if you change position quickly, you can pass out), That might have been the time they hurt my right shoulder when they were not gentle in

lifting me up from a sitting position not a lying down position. When they handcuffed me behind my back that could have been the time when my shoulder was twisted which damaged the tendons.

From Nov. 10 to Nov. 24, the pain has been unrelenting and excruciating. It hurts more that the pain combined from my two knee replacements in August and November of 2014. Pain medications are not helping to relieve the pain longer than 2 hours. Taking more pain meds just results in the complications of pain medication, constipation, stomach problems. The pain is less frequent but every now and then, I can move just a bit and the sharp pain strikes.

I also have arthritis in all my joints per one of my doctors, and spinal stenosis which is the narrowing of the spinal cord resulting in the nerves being squeezed which sends streaks of pain down and/or up your body. I have one area of my right lower back that is in pain when I move as in sitting or standing or turning in bed or driving or carrying groceries into the house.

They were not gentle in leading me to a vehicle and tried to shove me in but I said, "Take your hands off me, I will get in by myself." Unfortunately, there was no room for my legs and the pain in my wrists and back (due to the spinal stenosis) and right arm were mounting. I begged to have the cuffs moved to the front of me all the way of the long drive in. The officers ignored me. One seems especially glad that I was in pain. I could see it in her face. They promised to take the cuffs off when we got there but did not. They said I had to go inside which I did and then sat down. They still did not remove the cuffs again when I said to take them off because I was inside. Their modus operandi is to make you feel subservient to them and as demoralized, hurt, and emotionally upset as possible.

Once inside far enough to suit them, they took off the cuffs. That was when I noticed the red marks on my wrists and the hematoma on my arm. I mentioned this to one of the person there and finally photos were taken several hours later for documentation. For the time there, I was basically ignored except for about 5 minutes to read me my rights and ask what I wanted to do with the guns in the house which was at about 3 PM.

When I asked to go home at the shift change of 6 pm, the only officer with compassion said they were going to hold me overnight. I told her I had to go home to take my medications and to let the cats in. She then got the paper work going. I was demoralized further by being fingerprinted and my photo taken with and without my glasses. I was never informed of the charges against me until I got the paperwork when I was leaving at nearly 10 pm. I was finally home at about 10:30 pm.

In all my life I have been the one who was bullied. I constantly came to the rescue of others who were being hurt emotionally. I always took the underdog under my wing to help them.

I have volunteered all over town to help others. I did manicures at the VOA for 2 years until my back started hurting.

I volunteered for the relay for Life for 5 years.

I volunteered for the Martin Luther King Campaign to give to others in need by organizing a food and toiletries drive for Sharing Ministries in 2012 and over 2000 pounds of toiletries was given to Sharing Ministries by both myself and my husband.

I volunteered for Welcome Home Montrose and the Warrior Resource Center, helping with the first Warrior Week.

I volunteered with Altrusa for several years.

I volunteered for the group Montrose Recycles and still do.

I volunteered for a political party.

I volunteer for the Downtown District Authority and have helped the Executive Director write and publish a newsletter each month for the past 9 months. We have completed several projects that have benefitted the city.

I have volunteered for the Meth Coalition which became the Coalition for a Drug Free Montrose County and was chairperson for 2 years. The wife of Commissioner Henderson worked side by side with me. Commissioner David White was assigned to oversee this Coalition and we worked together to achieve goals and accomplish good results.

I have been in good standing in the community of Montrose and Montrose County for over nine years.

Now I am the underdog and am asking for leniency and for the charges to be dropped. I was hurt more physically and emotionally than the slap hurt that officer either physically or emotionally. My right shoulder will never be the same.

I am old and I am tired. I am scared and I am alone. I am pleading with you to let me go home and live out my remaining years which are not too many more. Most of my ancestors have not lived long. I have 3 cats that depend on me and that give me support. I am also asking for my care giver, Steven Duane Curry to be released from Mesa County Dentition Center.

I affirm that all of the foregoing is true and correct to my recollection. I affirm that I am competent to make this Affidavit. I hereby affix my own signature to all of the affirmations in this entire document with explicit reservation of all my inalienable rights and my specific right not to be bound by any "contract" or "obligation" which I have not entered into knowingly, voluntarily, intentionally, and without misrepresentation, duress, or coercion.
